





Commissioner Miller breeds and trains American Quarter Horses and is a recognized rodeo cowboy with nine world championship titles.

Miller and his wife, Debra, have been married for more than 40 years. They have two sons, two daughters-in-law and four grandchildren.




BOB TALLMAN

RED STEAGALL

For more than 40 years, Red Steagall has entertained people around the globe as a recording artist, songwriter, television and motion picture personality, and cowboy poet.

In 1991, the Texas Legislature named Red the Official Cowboy Poet of Texas. By 1994, he launched his one-hour syndicated radio show, "Cowboy Corner," which is now heard in approximately 165 markets across 43 states.


Musically, Red has won eight Wrangler Awards from the National Cowboy and Western Heritage Museum in Oklahoma City. He has also authored four books.

In recognition of Red's significant contribution to the western way of life, he was inducted into the Texas Trail of Fame in October 1999. In 2003, he joined the National Cowboy and Western Heritage Museum's Hall of Great Westerners. A year later, Red was inducted into the Texas Cowboy Hall of Fame.

In 2006, Red was awarded the prestigious Charles Goodnight Award and also was named the Poet Laureate for the State of Texas.

Red's television show, "In the Bunkhouse with Red Steagall," first aired in 2009. His current show, "Red Steagall is Somewhere West of Wall Street," airs nationwide on RFD-TV.

Sarah Ann Litten Kale was born in North Carolina. She traveled to Anderson County where she acquired 400 acres of land from her brother, James Litten, in 1860. She raised cotton and cattle with her husband, Luther Kale, and six children, one of whom was William Henry ("W.H.").

W.H. Kale acquired 200 acres of the original land in 1901. He raised cotton and cattle with his wife, Fannie Jane, and their only child, Ide Mae Kale. W.H. later purchased 100 acres to add to the family's homestead.

In 1961, Marie Irene Schrader Stafford acquired the property after the passing of her grandparents. She married Wayne Stafford and they had two sons: Steven and Randall. They raised hay and cattle. Darrell Lee Hillhouse acquired 17 acres of the land from his aunt, Marie Irene Schrader Stafford, in 2014. He raised cattle for many years, but now raises hay, pecans, alpacas, and bees with his wife, Kendall.

Sarah Ann Litten Kale was born Catawba County, North Carolina. She traveled to Anderson County where she acquired 400 acres from her brother, James Litten, in 1860. Sarah raised cotton and cattle with her husband, Luther Kale, and their six children: Ephriam Monroe, MAS, Nancy Elizabeth, Charles, William Henry ("W.H.") and Mary Margaret.

W.H. Kale acquired title to the land after the passing of his mother in 1901. He continued to raise cotton and cattle with his wife, Fannie Jane, and their only child, Ide Mae Kale. During this time, W.H. purchased an additional 100 acres to add to their homestead.

In 1961, Mary Fayrene Schrader Hillhouse acquired the land after the passing of her grandparents. She married Alva Clarence Hillhouse and had one child, Darrell Lee Hillhouse. She raised cattle for many years but now raises hay, pecans, alpacas and honey bees.

FOUNDER: Catarina Garza Riojas

Mary Garcia & Dianna Herrera

In 1868, Catarina Garza Riojas purchased 380 acres of the Cruz-Landin land from Luciano Navarro and wife Theodora Carvajal de Navarro. Her and her children's lives revolved around the farm. Catarina willed the land to her grandchildren: Estanislado Jr., Eduardo, Bernardo, Gregoria, Louisa and Maria, who all obtained title in 1935. Eduardo and his older brother, Estanislado, began farming the land in the mid 1930s.

In 1973, Estanislado Jr. sold his portion of the land to Eduardo. Eventually, the rest of the Riojas Reyes siblings also sold their shares of the land to Eduardo and his sons: Albert, Richard and David. Eduardo and his sons maintained the farm for many decades. Both Richard and David answered their draft calls to serve in the Vietnam War but returned to the family farm once they had

completed their services.

In 1999, Eduardo retired and the land was passed down to his sons. Albert and David currently operate the land. They raise hay for their livestock and grow a variety of produce, including strawberries, which have won numerous awards at the Poteet Strawberry Festival. Eduardo's son, David Roy, is the only one who still resides on the original land.



In 1857, Ernst and his wife, Elisabeth, left Rehburg, Hanover Germany for America. They first settled in Rehburg, a small community in Washington County, and then resettled in 1866 after purchasing 163 acres in Austin County. Ernst and Elisabeth had six children: Heinrich Willheim, Marie Sophie, George Elterw, William. Joahnna and Henrietta. They raised cotton, corn, milo, and farm animals.

George acquired the farm in 1886. He and wife, Emma, had 12 children: Julia, Ernst, Frieda, Willie, Elisabeth, Mary, George Frieder, Emma, Hermann, Lydia Antonie, Alice and Bennie William. Hermann acquired the farm in 1944, after his father's death. He and his wife, Edna, lived in the original farmhouse and raised four children: Baily Bennie, Norris Rueben, Vivian Lucille and Clarence Edward. Corn, cotton, milo and dairy cows were raised on the farm.

In 1998, Clarence Sr. acquired the farm after the passing of his parents. He and his wife, Ora, had four children: Charles Edward, Sharon Marie, Clarence Jr. and Linda Kay. Cattle and hay were raised on the farm. Clarence Jr. acquired the farm in 2012. He has two sons, Michael Ray and Jonathan Thomas. Hay and cattle continue to be raised on the land today.

Charles W.A. Ueckert acquired 1,040 acres from Jasper N. Daniel and E.E. Daniel in 1865. This land was part of the Four Leagues, No. 11 granted to Stephen F. Austin. Charles and wife, Adelaid, had seven children and raised livestock, cotton and milo.

In 1884, title to the farm was divided amongst the children. Bertha, daughter of Charles and Adelaid, acquired 362 acres. Bertha and her husband V.C. had six children. They raised livestock, cotton and milo.

Adela, daughter to V.C. and Bertha, and her husband, Hugo, acquired 100 acres of the land in 1922. Adela and Hugo raised their five children on the farm. They raised livestock, turkeys, chickens, watermelon, milo, corn and timber.

LaVerne, the daughter of Adela and Hugo, and her husband, Fred, acquired 31 acres after her parents deaths in 1974. They had two children and continued to raise livestock and hay on the land.

In 1996, LaVerne and Fred deeded the farm to their daughter, Sharon. Sharon along with her husband, Clayton, continues to raise livestock. They have one son, Clint. The family belongs to the Austin County Farm Bureau Association.

men Omenson was born in Skiold Parish, Stavanger, Norway in 1832. In 1855, he immigrated to America with his parents and siblings. They entered the United States through New York and eventually made their way to La Salle County, Illinois. Omen immigrated to Texas while his family settled in Nebraska. He tended sheep for ten years while living off the land in Waco. Norwegian was the only language Omen spoke. He was mustered into the Civil War in 1864, a war he could not understand.

In 1868, he bought 100 acres of land in Bosque County. On the farm he raised oats, barley, wheat, horses, mules, cattle, chickens, donkeys, hay and sugarcane. Omen married Eline in 1869. The couple lived in a small cabin with their seven children. In 1885, a new home was built. Omen and Eline paid passage for 35 Norwegian immigrants to live in Texas.

After Omen's death, the land was passed down from generation to generation. By the time he died he had accumulated 1,800 acres of land, owned seven houses and had given each daughter \$1,000 in dowries. Elaine, greatgranddaughter of the founder, currently owns the farm. Today, cows and hay are raised on the land.

Brown

Holloway Ellison was born in Alabama in the early 1800s. He moved to Caldwell County, Texas. He married Martha Roberts in the late 1840s. They had thirteen children including Eugenia Ellison.


Tyre Harris Brown, born in North Carolina, moved his wife Lydra to Tulip Ridge, Arkansas. In the late 1860s they moved to Caldwell County and settled in what is now the Brownsboro Community. With three sons, including Robert Adkins Brown. Robert married Eugenia Ellison On November 1, 1871. They had 11 children including Robert Eugene Brown, named after his father and mother. They lived on the Ellison farm, which his wife Eugenia inherited most of. They raised cotton, corn and livestock.

Robert Adkins Brown had 650 acres when he died in 1909. Robert Eugene Brown inherited and bought acres from his siblings for a total of 1000 acres where he

continued to raise cotton, corn and livestock.

This land was inherited by his only child Robert E. Brown Jr., who continued to raise cotton, corn, milo and livestock. He had only one child; Robert E. Brown III who inherited the 1,000 acres at his death on April 13, 1994. Today Robert E. Brown III and two sons, Robert E. Brown IV and Reginald W. Brown, operate a commercial cattle ranch and produce hay.

CHAMBERS COUNTY

FOUNDER: John H. Jackson

CURRENT OWNERS: Clay and Karla Jackson Dean


John H. Jackson was a descendent of Humphrey Jackson who originated from Ireland and came to Texas in 1823 with Stephen F. Austin's original 300. Upon the death of his parents, Hugh and Sophic, John, age four, moved to Double Bayou, Texas to live with his Aunt Letitia. As a merchant, he saved enough to accumulate over 30,000 acres of land in Chambers County. He became one of the largest landholders and ranchers in southeast Texas.

In 1934 he died, leaving approximately 20,000 acres of land to his nephew Solomon Barrow. Approximately 10,000 acres were left to his three boys, one being the current owner's grandfather, Arthur A. The Jackson Ranch then became The Jackson Brothers Ranch. Arthur acquired 5,306 acres, raised cattle and farmed. In 1953 he left 884 acres to Quinten,

who continued to ranch, breed cattle and horses, and improve pasture land for grazing and hay production.

Upon Quinten's death in 1995, his acreage was partitioned for better management and business purposes. It is currently in production and managed by his daughter Karla Jackson Dean.

FOUNDED: 1854

FOUNDER: Otto Fischer

CURRENT OWNERS: Carol Fischer Asher and

Thomas Asher

tto Fischer came to Texas from Germany in 1852. He married Adolfine and raised four sons. Over the years he added properties to his original land for a total of 1,600 acres at his death. Otto was a noted horse breeder of trotting and racing stock. He was known as the "Stock Fischer". His property was passed to his surviving sons, Rudolf and Waldemar, Rudolf and his wife. Elfrieda continued to raise livestock and farm the fields. The land was then passed to their four children. Walter, son of Rudolf and Elfrieda, and his wife, Ella, raised cattle and Angora goats.

In 1974, Fischer Ranch received Texas Family Land Heritage recognition for 100 years of agriculture production. In 2017, the Otto Fischer Homestead was listed in the National Register of Historic Places by the United States Department of Interior. A log home that was built in 1857 still stands on the land today and has the original cedar logs, caliche and hav.

Carol, daughter to Walter and Ella, and her husband, Thomas, continue to carry on the Fischer family's heritage by farming the fields, raising sheep, restoring pasture, and living in the family home built by Otto



Schaeferkoeter Ranch

COMAL COUNTY

23 miles NW of New Braunfels at U.S. Hwy 281 & FM 306

FOUNDED: 1862

FOUNDERS: Friedrich Wilhelm Schaeferkoeter CURRENT OWNER: Kenneth Schaeferkoeter

The Friedrich and Wilhelmina Schaeferkoeter family traveled from Westphalia, Germany to Indianola, Texas aboard the Creole in 1852 and rode by wagon train to New Braunfels. Once there, they traveled northwest to the Hill Country and built a two-room log cabin, and became a founding family of Spring Branch. In 1862, Friedrich obtained a 320 acre land scrip from the State of Texas. On the land they raised cattle, horses, sheep, hogs, feed crops, cotton, large gardens and orchards.

In 1901, Friedrich's son Wilhelm obtained the deed. He was married to Elisa and they had eight children: Melitta, Richard, Emma, Monroe, Harry, Ida, Fred and Thekla. Wilhelm co-owned a butcher shop in Blanco, a blacksmith shop in Twin Sisters. He hauled freight for merchants in Blanco, Twin Sisters and Fischer. They continued to raise livestock and crops. Wilhelm's

son Fred acquired title to the land in 1917. He married Florence and they had two sons, Ralph and Arnold. Ralph was married to Irene and acquired the land in 1960. They had one son, Kenneth. Kenneth received the deed to the homestead in 1983. He lives on the ranch along with his children, Chad and Stacie, and their families. Currently, the seventh generation of Schaeferkoeters resides in the original homestead.



FOUNDED: 1855

FOUNDER: Frederick Duderstadt

CURRENT OWNERS: Richard and Catherine Bettge

Chortly arriving after **S**Texas from Lutgenrode, Germany Friedrich Duderstadt Americanized his name Frederick. As an enterprising immigrant, he purchased 258 acres of land upon which he built a gristmill, castor bean oil press, cotton gin and cotton press. He was a teamster during the Civil War and acquired approximately 1,000 acres in his lifetime.

In 1880, Albert, son of Frederick, and his wife, Caroline, built a two-story house that still stands on the land. In 1884, Albert purchased 393 acres from Frederick which was passed to his son, Alois, and granddaughter, Ruth. Albert, in addition to raising and fattening cattle, was a butcher and horse trainer. He started using the bar 6D brand which is now used by the current owner but without the bar.

Richard married Frieda and they had one daughter, Ruth. Ruth acquired the land in 1947. She and her husband, Chester, operated a dairy for 20 years. When Chester died, the land was passed to their children, Richard and Hazel. The land is currently owned and operated by Richard and his wife, Catherine, as 6D Cattle, raising hay and cattle. They have two daughters, Lisa and Angic, and four grandchildren.

In 1860, John Stanley moved his Lwife, Mary, and his 10 children from Mississippi to Franklin County. He purchased the 240- cre J.A. Wimble Survey, below Ringo's Ferry, south of Sulphur River. The family grew cotton and acquired more acreage throughout the years. Following John's death in 1874, his unmarried daughter, Elmina, was deeded 57 acres of the land. Cotton farming continued on her land by twin brothers, Marion and Isaac. Later, Elmina lived with Marion's son, Sam. In 1918, Elmina died, leaving her land to Sam and wife, Addie.

Addie and Sam grew cotton, cucumbers, sold chickens and dairy products. They farmed a low-lying creek land to grow cane. Sam was well known for cane milling and his ability to process cane juice into syrup. In 1953, Sam and Addie borrowed \$1,170 to construct a

new house. In 1959, with Sam's health failing, Addie and Sam deeded their 57 acres to their son, Gerald, who was able to assume their loan, pay back-taxes and make improvements to the farm.

Gerald saw potential in ranching so through the 1960s he cleared land for pastures and began raising Hereford cattle. He added to his 57 acres, purchasing parcels of original John Stanley farmland. Gerald now owns 140 acres. Cattle continues to be raised on the farm.

The Beard Farm

HOUSTON COUNTY

10 miles W of Grapeland on FM 2544

FOUNDED: 1850

FOUNDER: Dr. Francis Lewis Meriwether CURRENT OWNERS: Peggy Beard Dworsky

Dr. Francis Lewis Meriwether was born in 1804 in South Carolina. Dr. Meriwether traveled with his wife, Ethalinda to Texas in 1845 and purchased approximately 2,000 acres in Houston County. In 1850 he had a house built and raised four children. The land was cleared for raising cotton, corn, milo and livestock.

Dr. Francis Meriwether died in 1888. His son, Frank Meriwether continued to live on the farm and raised cotton, corn, and livestock. Frank had three children that he raised on the farm, and after he died his two daughters acquired the land. One daughter, Jessie Irene Meriwether Eaves, remained on the farm, married and continued to raise corn and livestock.

The Eaves had one child named Julia Lee Eaves. In 1924, Julia married James Oscar Beard of Houston County. They had five children: Henry Arnold Beard, Frank Beard, Jane Hopson, Curtis Beard, and Ray Beard. Jessie died

in 1955 and Julia acquired what was left of the farm, which was 428 acres, known as The Beard Farm. Only corn was raised to feed livestock.

The oldest son, Henry Arnold Beard and his wife, Eva Abshire Beard, acquired 107 acres in 1973 and continued to raise cattle. They had three daughters: Susan Abshire, Barbara Irving and Peggy Dworsky. Peggy Beard Dworsky, the youngest daughter, and her husband David Dworsky, continue to operate a small cattle operation.

Born in Mier, Tamaulipas, Mexico, Gregorio Gomez and his family crossed the Rio Grande River from Mier into El Colorado, known as such not for the color of soil but for the color of the cattle, which is now known as Guerra, Texas. In 1866, he acquired 480 acres where he and his wife, Eugenia de la Garza Gonzalez Gomez, raised their children, cattle and goats,. They also farmed corn, beans and squash. After Gregorio's death, his son Teofilo inherited some of the land where he continued to raise cattle and goats and continued to farm.

After Teofilo's death his daughter, Rosa Garcia, inherited 11 acres in 1935. They continued with cattle and small livestock. In 1979, David, the youngest son of Rosa, was given the 11 acres through a quitclaim deed in addition to the 27 acres he purchased from his uncles in 1947. After David's death in 2000, his wife Osvelia acquired the land and her two sons continued to raise cattle. When Osvelia passed in 2008, the land was then inherited by her eight children. Presently, all three sons are still raising cattle and small livestock.



As a rancher, he raised cattle, hogs, and horses. Luke was known for his cattle drives to Abilene.

Luke passed away on December 7, 1919 at the age of 89. His surviving family included his widow, 18 children, 73 grandchildren, 65 great-grandchildren and one great-great grandchild. His son, Euel, acquired title to the land in 1938. Euel and his wife, Rina, raised four children on the ranch: Myron, Bernice, Marjorie, and Jim. Euel was the Llano County Commissioner for 18 years while

also actively ranching, raising cattle and hogs.

Euel's son, Jim, acquired title in 1976 and today actively raises commercial cattle. Jim was named Cowboy of the Year in 2014.

Constant R. Hall acquired 640 by Anson Jones, is in the possession of Alan L. Tinsley, Jesse D. Tinsley purchased the land in 1868, moved his family to the property that same year, and began farming and ranching activities raising primarily cattle, cotton and corn.

Jesse D. Tinsley died in 1890. James F. Tinsley eventually sold 40 of the 140 acres. While he owned his share of the property, he started the first cotton gin in Madison County. In the 30s, Bonnie Parker and Clyde Barrow crossed the property where they sawed off a shotgun. James F. Tinsley's five children inherited undivided interests in the property owned. Elizabeth Hensarling and Glynn S. Tinsley purchased the interests of their three siblings.

Elizabeth Hensarling sold her interest to Alan L. Tinsley, her nephew, in 1992. In 2010, Alan reacquired approximately 160 acres of the original 640 acres from a third party. He also inherited his father's interest in the property. Alan and his wife, Diane, own approximately 250 acres of the 640 acres and operate a cow/calf operation on the property.

John W. Justiss, born in 1829 in Georgia, made his way to Texas via the California gold rush. In 1868, he bought 146 acres. On this land he and wife Rachel C. Yancey reared five children. He had a wagon repair shop and raised corn, sugar cane, sheep and cattle.

Joe Justiss, the fifth child, acquired the land in 1928. He added acres to this land and raised sweet potatoes, cotton, corn, melons, sugar cane and cattle. He and wife Willie had 12 children.

Adron Justiss, the sixth son, purchased his siblings' share of the land in 1961, and paid it off when he was 86 years old. He was a Pioneer Polled Hereford Breeder, and registered his first animals in 1936. He and wife Mac Copeland of Georgia raised two daughters and were active in the Northeast Texas Hereford Association. They sold the original 146 acres to daughter Sheila and her husband in 1985 and they continued raising cattle on it.

In 2010, Sheila Justiss deeded the original 146 acres back into the larger family operation, Justiss Ranch, LLP, when she and Madron Justiss Hartley became heirs and general partners of the ranch. The two sisters have continued running the cattle operation selling bulls and replacement heifers each year to buyers in Texas, Arkansas, Oklahoma, Louisiana, Mississippi, Florida and Colorado.



The memorial category honors men and women who have lost their lives while engaged in agricultural-related pursuits such as working livestock, transporting agricultural goods or operating machinery.


The honor category recognizes those who

In 1883, Dorthea and Ulof acquired land in Bellville. They built the home where Hugo and his siblings were brought up, raised cattle and grew most of their own food.

Later in life, Hugo married Emma Hoff Hagen. In 1902, Hugo purchased 130 acres of land from Charlie Ueckert. Hugo and his wife had three children: Gardner, Lenora and Charlie. They continued to raise livestock.

After Hugo and Emma died in 1962, the land was split between

the children. In 1968, Lenora left her share of the land to her children William E. Brast and Dottie Brast Finch

In October 2003, William Brast divided his land between his three children: Janet, Randy and David. David Brast acquired 25 acres on which he built his current home. He, his wife and son still live there today and continue to raise livestock.



Wilhelm Doernbraack was born in Warbende, Germany and traveled to the United States. In 1885, he acquired 160 acres. With his wife, Anna, he raised livestock and farmed the land. They raised three daughters: Annie, Emma and Minnie. Annie and her husband, Charles, acquired the land from her parents in 1908. They raised three children: Zadie, Lee and Lillie May. They raised livestock, corn and cotton.

In the 1930s, during the warm seasons, the surrounding neighbors would gather on the farm for an event they called Butcher Club. A calf would be butchered to provide food for the families in the community, due to the lack of cold storage. Every week a different neighbor would donate the calf.

Lillie acquired the farm in 1966. She and her husband, Leonard, raised cattle, hogs, mules, horses, sheep, cotton, corn and hay. Iron ore was harvested off the land. They raised four children on the farm: Charles, Delores, William and Joy. They were one of the first in the community to win an electric refrigerator from San Bernard Electric Coop at the annual meeting in 1942. In 2018, the land was acquired by Lillie and Leonard's children. Cattle is raised on the land today.



Diane, Joan, Kathleen and Betty learned how to work the ranch at an early age and fought screwworms that affected the livestock. Predators took a toll on the sheep and goat production, so today the ranch is home to a set of black cows and two

Landon acquired 192 acres in 1935. He later expanded the farm to 254.29 acres. In 1927, Landon and his wife, Louise, had one child, Horace Kenneth. They raised peanuts, watermelon, peaches, plums, cattle, hogs, sheep and garden vegetables.

Kenneth held the title to the farm from 1948 to 1953, then again in 1969 when he and his wife, Nita purchased 253 acres, 155 acres of which were original 1891 parcels. Since Kenneth's passing, Nita has taken over the farm and raises cattle and hay.

In 1917, Tom sold the original 290 acres to his son Elmore, Elmore and wife Dema (Walker) Vestal raised three children: Loreta, Juanita and E.I. Jr. (Dick) in Callahan County. Dema acquired title to the land in 1958 when Elmore Isaac Sr. died. She raised livestock, peanuts, grains and hay with the help of Dick. In 1935, after her husband's death, Myrtle acquired the land. She moved to the town of Childress while Iley and family moved into the farmhouse to continue the farming operations. Myrtle and Iley acquired an additional 100 acres in 1938. In 1942, Iley purchased a portion of his mother's land to help with her personal finances.

Iley and his wife, Ethel, had six children: Peggy, Iley Jr., Betty, Michie, Jerry and Tony. They were raised on the farm, milking cows as well as plowing, weeding and helping pick cotton at harvest. In 1976, Iley bought the remaining acres of the original land. They continued to raise cotton, wheat and hay. After Iley's passing in 1996, his surviving children formed the Compton Farm Partnership. In 2013, after Peggy's passing, her son, Arlon Williams Jr., was added to the partnership. Today, Compton Farm Partnership grows cotton and continues the Compton legacy.

Stephan and his wife, Frances, purchased the original 160 acres from his parents, Anton and Josephine, in 1911. The couple, along with their two children, Regina and Edwin, continued operating the land. In 1920, Stephan died unexpectedly leaving Frances with half of the land while each of the children acquired a half undivided interest. They continued to raise livestock and hay. In 1951, after Frances died, both Regina and Edwin each partitioned off part of the original land. In 1971, Regina gifted part of the original 160 acres to her daughter, Lorease. Lorease continued raising cattle and planting grasses to produce better hay meadows.



August and Mary purchased 480 acres in 1907, and then added 440 acres in 1913, to form the current Novian Place. They had four children Mary Katherine, Anne, Zanata and James. They raised horses, cows, sheep, cotton and wheat.

Mary Cornelia acquired title to the land when her husband passed in 1952. She continued to operate the stock farm until she died in 1975. At that time the property was in an undivided estate for Mary Katherine Wood's children, Janette, Judy, Gwen, Ed, Robert, Richard and Mike. After Mary Cornelia

died, Richard and Robert operated the ranch. In 2011, Richard Wood divided his 90 acres plus 45 he had purchased from a sibling.



They had five children: Souli, William, Harry, Lessie and Arthur. In 1905, S.J. began buying land northwest of Rocksprings and acquired about nine sections throughout the years. He moved his family to this land in 1912. S.J. raised 500 Angora goats, 250 Delaine sheep and 500 Hereford cattle on the ranch.

After World War II, S.J. and Serena bought a home in Rocksprings and Arthur ran the ranch. Serena died in 1946 and S.J. in 1956. The ranch was divided, with Arthur receiving three sections and Souli, Burk and Lessic each receiving 1,116 acres. Souli gift deeded his share to his only son Souli James (Tooter).

Clemens Immel purchased 160 acres of the Big Flat property in 1942 and continued to live with his wife, Viola "Olie" Klein Immel, in the original home that Albert had restored 30 years earlier. They had three children, Lyndon, Alton, and Geraldine. They raised oats, wheat, cattle, sheep, hogs, and turkeys.

Clemens died in a tractor accident in 1976, leaving Olie and Alton to continue his work. The property was then passed to Hattie Craven Sanders, Tennie Craven Blackerby, Isaac Craven, Jr. and Jackson Craven. These

children and their families lived on the property and continued to raise cattle and crops. In 1990, John T. Jordan Sr. began the process of putting the original parcel back together for his wife Betty Jacqueline Craven Jordan, graddaughter of the founder. They live and raise cattle on the 102 acres of the remaining property.

?rank Edens Taylor was born in P Houston County, Texas near the Trinity River. He grew up raising cattle on a large piece of property belonging to his family. In 1912, Frank E. Taylor married Orie Sue Howard Taylor. They had two children, Sue and Henry Frank. In 1917, Frank acquired 1,611 acres and began raising corn, cattle, cotton, hay and sugarcane to support his young family. In 1922, he downsized to 494 acres for his farming and cattle operation. He was an innovative farmer who was the first in Houston County to own a tractor.

His son, Henry Frank Taylor, bought property next door and raised three children: Josephine Taylor, Frank Edward Taylor, and Margaret Sue Taylor. Orie Sue Taylor acquired the title to the land in 1968 when Frank passed away. The land was no longer used for row crops; it was exclusively a commercial cattle operation.

In 1994, Margaret Sue Taylor Riess and her husband, Barrett Riess, acquired the land from Orie Sue Taylor. They continued to raise cattle and work hard to restore the property to function efficiently. They raised two children, Julie Michelle Riess and Cameron Scott Riess. The family is active in the Houston County Farm Burcau and the Independent Cattleman's Association.

Jim and his wife, Ivan, had five children: Harold, Francis, William, Sarah, and Joe. When Jim died in 1959, his son Harold, took over the farm operation. The farm land was divided between the siblings in 1967 with the death of Ivan.

In March 1972, Harold and wife, Viola, purchased the 154 acre farm from Harold's siblings. They had four children: Donald, Connie, Brian, and Audrey. Harold died in 1992 and his son, Don, took over the farming operation. Viola died in 2014 leaving the farm to her four children. In 2016, Don and his daughter, Chasta England,

acquired all but 24 acres of the original 154 acres from his siblings. Audrey retained the remaining 24 acres

From 1918 to 1992, the England Farm produced livestock, cotton, wheat, milo and corn. Since 1992, the England Farm has produced hay that supplies feed to cattle and horse operations.



m rank}$ John Bedrick, emigrated from Czechoslvakia to the United States in 1898. In 1909, he purchased 100 acres situated in Kaufman County. Comprised mostly of Czech emigrants, the community became known as the Lonestar Community. Frank Bedrick Sr. planted corn, cotton, milo and oats. There was also a cow barn, hog barn, blacksmith shop, spring-fed well, and two cisterns - these remain today.

Frank and his wife, Anna, had two sons, Frank Jr. and Joseph (Joe). In 1945, the 100 acres were deeded to Joe and his wife, Rosic Pucelik. Joe and Rosie raised cotton, corn, milo, oats, hay, cattle, chickens, turkeys and a large garden. In 1947, Joe and Rosie built their house. There was no electricity until the 1950s in the community, so they used

coal-oil lamps for light and cooking, a battery radio and a wood stove for warmth.

After Joe and Rosie's passing, their two daughters, Roseann and Margaret, inherited the 100 acre farm. Roseann purchased Margaret's half in 2008 and currently lives on the farm with her son, Glenn Morrow.

Pritz Basse and Olga Usener Basse of Fredericksburg bought 3500 acres of ranch land in west Kerr County in 1917. They had two children, Anita and Leroy, who grew up on the ranch. The family raised sheep, Angora goats and cattle.

Fritz and Olga deeded 931 acres each to Anita and her husband, Bob Ned, and to Leroy and wife, Marjorie, in 1951 while Fritz and Olga retained 1406 acres, and created three separate ranches. Anita and Bob Ned called their portion T Bar Ranch. Following Olga and Fritz's deaths, the remaining ranch land was gift deeded to each of his children, Anita and Leroy.

Anita and Bob Ned had two children, Charles and Nelta LaVerne. In 1972, they deeded 703 acres to Charles and wife, Joy, and to LaVerne and husband, Rickey.

In 1918, Tom Phillips and Belle Parker purchased a ranch in Kimble County. They farmed cotton, corn, and hay, as well as raising sheep, goats and cattle.

Tom and Belle's son, Charles C. Phillips, and wife Alice, took ownership of the land in 1955 and operated the Phillips ranch until 1990.

In 1990, the Phillips ranch was gifted to their three children, Charles D., Jack Wayne and Nancy Jane. Jack Phillips and his wife, Sharon, acquired the remainder of the land from Charles D. and Nancy Jane in 2001 and 2004. They currently raise cattle and wildlife on 1570 acres.

Upon the death of Anita and Bob Ned, Charles and Nelta LaVerne inherited additional land in 2000.



Orn to parents of German Dand Alsatian descent, Louis Heller purchased three sections of La Salle County property in 1913 from the State of Texas land grants. Despite an abundance of Prickly Pear Cactus and Senecio, Louis had intended to grow vegetables on this parcel of 1920 acres. He had been enticed by promises of it becoming part of a "Breadbasket of the World" region, but soon discovered that things were not quite so simple - irrigation was necessary. The small creek on the property proved unsuitable for this purpose, thus the land was used instead for grazing cattle and wildlife management. Various crops to feed both were developed over the years, including oats, wheat, sesame, maize and milo.

Property ownership passed from Louis to his sister, Mary Heller, before being passed to her daughter, Julia Heller Meiners. Her son Elvis W. Meiners acquired the ranch from her in 1935. Since E.W.'s death in 2002, the ranch is jointly owned and managed by Elvis's daughter Elva (Meiners) Keilers and his son Don Louis Meiners, the two comprising Meiners Partners GP, Inc. It also serves as beloved second home for their families who continue his ranching and wildlife operation.



G.W. Young was born in Wayne County, Tennessee in 1852. In 1900, he visited his brother in McCullouch County and liked the opportunities he found. He purchased 160 acres in 1900 from A.R. Watkins and his wife.

G.W. and his wife, Martha, raised five children on the farm: Katie, Emma, Walter, Woody, and Harvey. The two youngest sons died as young men and Emma moved away for college and recieved a teaching position. Katie and her husband, L.C. Sansom, remained on the land and helped her father raise cattle and grow corn, cotton, wheat and oats. Katie's brother Walter farmed nearby.

In 1936, Emma was deeded this land by her father, but he continued to farm it. After G.W.'s death, Emma sold her land to her brother-in-law, L.C. Sansom, in 1949. When

Katie and L.C.'s daughter Emagene was given the deed to this parcel in 1959, they continued to operate the spread. After Emagene's death, her husband, Charles, continued their work until his passing in 2015.

Albert's son, John, acquired the title to the land in 1926. John and his family raised crops such as cabbage, broccoli, carrots, onions, cotton, and corn. John and his wife, Mary, had two children, John Jr. and David.

In 1935, John gave his sister, Stella, 95 acres. Stella and her family raised cattle, cotton and grain sorghum. Stella and her husband John had five children: Mary, Annie, Bennie, Celia, and John Jr. In 1979, Stella

sold her 95 acres to her nephews and their wives, to ensure the land was kept in the family.

Today, Hans and Loring Kircher (great grandsons of Albert Thomas) farm over 2,700 acres and run cattle. They raise crops, incuding cotton, grain, sorghum, corn and a home garden. Russell came to Texas in the 1850s and became a prominent land owner, rancher, merchant, farmer and silver miner in Presidio County. He was the great-grandson of General William Russell, American Revolutionary War soldier credited with aiding in the drafting of the Declaration of Independence.

In 1889, William purchased 160 acres of land, known as *La Punta Del Agua* from Dionicio Mata which included a two-room rock house. He gave the land to his two daughters, Lucia "Lucy" and Anita. Anita sold her share to her sister. Lucia and her husband, Natividad Vasquez, grew wheat, corn, beans, squash, peaches, and raised goats, chickens, turkeys and cattle.

In 1913, the eldest son of Natividad and Lucia, Conrado L. Vasquez, knew that the community was in need of a post office and store. He decided to name it Casa Piedra, Spanish for rock house. The Casa Piedra United States Post Office and store opened in 1913. In 1947, Conrado purchased 560 acres from his parents and added 5152 acres. Conrado gifted all 5712 acres to his children, Conrado H., Armando, and Conchita. Today, the ranch is owned and operated by Armando and Conchita. Conchita has converted the Post Office and store to a family museum containing old pictures and artifacts.

They raised 10 children at "Okonski HomePlace" with 100 acres. Joseph raised corn, tobacco, livestock, poultry, tomatoes, and sold logs and wood from his sawmill.

Edward L. Okonski was born in 1906 and married Helen Novak in 1929. They stayed at the "Okonski HomePlace" while his parents moved one mile west. Seven children were born in the "Okonski HomePlace". Edward raised livestock, corn, cotton, turkeys, and tomatoes.

Gene Okonski, son of Edward and Helen, purchased all property of original 100 acres between 1978 and 2004 from parents and siblings. Gene raises cattle and coastal hay and has been actively involved in Okonski Ranch since the early 1950s.

Gene's son, Kevin, his wife Sherry, and grandsons Tyler and Ryan are also enjoying the Okonski HomePlace and Ranch.

They raised cattle and wheat on this property through both World Wars, the Great Depression, the Dirty '30s and the drought of the 1950s. The unbroken ownership of the property has resulted in a partnership of all great-grandchildren of the original founder being the current owners.

Henry Mohr was born in Germany. He and his wife, Kate, came to Washington County with their family. Henry purchased 282 acres from W.I. Taylor in 1889. He raised corn, cotton, cattle, and hogs, and operated a cotton gin. They had three children: William, Fritz and Gustav. They schooled their children in the former Anson Jones home on the adjoining farm.

Gustav Mohr bought 50 acres of the farm in 1915, built a blacksmith shop and raised corn, cotton, hay, hogs and cattle. He milked his cows and sold cream to Blue Bell Creamerics in Brenham.

In 1950, Charles Mohr purchased the 50 acres and Fred and Raymond raised corn, hay, and cattle. In 1958, Fred Dickschat purchased the farm and continued operation.

In 1990, Raymond Dickschat

purchased the 50 acres and continued raising hay and cattle. He received the Washington County Farm Bureau's Outstanding Farmer and Rancher Award in 2013. Raymond and Joy are 4-H adult leaders. All four sons are Gold Star Recipients and are Texas A&M graduates. Three sons are active in farms operations and two grandsons are county extension agents. All family land will be passed on to the children.

D.G. Sims of Newsite, Alabama acquired a 160 acre ranch in Mobeetie, Texas with his wife, Effie, in 1918. They raised beef cattle, cows for milk and cream, chickens, butcher pigs, cotton, and grain along with three children – Ruth, Mary, and Jack.

In 1977, Jack Sims and his wife LaRue acquired the land. They had three children: Sharon, Harry, and Kyle. They raised cattle, horses, and planted improved grasses on the original 160 acres.

In 1990, Harry Sims and wife Sherry acquired the land. They continued to raise cattle and horses and planting improved grasses for the livestock on the original 160 acres, but took the initiative to expand the ranch to the current operating acreage of 3,680 acres. Many fences have been replaced due to the recent fires. Harry and Sherry have two children, Juhree and Tye; four grandchildren,

Lauren, Chase, Savanna and Kelton; and two great-grandchildren, Jerry and Jack. The original home, never altered by nature, is used for a camp house and guest quarters. Harry and Sherry live nearby on an addition to the ranch, and Tye's family lives on another addition to the ranch.

William (Willie) Steven Stadler was born in Cherokee County, Texas in 1862. He married Bertha Pryor and they had seven children: James Earl, Ernest (died in infancy), Audrey, Pearl, Arthur "Pete", Addie, and William Alton.

On January 11, 1901, Willie and J.A. Pryor acquired 400 acres of land in Wilson County. In 1907, Willie Stadler became the sole owner of 200 acres situated nine miles southeast of Floresville. He raised livestock, cotton, corn, milo, peanuts and watermelons.

William Alton Stadler acquired the title to 68 acres of the land in 1942. His brother, James Earl Stadler, acquired 69 acres of the land at the same time. They both raised livestock, corn and peanuts. Richard Alton Stadler acquired title to the entire 68 acres that William Alton Stadler had owned in 1989. In 1998, he acquired title to 45 acres of the land which had been owned by James Earl Stadler.

Richard and his wife, Louise, live on the land and raise coastal grass and hay for their cattle. They have three children: Randy, Beverly, and Dana.

William (Willie) Steven Sadler migrated from Cherokee County, Texas to Wilson County, Texas in 1898. He brought his wife, Bertha Pryor Stadler, and three children, James Earl, Audrey and Pearl. On arrival, he rented land and farmed cotton. In 1900, he and his brother-in-law, J.A. Pryor, purchased 400 acres of land west of the Cibolo Creek in the Sunnyside Community.

In 1907, Willie built a home and established a homestead with his wife on the western 200 acres. Willie and Bertha had three additional children: Arthur "Pete" Stadler, Addie Stadler, and William Alton Stadler. In 1916, Willie purchased an additional 175 acres of land located nearby on the west side of the Cibolo Creek. Willie raised his family while farming and ranching this land until his death in 1942.

All six of Willie's children lived their adult lives while farming, ranching, and raising their families within four miles of the original Willie Sadler homestead.

Today, Tommy and his wife Shirley, own a portion of the original William Stadler homestead and are proud to continue their legacy of farming and ranching.

Born in McMinn County, Tennessee, Robert G. Cates acquired 640 acres and moved to Decatur, to provide a better life for his family in 1871. He raised beef cattle and horses, and grew cotton, corn and peanuts. Robert also served as the county's sheriff for 11 years. He and his wife, Elizabeth Taylor, had 10 kids, including Charles Franks Cates and Joe Claude Cates.

Charles acquired 100 acres of the original parcel of land in 1899. Charles used the land for cotton, corn, peanuts, and cattle while raising his six kids with his wife, Lucy.

In 1903, Charles' brother Joe, acquired the 100 acres from Charles Frank and continued to use the property for cotton, corn, peanuts, and cattle. Joe and his wife, Mary Jane Champion, raised

two children, including James Gordon Cates.

James Gordon Cates acquired 95 acres of original parcel in 1969. Following James' passing in 2014, the land was left to his wife, Laura Maria Cates. The property is maintained by Laura's son, Joseph Lee Greene, Jr. To this day, the land is used for coastal hay and beef cattle.

He aquired 25 acres from his brother, Richard Henry L. Galloway, in 1887. William and his wife, Nancy, had seven children: Thomas, Francis, Robert, Mary Ann, William, Richard, and Martha Eudora. Acquiring another 25 acres in 1902, the family lived on and worked their land; raising cotton, peanuts, corn, hogs, chickens, cattle, and horses.

Martha Eudora gained ownership of the 50 acres in 1936. Martha married Pursley Daniel Radney in 1908 and the couple had 11 children: Robert, Ola, Almer Virgil, Florence, Eva, Lendsey, Lela, Nancy, Rubin, Amanda, and Bertha. They raised cotton, peanuts, corn, hogs, chickens, cattle and horses.

In 1970, Almer Virgil acquired the 50 acres. He married Willie Mozell Gilbreath in 1935 and had five children: Dortha, Linda Geneva, Roy, William, and Valta. They raised cotton, peanuts, corn, grade B milk, hogs, chickens, cattle, and horses.

Linda Geneva, married to Charles Ray Busby in 1960, acquired the 50 acres in 2004. They had two children, Cathey and Mark. Linda and Charles continue to raise beef cattle and hay today.



Eleuterio Lopez was born in Guerrero, Tamaulipas, Mexico in 1889. He was brought to Texas at the age of 12 to work the land at La Encantada Ranch and El Huisache Ranch as a cowhand. Here he learned ranching and farming. In 1906, Eleuterio purchased 1,280 acres from the State of Texas where he raised livestock, beans, corn, cotton and sorghum.

Eleuterio married Eva Pena in 1909. The couple had nine children: Esther, Pedro, Amador, Lauro, Alonzo, Antonio, Eleuterio Jr., Evangelina and Agustin. After Eleuterio's death in 1962, Eva and her children continued the farming and ranching operation. They raised livestock and cotton.

In 1968, Eva Pena de Lopez passed away and the 1,280 acres were divided amongst the nine children. Each one of the children got 139 acres and they continued to raise livestock.
