PURPOSE: "To establish a climate conducive to the development of technical, vocational, and manpower training in educational institutions in the State of Texas to meet the needs of industrial and economic development of the state."

S. R. 865 By: Brooks

WHEREAS, the development of effective occupational training programs in the public educational institutions of Texas is vital to the industrial development; and

WHEREAS, the administration of many technical-vocational programs in Texas is under two or more State Agencies; and

WHEREAS, there now exists a critical need for coordination and cooperation in the administration of occupational training courses administered by more than one agency; and

WHEREAS, the 61st Legislature has passed Senate Bill 261 creating the State Advisory Council for Technical-Vocational Education and Governor Preston Smith has signed it into law; now, therefore, be it

RESOLVED, that the Senate of the 61st Legislature formally requests the State Advisory Council for Technical-Vocational Education to conduct a study and evaluation of public education programs in the field of occupational training which are administered in whole or in part by more than one State Agency, and report its findings and any legislative recommendations it might formulate to the 62nd Legislature convening in January, 1971.

# Summary of Reviews and Recommendations of the Advisory Council for Technical-Vocational Education in Texas

The Advisory Council staff requested, received and reviewed statutes giving authority to and under which twenty-nine state examining and licensing boards operate. In addition to the review, the Advisory Council staff visited staff members of the following boards: State Board of Cosmetology; State Board of Barber Examiners; State Board of Plumbing Examiners; Texas Board of Vocational Nurse Examiners; and Texas Board of Licensure for Nursing Home Administrators. Telephone interviews were made with selected boards in addition to the above. Unless otherwise stated, licensing and examining boards consist of six members appointed by the Governor for six year staggered terms. Refer to Chart No. 1 for the Summary Review.

The Advisory Council staff conducted a review of the Manpower training and services programs with the cooperation of several agencies and groups.

The resulting tabulation is found in Chart No. 2 of this report.

Since its establishment, the Advisory Council has studied data contained in Chart No. 3 believing that the flow of funds is one strong indication of the highly fragmented management structure of technical-vocational education in the state. Further, Charts No. 2 and 3 contain current fiscal year data and may be compared with similar data contained in the First Annual Report of the Council.

FINDINGS resulting from the study conducted by the Advisory Council are as follows:

 Generally it was found that licensing and examining boards reviewed were functioning effectively and efficiently in the best interest of the public.

- There was formal and informal coordination and cooperation between the members of boards, their staff and state agencies and members of their staff. There was found to be some variance as to the extent of such coordination and cooperation.
- 3. There was substantial evidence that licensing and examining boards make efforts to accommodate applicants for licensing while fulfilling their responsibilities to the public being served.
- 4. As is evidenced from the review of Chart No. 1, the majority of the twenty-nine licensing and examining boards do not have responsibilities for occupational training and/or their responsibilities do not overlap with those of other state agencies or boards.
- 5. It was found that many boards have responsibilities for examining and licensing in occupational areas in which rapid changes occur. In such instances, there is question as to whether adequate provision is made through the board and its staff to (a) be fully aware of such changes within the occupational area served, (b) evaluate standards under the responsibility of the board in view of changes and advances in technology and techniques and (c) periodically evaluate instruments and techniques of examination as they relate to the skills and competencies required in work within the occupational area.
- 6. As is evidenced in Chart No. 2 of this report, the number of programs, services and agencies involved in Manpower Training and Services in the state is multitudinous. This is further evidenced by data in Chart No. 3. The local, area, state and national Cooperative Area Manpower Planning System (CAMPS) has achieved substantial success in coordination of programs and services among the various agencies

- involved. Many of the programs listed in Chart No. 2 have been initiated and for the most part are funded by Federal agencies. Major efforts have been made to utilize many "services consumers" in the planning and administration of this long, long list of programs. Many linkages have been established between agencies and organizations involved.
- 7. For the most part, agencies and organizations provide the services for which they are best equipped. With the large number of programs and agencies involved, the efficiency of administration and delivery of services is certainly questionable.

#### RECOMMENDATIONS OF THE ADVISORY COUNCIL are as follows:

- 1. That the State Legislature establish a legislative committee, state commission or other mechanism,
  - (a) to conduct a review of state licensing and examining boards in the state to evaluate the effectiveness and efficiency of such boards in relation to their objectives and responsibilities;
  - (b) to conduct public hearings, if and when needed, to serve the best interest of the public and occupational area served;
  - (c) to serve the arbitration function between boards and state agencies that have overlapping responsibilities; and
  - (d) to report to the Legislature on December 1 preceding the convening of the Legislature in January.
- 2. That the State Legislature direct state agencies, organizations and boards involved in CAMPS at the local, area and state levels to review the administration and delivery system for manpower training and services to achieve greater efficiency and economy, with the

ultimate goal being that state and federal agencies condense and streamline the administrative process which is now so complex; and that such actions be reported at least every six months to the State CAMPS and subsequently to the Advisory Council for Technical-Vocational Education in Texas for a report to the State Legislature as of December 1 preceding the convening of the Legislature in January.

Board examines approximately 2900 applicants each year. It is estimated that 12% fail the examination. The Board maintains licenses for 45,000 LVN's in the state, of which it is estimated that 39,000 are active. Must renew license annually. Board is responsible for all schools meeting standards as these relate to facilities, equipment, faculty, curriculum and others.


