Report of the Director - Librarian

To the Texas Library and Historical Commission:

The significant accomplishments of the Texas State Library are reported for the 29th biennium, September 1, 1964 - August 31, 1966.

The Commission was host for the 28th annual meeting of the Society of American Archivists in Austin from October 6-10, 1964. Of particular significance to library development in Texas was the First Texas Governor's Conference on Libraries in Austin, March 23, 1966. Partly, as a result of the Governor's Conference and the work of the State Library, the agency has received three awards: (1) The 1966 *Award of Merit*, was presented by the Texas Library Association, following the Governor's Conference. The citation reads, "For meritorious achievement in broadening the role of the Library in its services to the State as demonstrated by the Regional Field Consultants, by the distribution of Texas State Documents, by the Centralized Processing Center, and by a major effort in the interests of the First Texas Governor's Conference on Libraries. Other services have shown constant improvement, and, most importantly, the staff has contributed a sense of cooperation which engenders an optimistic outlook for the future of library development in Texas." (2) At the 1966 American Library Association meeting in New York, the Texas State Library was presented the *John Cotton Dana Award*. This award was presented for outstanding publicity among state libraries and the citation reads, "For a well organized effort to highlight a successful Governor's Conference." (3) Also at the time of the American Library Association meeting, the State Library was presented the 1966 *Grolier National Library Week Award* for work done in Texas during National Library Week. The Austin Telephone Directory issued in December, 1964, carried on its cover a picture of the State Archives and Library Building.

The Director and Librarian, as the Executive and Administrative Officer of the Commission, has been a participant in a number of library and archival functions during the biennium.

On the national level, he was appointed by President Lyndon B. Johnson to a nine-member Advisory Committee on Library Research and Training projects. The committee was authorized by the 1965 Higher Education Act, which provides grants to colleges, universities, and other organizations for research geared to improve libraries and librarian training programs.

Also on the national level, the Director and Librarian served as a member of the Planning Committee of the Association of State Libraries and Chairman of the Joint Committee on Local and State History, American Library Association, and was a delegate to the Extraordinary Congress of the International Council on Archives held in Washington, D.C., May 9-14, 1966. Within the State he has served on the Library Development Committee of the Texas Library Association, given speeches to library Trustee and Friends groups throughout the State, spoken at numerous library dedications, and has been a frequent speaker for patriotic groups. Visits to libraries within the state have been made when time permitted. The Director and Librarian also serves as the Chairman of the State Board of Library Examiners and Chairman of the Records Preservation Advisory Committee, created by the 59th Legislature.

Outstanding accomplishments of each division within the State Library are outlined in detail on the following pages.

Administrative

Prior to July, 1966, the Administrative Division was under the direct supervision of the Assistant State Librarian. On that date the duties as head of the Administrative Division were turned over to the Staff Services Assistant in order to free the Assistant State Librarian for more administrative duties in relation to the State Library as a whole and to work more closely with the administration of the Library Services and Construction Act, especially with the expanded Act to include the two new titles incorporated in the original Library Services and Construction Act from 1964.

The Administrative Division is charged with the responsibility of personnel administration; preparation of the Biennial Budget with the advice and guidance of the Director and Librarian; fiscal affairs of the agency; inventory control; centralized purchasing; and library information contained in the brochures, exhibits, and in the Library's publication *Texas Libraries*.

A steady increase in the pieces of informational literature distributed by the Texas State Library on history and other subjects about Texas has been made during the past biennium. The total number of pieces will exceed the hundred thousand mark and requests continually come in, especially from the schools throughout the state and the nation. Close cooperation is still in effect between the Texas State Library and the Texas Highway Department, as well as other state agencies, in distributing information items relative to their respective agencies. New brochures have been produced and the revisions of previous brochures are still being made.

During the First Texas Governor's Conference on Libraries, held in the spring of 1966, the Assistant State Librarian took charge of the exhibits for this Conference. In connection with this duty, eight graphic presentations were produced and exhibited in the Conference area during the Governor's Conference. They have been in constant use since the Conference and were used at the Texas Library Association meeting following the Governor's Conference. This exhibit concerned the function that

the State Library assumes in library development in the state of Texas and pointed up the need for better support of public libraries in Texas.

One of the most time-consuming duties of the Administrative Division in the past biennium was the placing of equipment orders, not only for the State Library's needs, but also for the various public libraries throughout the state through Library Services and Construction Act funds. The purchasing office initiated 1030 purchase requisitions for supplies and equipment, and 1077 items of equipment were added to inventory.

It is recommended that a study be made during the next year of the 1966-68 biennium regarding the automation of the various aspects of the fiscal affairs of the State Library. If this study proves that it would be feasible to further automate various aspects of fiscal duties, then this work should be centered in the Administrative Division of the State Library in order to better control all funds expended through the State Library agency.

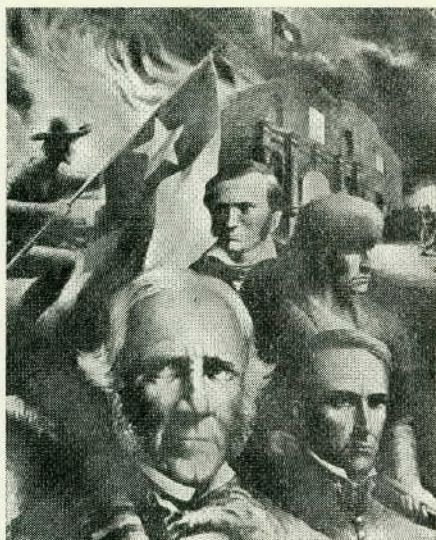
In June, 1966, a new division of the State Library was created—the Blind Services Division—and with this new division the responsibility for this specialized service was divorced from the Administrative Division where it had been for the past few years. Prior to its connection with the Administrative Division it had been associated with the functions of the Reference Division. Because of the phenomenal growth of this service over the past two years, and because of a greatly anticipated future growth due to the expanded Library Services and Construction Act of 1966, it was felt that full division status should be afforded this very important section of the State Library. Full division status for this section is keeping in line with *STANDARDS FOR LIBRARY SERVICES FOR THE BLIND* of the American Library Association, which was recently published and distributed to members of the library profession.

In accordance with Public Law 87-579 of the U.S. Congress in 1962 setting up and expanding the U.S. Government Depository libraries, the State Library attained one of two regional libraries in the State of Texas. This status entitled the State Library to receive one copy of every publication distributed by the Superintendent of Documents and consequently greatly enlarged the acquisitions program of this section of the Library. In order to fully utilize the information in the collection, this section was transferred from the Administrative Division to the Reference Division in July, 1965. Because of the experience that the Assistant State Librarian had in the use of these publications it had previously been his responsibility under the Administrative Division to supervise directly the operations of this section. With the experience gained during the past biennium of the person presently in charge of this section, it has been decided that it could be better administered under the Reference Division.

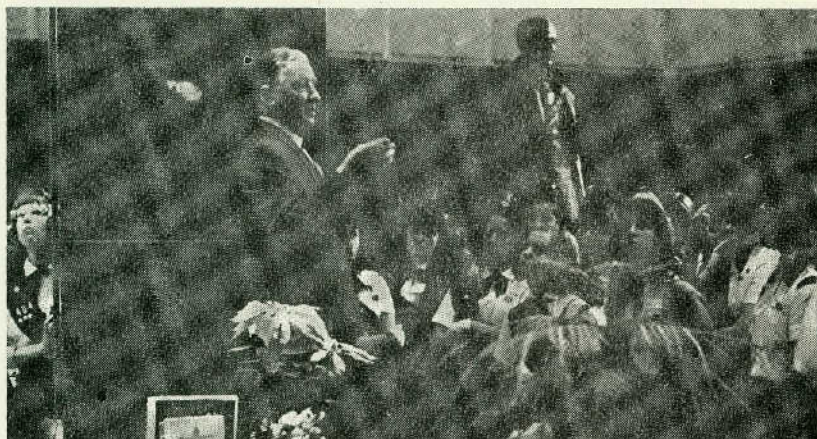
During the biennium 181 new employees and 145 terminations were handled through the personnel office. There were also 92 payroll changes made which included promotions, demotions, time status changes, and salary adjustments. The State Library

has an employee evaluation system and the evaluations are a determining factor in awarding merit salary increases. Seventy-nine merit increases were earned during the biennium. The personnel office also processed 391 applications for positions during the biennium, in addition to those applicants that were employed.

Before the end of the 1966-68 biennium it will be necessary to acquire additional space to house some of the offices of the Administrative Division. Space now is at a premium, and as additional staff members are added as requested in the 1967-69 biennial budget, office space will be needed to accommodate those additional persons employed who will be directly supervised by the head of the Administrative Division.



During the past two years, thousands of visitors have poured into the foyer of the Texas Archives and Library Building to see the Texas History Mural. Created by Peter Rogers, the mural depicts the panorama of Texas history—a welter of subject matter from Conquistadors to cowboys and from the Alamo to oil wells.





Archives

Research in the Archives Division maintained a level during the biennium, September 1, 1964-August 31, 1966. On the average 312 persons performed research each month of the biennium compared with 335 persons per month during the preceding two years. Complete statistics are given in Appendix I. The work load has remained much the same except that the museum function was assigned to the Archives in July, 1965.

Only three changes in personnel have occurred during this period. Floree Haire, Clerk Typist I, and Andrew Smith, Janitor, retired on May 31, 1966, and Donna Yarbrough resigned effective August 31, 1966. Randolph Whittington filled the Clerk Typist I position and Robert Manz became the Janitor. On September 1, 1965, a new position of Librarian I was added. This was filled by Marilyn Von Kohl.

The Texas Documents Section began the biennium with definite plans for improving the procedure for collecting and distributing state documents. Trips were made to several state supported institutions of higher education to outline a program for acquiring the appropriate publications in the correct quantities needed. The "depository libraries" located in the institutions visited, and in the areas nearby, were given a program for building and managing a collection of Texas Documents.

Twenty-eight libraries located in Texas which were receiving routinely one copy of each available document were given the opportunity to change their status. Eighteen of them chose to be allowed to select those documents needed or desired. Currently there are thirty-seven "depository libraries" for Texas Documents. In addition to the depository libraries, ten libraries in Texas and thirty libraries throughout the other states receive routinely one copy of each available Texas Document. There are approximately sixty-five libraries in Texas and throughout the other states which select and request only those Texas Documents which they need or want.

Currently eighty-nine state agencies, boards, commissions, departments, and institutions are contributing state documents for

this operation, an increase of ten over the previous biennium. Perpetual record keeping of the number of each report distributed indicates that the average requirements are 110 copies of each publication.

A campaign of visiting, telephoning and corresponding with the agencies was begun to reduce the quantities from 150 copies as stipulated by law to 125 copies on all routine publications so that 15 or fewer surplus copies of each document would be left for storing indefinitely. Definite quantities were requested of the special reports which, heretofore, were haphazardly supplied.

Statistics on the operation of the Texas Document Section include the following: Approximately 82,000 documents were collected from 89 state agencies, boards, commissions, departments, and institutions. The publications consist of an estimated 650 titles and editions of various types of reports. Approximately 72,000 of these documents were distributed to 150 libraries located in and out of Texas. It required 4,100 mailing containers individually packed in which to dispense the documents. The 10,000 surplus documents are stored for replacement copies and requests in the future. Twelve issues of the bi-monthly "Checklist of Official State Publications" were compiled, reproduced and mailed to 200 libraries of all categories, and to persons and organizations throughout the states. Two libraries in foreign countries are receiving the Checklist. Twenty-four issues of the monthly "List of State Publications Issued" were compiled, reproduced and mailed to 36 "depository libraries" and 84 state agencies. Approximately 1,400 letters were written seeking information, requesting documents, and answering requests for documents and information. The work of this section was recognized in 1966 in a merit award from the Texas Library Association.

Both the Director of State Archives and the Archivist have participated in professional activities. Mrs. Osburn, Archivist, delivered archival addresses to the Fort Belknap Genealogical Society (May, 1965), the Austin Genealogical Society (July, 1965), and the William B. Travis Chapter, Daughters of the Republic of Texas (December, 1965). She has also been active in the work of the Archives and State and Local History Round Table, Texas Library Association. During the biennium the Director of State Archives represented the Library at the meetings of the Society of American Archivists, New York, 1965, Texas Independence Day Celebration, Washington-on-the-Brazos; Texas State Historical Survey Committee, Odessa; and American Library Association, Detroit. When the Society of American Archivists met in Austin in 1964, he served on the Local Arrangements and Program committees.

During the biennium the Director of State Archives has made addresses to the following patriotic and historical associations: Sam Houston Shrine Association; Henderson County Historical Survey Committee; West Texas Historical Association; Bastrop County Historical Society; Odessa Civil War Round Table; Texas Permian Historical Society; Austin Genealogical Society; William B. Travis Chapter, Daughters of the Republic of Texas; Texas

Masonic Lodge of Research; Laredo Historical Society; and San Antonio Historical Society. In May, 1965, he was elected a Fellow in the Texas State Historical Association, and in July, 1965 was presented the C. S. Hammond Company Library Award by the American Library Association for work in publicizing the maps of the Archives.

The Archives publication program has progressed satisfactorily. Four books on the legislative sessions of the Tenth Texas Legislature (1863-1864) have been completed, with introductions being written by Dorsey B. Hardeman, John Ben Shepperd, Ben Barnes, and Neveille Colson and Walter E. Long. Of the eight volumes printed on the legislature in the Civil War, four received the "Award of Merit" from the Texas State Historical Survey Committee and the Texas Civil War Centennial Commission.

The biennium is notable for the installation of shelving on the main stack floor which resulted in the transfer of the archival materials from filing cabinets to Hollinger boxes. An important restoration was performed on the battle flag captured from the Mexican Army at the Battle of San Jacinto. The 59th Legislature appropriated money for this work which was magnificently performed by Mrs. Josephine Roser of Fort Montgomery, New York.

Accessions for the Archives Division have been satisfactory. The listing below is intended to show all of the gifts to the Archives in addition to some of the more important purchases. The possibility of overlooking a gift is recognized and if this occurs, forgiveness is asked in advance.

Blind and Physically Handicapped

Since 1934 Texas State Library has been serving as one of the 32 Regional Libraries throughout the country designated by the Division for the Blind, Library of Congress, to carry out the program of circulating reading materials for the blind. Braille books and Talking Books provided by Library of Congress funds are distributed by this library to legally-blind persons residing in the state of Texas.

Until June 1, 1965, the Regional Library for the Blind functioned as a branch of the Administrative Division. Increased volume and expansion of services warranted a change of status—the creation of a separate division for Blind Services.

During the past two years there has been an astounding acceleration in the registration of new readers, an average of two new applicants per day having been sustained. After deducting the number of readers who for various reasons (loss of hearing, removal to another state, regaining of vision, senility, or death) became inactive during this period, statistics as of June 29, 1966, indicate a present biennial increase in registration for this service of 931 Talking Book readers and 96 Braille readers. Circulation reports for the same period indicate a comparable increase. During the present biennium there has been a circulation of 290,314 Talking Books and Braille books, as compared with 174,463 during the last biennium—an increase of 115,851.

In addition to the tremendous volume of Talking Books and Braille books which this Regional Library is now circulating among its 3812 Talking Book patrons and 439 Braille readers, several additional services are now being offered.

A notable recent development in the national program is the provision of books recorded on *magnetic tape*. These books are available for free loan to any legally blind person who owns a tape recorder. Already Texas State Library has become a participant in the circulation of taped books. The Library of Congress during the past year has provided this library with master copies of more than three hundred titles of books in this medium, and almost daily additional ones are being received. Using the

recording equipment bought for that purpose, this library is recording copies for circulation. Although official announcement of the tape program has not yet been made, already approximately 400 owners of tape recorders have requested the service. While it is not believed that books on tape will ever replace the Talking Book in disc form, they will always be a very fitting supplement; and, very soon, will most likely be a program of equal magnitude to that of the Talking Books.

For many years the provision of enlarged books in large or clear type for the use of the partially-sighted or visually-handicapped has been an objective of workers and organizations in this field. Several recent events have stimulated a new awareness of the great need for books in this medium. Texas State Library during the past year has set up a collection of *Large-Type* books, the number of titles now having reached approximately 200.

Numerous requests for library service have come to the Regional Library from visually-handicapped Texans who do not have enough vision for reading large print and yet whose visual acuity does not fall to the level of legal blindness, thus being disqualified for the regular Talking Book program. In an effort to meet the reading needs of this group of individuals who are entirely bereft of any kind of reading material, Texas State Library during this biennium has set up a collection of recorded books now numbering well over 500 titles. These books, not being subject to Federal restrictions which limit library service to the legally-blind, are being circulated on request to any handicapped Texan who, for any reason, cannot read ordinary inkprint and who can provide his own record player.

In the belief that many blind readers should benefit by physical access to library service at the local level, Texas State Library, in cooperation with the Division for the Blind, Library of Congress, has continued the establishment of small collections of Braille books in selected locations throughout the state. Having begun this practice in the previous biennium, it has now been extended to include collections located in Dallas, Houston, San Angelo, the University of Texas, and the Lighthouse for the Blind, Austin. In these locations space is provided where blind patrons may "browse" just as sighted patrons do.

The Regional Library has continued its close contact with numerous private agencies for the blind who are able to provide many types of specialized reading material which are not available through the Library of Congress. Hundreds of requests for these materials are forwarded each year by this library to such agencies as Recording for the Blind, Inc., John Milton Society, both of New York; Braille Circulating Library, Richmond, Virginia; Lutheran Library for the Blind, St. Louis; Jewish Guild for the Blind; American Bible Society; Christian Record Braille Foundation, Lincoln, Nebraska; Hadley School for the Blind, Winnetka, Illinois; and many others.

In the summer of 1966 blind children were privileged to participate for the third time in the Texas Reading Club, a summer program planned for sighted children and sponsored by all Texas

public libraries. The response this year was greater than either of the two previous years, 100 blind children having registered for membership in the club. At the close of the summer those children who submit reading logs indicating that they have read the specified number of books, either in Talking Books or Braille, will receive a personalized brailled certificate similar to those awarded sighted members of the reading club.

A close working relationship exists between the Regional Library and the State Commission for the Blind, who supervises the distribution of Talking Book machines. In April, 1966, a representative of the Library was invited to attend a statewide workshop in Dallas sponsored by the State Commission for the Blind and attended by all counselors, home teachers, and other field workers employed by the Commission. A feature of the program was a discussion period when the resources and available services of the Regional Library were outlined in detail, representing a fine spirit of cooperation between the two agencies and pointing up many areas in which each can supplement the work of the other.

The director of Blind Services has participated in national and international conferences focusing attention on the problems and general needs of the blind.

Much insight into new possibilities for study and education for the blind was gained by attending the annual conference of the American Association of Workers for the Blind and the quinquennial World Assembly of World Council for the Welfare of the Blind, both held in New York in late 1964.

As a result of attending these meetings opportunity was provided for valuable and highly worthwhile visits to many agencies in the New York area which are engaged in work for the blind.

In October, 1965, the Division for the Blind, Library of Congress, called a conference of the 32 regional libraries throughout the United States to convene in Louisville, Kentucky, home of the American Printing House for the Blind, the largest agency in the world dedicated to the production of reading materials for the blind.

At this time the librarians were brought up to date on all matters pertaining to the production of braille, Talking Books, and books recorded on magnetic tape—all of which make the same contribution to the blind in his struggle for individual and social independence as does good library service for sighted individuals.

Locally, Blind Services Division has participated in activities related to many agencies and organizations whose interests are either directly or indirectly related to the blind. Among these are special programs for Senior Citizens, the Governor's Committee on Aging, American Association of University Women, Future Teachers' organization of St. Edward's University, Parent-Teacher group of the State School for the Blind, and the Austin Volunteer Visual Aides—a group engaged in supplying supplementary textbook material to meet the needs of blind children attending public schools.

Traditionally, all services for the blind have been separated from programs for individuals with other disabilities. For the past few years much attention has been given to the question whether it is desirable to expand library services for the blind so as to let it become a general reading program for all categories of the disabled. Recent evaluation of the question resulted in new legislation as outlined in Library Services and Construction Act, Title IV, Part B, which extends the library service to include the two million handicapped persons in the United States, only 400,000 of whom are eligible to be served through the present national books-for-the-blind program.

Obviously, the new legislation is going to necessitate drastic changes in the overall operation of Blind Services Division of Texas State Library.

The present biennial increase of more than 30 per cent in enrollment of the legally blind, plus the three-way expansion of services during the past year, are already taxing to the limit present staff and facilities. It can readily be seen that new and far-reaching demands of the new legislation will make it mandatory that added floor space, shelving, and equipment be secured. Additional office staff will be required, including the position of Assistant-Director.

Unquestionably, the increased responsibility that will accompany a complete reorganization of Blind Services Division should bring about a re-classification of the directorship in the salary schedule, giving this position equivalent consideration to that of parallel positions in the other divisions of the library.

The future outlook for this division of the State Library is one of tremendous challenge. The recreational and educational values of reading are basically the same for everyone. Physically limited people, however, face special problems that can be alleviated through an effective library program. Because of the unique position which the blind hold in society they are well-equipped to give leadership in developing services for all the handicapped.

No individual or organization survives in isolation, and we are realizing, more and more, that socially we are not independent beings. The welfare of any one group depends upon the welfare of all groups. The library is a human enterprise, and all human beings should be the concern of all libraries.

Legislative Reference

The Legislative Reference Division experienced a period of relative stability during the biennium of 1964-1966. There was no change in personnel until the last month of the biennium.

The early part of the biennium was spent in preparing for the convening of the Fifty-ninth Legislature. A form letter was sent to the members of the House and Senate to remind members of previous legislatures and to inform the new legislators of the service provided by the Legislative Reference Division. Attached to this letter was a biographical form and a request for the members to complete the form. It was hoped that the response would be sufficient to publish a pamphlet containing the biography of each of the legislators. Although the response was not great enough to accomplish this purpose, the Division now has the beginning of a biographical file of the members and this file will grow as time passes.

The Regular Session of the Fifty-ninth Legislature convened January 12, 1965, and adjourned May 31, 1965. As in the past, the Division was open from 8:00 a.m. to 9:00 p.m. Monday through Friday and all day Saturday. Two student assistants were on duty at night to handle requests for legislative reference material and to file and index the copies of bills and journals received daily by the Legislature. Also the daily journals were mailed weekly to the depository libraries in Texas. As in the past, the "bill book" was posted daily. The book contains a complete legislative history of each bill. This book contains page references to the daily journals of each stage of any bill or resolution.

The use of the library has increased with each legislative session. During one typical week of the legislative session, the Legislative Reference Division was used by over 600 patrons. Because of the collection being primarily reference material, circulation figures are misleading, but average circulation during the session averaged 300 books and pamphlets a week.

The post-session work consisted of sorting and indexing the large amount of material received from the members as they

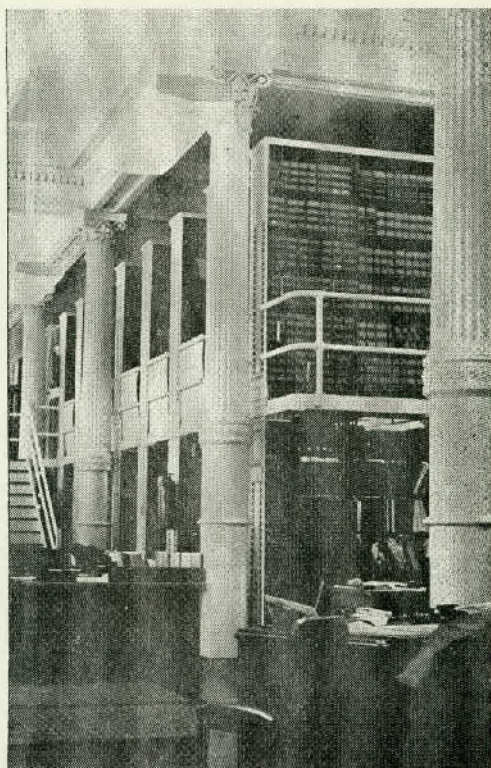
cleaned out their files. The Division requested the members to send their unwanted material to the library rather than disposing of it. In this way the library is able to acquire many documents and pamphlets not obtainable by the usual sources.

The period was also spent in bringing up to date the various compilations of laws and lists available to interested citizens. These publications are: Library Laws of Texas; Chief Elected Officials of Texas; The Texas Flag Laws; The Hazlewood Act; Marriage and Divorce Laws; Sessions of the Legislatures of Texas; Congressional Apportionment Laws, Legislative Apportionment Laws and, Statutory County Courts of Texas.

The Legislative Reference Division has attempted to specialize its holdings during the past biennium. Subscriptions to loose leaf services and periodicals have been expanded. At the present time, the Division subscribes to approximately 260 periodicals and numerous loose leaf services. The Division also acquired a clerical supervisor to allow the librarian to devote full time to the cataloging of Texas Documents. Work on the Texas Documents catalog was begun in 1961 as a part-time project. At the present time, the catalog is complete through the Texas Railroad Commission. It is hoped that it will be completed during the next biennium.

Although the work of the Division will never be complete, it is felt that much has been accomplished during the past biennium. The holdings have been increased, the cataloging of Texas Documents continues, and the use of the library services by the legislature, legislative employees, state officials and the general public continues to multiply as reliance on technical knowledge becomes increasingly important to a government in a complex society.

The Legislative Reference Division is located on the second floor of the State Capitol. One of the oldest divisions in the State Library, it was created in 1909 "for the use and information of the members of the Legislature, the heads of the several State Departments and such other citizens as may desire to consult the same, a section of the State Library for legislative reference and information."



Field Services

The Texas State Library carries out a program of public library development throughout the State. This program is administered by the Field Services Division and uses funds made available through the Library Services and Construction Act (LSCA).

Several years of planning and studying have gone into this program which reflects the thoughts and advice of many people. Gradually the plans grew and finalized into the "Texas State Plan for the Further Extension of Public Library Service" and the "Texas State Plan for Public Library Building Program." These two plans were submitted to and approved by the U. S. Commissioner of Education in Washington. Periodically these plans are revised as thinking and needs change. Currently, three main projects are carried out in the State Library's Plan under Title I (Services) of the LSCA.

- (1) Statewide planning and services.
- (2) Multi-county bookmobile demonstrations and aid. To be discontinued at the time local governments take over operation.
- (3) Library service improvement program.

Under Title II (Construction) a city or county may apply for funds to build or expand a public library facility. Fifty per cent of the total cost of the construction project may be provided to qualifying libraries. Thirty-five libraries at present are being constructed under this program.

On December 1, 1965, metropolitan librarians were asked to come to Austin for a planning session to consider specific extension programs. The librarians attending that meeting were Mrs. Lillian Bradshaw, Dallas; Wyman Jones, Fort Worth; Miss Elizabeth Kelly, El Paso; Mrs. May Lea McCurdy representing Austin; Mrs. Harriet Reynolds, Houston; Irwin Sexton, San Antonio; and Mrs. Phyllis Burson, Corpus Christi. It was the general con-

sensus of opinion that the large public libraries should extend inter-library loan and reference services to libraries in their area. Specific programs of this type of cooperation would have to be worked out locally on an informal basis.

Since these librarians would be working more closely with librarians in secondary size cities, the State Library asked a representative group to a similar work session on January 12, 1966. The participants included Miss Thelma Andrews, Abilene; Miss Alice Green, Amarillo; Mrs. Flora Wilhite, Baytown; Mrs. Reta Piland, Beaumont; Mrs. Walter Dix, Brownwood; Mrs. Hazel Richardson, Bryan; Mr. Jerry Hunt, Denison; Mrs. Kathleen Cook, Orange; Mr. John D. Hyatt, Galveston; Miss Lucy Stiefel, Port Arthur; Mrs. W. B. Miller, Temple; Mr. David Holt, Waco; Miss Katherine Ard, Conroe. As this was the first time representatives of this size libraries had met, many interesting projects were discussed and news of developed projects was exchanged. These librarians were eager to develop interlibrary loan and reference referral policies with neighboring libraries. The need for a statewide communications system was seriously studied as was a statewide library card. In the future, other librarians from across the State will be asked to come and exchange ideas and help the State Library in its planning.

In the work sessions mentioned and in daily contact with persons interested in library service, several outstanding examples of cooperative practices have been noted. A sample listing of these will give an idea of what is taking place in Texas at this time. All of the examples cited here are in libraries presently in the LSCA program.

1. *Trans Pecos Project.* With the active support of the El Paso Library Board, Miss Elizabeth Kelly, acting librarian, is carrying out an extensive program of public library development in that part of West Texas defined as the Trans Pecos. El Paso will serve as the major resource center for the libraries in this part of the State. Services from El Paso include interlibrary loans, reference referral in-service training, and guidance to library boards and civic officials in the creation and strengthening of their libraries. The building up of book collections will be a primary goal of this project. Counties included in this project are Brewster, Culberson, El Paso, Hudspeth, Jeff Davis, Loving, Pecos, Presidio, Reeves, and Terrell.

2. *Corpus Christi Service Area.* La Retama Public Library is undertaking extension of its services to surrounding counties. Mrs. Phyllis Burson and members of her staff have been active in giving leadership to the Coastal Bend and Rio Grande Valley sections. County, college, and public libraries are combining several of their cataloging and processing procedures. The city of Corpus Christi has a master plan developed by Bartholomew, Harland, & Associates of St. Louis which is being used to make the city a trading center. The library as a public service organization plays a key role in this plan. Of major importance will be the area

reference center to be housed at La Retama. This center of reference materials in depth will give service to surrounding libraries.

3. *Abilene Public Library.* Miss Thelma Andrews has long been recognized as a librarian interested in extension of public library services and cooperative ventures. The Abilene library serves Shackelford and Taylor Counties through a bookmobile and other libraries have long received inter-library loans and guidance. Miss Andrews is the chairman of a committee to study and institute cooperative programs in TLA's District III. A union list of serials was the first such project to be completed under the committee's supervision.

4. *Council on Libraries.* In the spring of 1964, the State Library sponsored three workshops on library problems in metropolitan areas. Mrs. Gretchen Schenck conducted the sessions with the assistance of the Field Services Division Staff. The workshops were held in Beaumont, Houston, and Fort Worth. From the Houston group emerged a very interesting and new concept for Texas. They suggested the creation of a library council of laymen to make recommendations on library service to an entire metropolitan area. The League of Women Voters of Houston voted to take this project over and see that the Council was created. All governmental bodies as well as library boards concerned were contacted for approval of the idea. These bodies have agreed to the creation of this advisory council and as soon as persons are found to serve on it, the council will begin to study the situation and make recommendations.

5. *Multi-County Library Cards.* John Hyatt of the Rosenberg Library in Galveston and Mrs. Mary Owensby of the Harris County Library worked out arrangements between the two counties that permit any patron of their libraries to use any library in either system. Harris County Library also has this agreement with Montgomery County Library under Miss Katherine Ard. Surrounding counties may sign similar contracts in the future. County courts and city councils are somewhat reluctant to open their libraries to non-tax paying residents, but librarians with vision are showing the way through new patterns of service.

6. *Multi-County Library Organizations.* Counties with small populations will do well to join forces with surrounding counties to give library service. This does not mean that a group of weak libraries will produce a strong system. Standards must be the goal of these combinations. One such group of libraries included Kerr, Gillespie, Kendall, and Bandera counties. First brought together by a bookmobile demonstration, these counties maintained a multi-county library organization after the close of the demonstration. The member librarians meet periodically to work on common problems and exchange collections of books. The completion of the proposed Kerrville library, to be a gift of Mr. and Mrs. H. E. Butt, Sr., will make a true library system a reality

in the Hill Country. A new organization just formed includes Mason, Kimble, Menard, Concho, and McCulloch counties.

The services offered by the Field Services Division are carried out through three major projects:

PROJECT I. State-wide Planning and Service:

1. "Library Excellence: Today's Necessity" was upheld as the goal and the need for Texas library development in the First Texas Governor's Conference on Libraries, March 23, 1966, in the Municipal Auditorium of the Capital City, Austin.

Approximately 2,500 citizens from 220 of the state's 254 counties participated in a program keynoted by Governor John Connally and implemented with speeches by Robert Vosper, UCLA librarian and president of the American Library Association; Chancellor Harry Ransom of the University of Texas; Mrs. Weldon Lynch, library consultant and lecturer, Oakdale, Louisiana; and former Texas Governor and member of the Texas Library and Historical Commission, Price Daniel.

2. The most important work done by the Field Services Division was rendered by the field consultant staff. These staff members worked under difficult conditions to provide guidance and understanding to public librarians and interested citizens throughout the State. The consultants made 983 calls on 417 cities.
3. During the past two years 40 workshops were sponsored by the division. In-service training programs were also conducted. The workshops were held as follows:

The most outstanding workshop listed above was the Library Buildings Institute conducted by Hoyt Galvin, nationally-known consultant on library buildings. About ninety-eight per cent of the librarians attending the workshop are now planning, presently in or having just completed a building program. The many letters received by the State Library concerning the results of the workshop have attested to its high quality and value.

4. The State Library produced a thirty minute sound and color film highlighting its services. The film has won acclaim from the several thousands of persons that have seen it at club meetings, workshops, conferences and television showings.
5. *Texas Reading Club*. "The world's largest reading club" continued to grow as more boys and girls joined this summer reading program co-sponsored by Texas State Library and local libraries. Many young people were introduced to their public library for the first time when they joined the Club. Others who had belonged before continued to enjoy the services of the public library. City and county officials were asked to present certificates to members having read the required twelve or more books. Librarians sent enthusiastic letters concerning the Club. Local newspapers gave considerable coverage to its activities. A total of 95,357 reading logs were requested by libraries for their members.
6. *Book Improvement Loans*. The Extension Section of the Field Services Division helps small libraries develop reader interest and book collections. A total of 100,932 book loans were made to 155 cities.

PROJECT II. *Multi-County Bookmobile Demonstration and Aid*

1. As local governments take over the operation of bookmobile service, the State Library will withdraw from this area of demonstration of library service.
2. Such service was provided in Morris, Camp, Titus, Franklin, Bailey, Parmer, Cochran and Lamb counties.
3. Counties assuming local support and operation were Taylor, Shackelford, Caldwell, Fayette, Hays, Hardin, Polk and Tyler counties.

PROJECT III. *Library Service Improvement Program*

1. Programs carried out in the past under Project III, Regional Library Demonstration, and Project IV, Post Demonstration Aid, are now revised under this project.

2. Cities and counties participating in this program signed agreements with the State Library allowing local funds supporting library service to be listed as matching funds under the services title of the Library Services and Construction Act. The goal of this program is to bring standard library service to all citizens through cooperative efforts.
3. Libraries participating in the LSCA program under agreement with the State Library; wherein almost fifteen million dollars (\$15,000,000) of library appropriations are involved, are:

Other libraries are encouraged to join in this pattern of service and become members of library systems. Interlibrary loan and reference service will be strengthened first in these systems. Regular mail deliveries will be used to handle this service presently, but new concepts will be considered for future use.

CONSTRUCTION PROJECTS.

In addition to the service improvements made available through Title I (Services) of the Library Services and Construction Act, funds were also available for the construction, expansion or remodeling of public library buildings under Title II (Construction).

The State Library contributes one-half the cost, within maximum limits, of the projects. These new buildings which will fit into our long-range objectives by providing bases for the extension of library services that will continue to be developed in the future. An amount of over six million dollars (\$6,000,000) of local and federal funds are involved in the above approved projects.

Records Management

Records Management Division has been sparked with a new way of life. Enactments of S. B. 244, 245, and 246 by the 59th Legislature have provided momentum to establishing a modern and functional records program.

Highlights of this records management legislation include:

- (1) Designation of 60,000 square feet of records storage space in the new State Finance Building.
- (2) Requiring that each agency shall:
 - a. classify and index their records;
 - b. furnish the Records Management Division with a copy of the index;
 - c. name a retention period on records to be stored;
 - d. request destruction of worthless records.
- (3) Establishing a Records Preservation Advisory Committee.
- (4) Requiring essential state records to be microfilmed.

Records Division personnel are preparing for the future move to the State Finance Building by reboxing, reindexing, and consolidating material for all agencies in anticipation of providing a well organized records management system.

Over 1850 boxes have been reboxed. Sixteen of the 23 storing agencies have been furnished with a revised up-to-date index of material which they have in storage. More than 10,000 boxes and 25,000 bound volumes have been moved or renumbered in order to consolidate material and provide a smooth flow of equipment and material during the 1969 move.

Records Division personnel are working together with the Building Commission and architects to make this new storage facility a big success.

Each agency storing records with the Records Division has been notified of their responsibility under Sec. 3, S. B. 245. Thirteen agencies have complied with all requirements. An example of compliance with the destruction of worthless records is reflected in the statistical data of this report. A decrease of 3302 cubic feet of material is reported for the 1964-66 biennium. This decrease will provide additional storage for semi-active records which could not be accepted in the past.

The Records Preservation Advisory Committee is composed of the State Librarian as Chairman, the Secretary of State, the State Auditor, the State Comptroller, the Attorney General, the Secretary of the Senate, and the Chief Clerk of the House of Representatives. This committee will work with the Records Division to establish uniform records management procedures throughout all state agencies.

The first meeting of the Records Preservation Advisory Committee was held August 17, 1965. Two additional meetings have been held since that time with the following results:

- All agencies storing records with the Records Division have been notified of the functions of the Committee and its desire that all requirements in Sec. 3, S. B. 245 be fulfilled.
- Each agency was requested to appoint a Records Administrator. All 23 have complied.
- Standards for the transmittal of records to the Records Division were submitted to the committee and approved. This "Instruction Sheet for Transmittal of State Records" will maintain a uniform procedure for indexing, boxing and classifying records transferred to the Records Division.
- A bond of \$5,000 was taken out for the State Librarian and the Records Preservation Officer as required by Sec. 3, Art. 5441a, V.A.T.S.

A microfilm project is now under way at the Records Division with over 100,000 essential documents on film. In order for a record to be considered essential, it must fall under one or both of the following categories:

Category A—Records containing information necessary to the operations of government in an emergency created by a disaster.

Category B—Records to protect the rights and interests of individuals, or to establish and affirm the powers and duties of government in the resumption of operations after a disaster. (Sec. 7, S. B. 246)

In years to come, microfilming will be one of the most important services provided by this division and a great asset in the preservation of essential state records.

Records Division is staffed by 3 full-time and 6 part-time employees. As in the past, services such as receipt, circulation, maintenance and disposal of records have been rendered to 23 state agencies.

During this biennium, 6252 boxes of non-public records were destroyed by the shredding machine. The scrap paper created by this process along with an additional 10,360 boxes of unprocessed material was sold under a Board of Control contract to a local paper company.

The verification of prior state employment and prior teaching experience continued to be an important function of this division. Eighty-three requests for a total of 397 years of state employment were verified. There were 261 requests for a total of 861 years verified for teachers seeking retirement benefits.

Early this year, the Records Management Division had the pleasure of assisting the F. B. I. in a survey made on Texas voter registration. Records dating back to the early 1900's through the early 1950's were examined for 24 counties. As many as 35 agents were given assistance during the five days required to make the survey.

The Records Management Division is constantly searching for ways to make better use of its floor space. During this biennium, over 70 bulky meatlockers were removed from the records center. The material contained in these meatlockers has been transferred to metal shelving which occupies less than half of the floor space previously required. A project to replace file cabinets and transfer cases with open shelf filing is now under way. By making this conversion the space above the present cabinets will be used.

Records Management Division will continue its efforts to provide additional storage space and better service to all state agencies in hopes of having a superior records management program.

SUMMARY OF RECORDS RECEIVED 1964-65

The figures represent the total number of records received from each agency. They are classified as boxes and bound material. Boxed records are classified as follows: Legal size (15x11x24); Perma-Pak (15x11x12); and Warrant size (8½x4x24). Bound volumes from each agency vary in size and are listed as cubic feet of space which they occupy.

Reference

Progress can best be measured in terms of the types of services performed by the division for state and federal employees, for interlibrary loan, and for genealogists.

With the aid of state and federal funds, the Reference Division strengthened its collection and added to its staff during the 1964-66 biennium. This expansion was imperative because of the increased demands for materials and services made by the citizens of Texas.

A brief summary of statistics indicates that the reference staff answered 7141 genealogy questions and 7938 reference questions, received 9333 loan requests, sent out 8823 books on interlibrary loan, and circulated 10,490 books to state and federal employees. In addition, the federal documents section received 8003 local requests and 3699 requests by mail, circulated 13,929 documents locally and 9484 by mail, received 54,602 documents, classified 30,419, and ordered 356 items.

An unusual event outside the customary routine was the ceremony on October 18, 1965, in the Reference Room when six paintings of Texas missions by Mr. Granville Bruce were presented to the Texas State Library by Mr. and Mrs. John B. Godfrey. Governor Connally accepted the gift for the library, and remarks were made by the donors, the artist, Dr. Dorman H. Winfrey, the Director-Librarian, and Mr. Stanley Banks, Chairman of the Texas Library and Historical Commission.

On display was a beautiful volume describing the history of each mission, with chapters written by six Texas authors, among whom were Dr. Dorman H. Winfrey and Mr. James Day, Archives Director.

In August, 1964, a new director was appointed. One person was added to the staff, two resigned, and one was transferred to another division. The staff now numbers five full-time workers, plus two student helpers. A federal documents librarian took charge of that section in September, 1964. One person has been added to this staff, which now numbers two full-time workers and two student workers.

State and Federal Employees. The staff conducts research and locates information for this group. Almost 8000 reference questions were answered with the help of new reference tools purchased in the past two years.

The general collection was also strengthened and new books placed on open shelves so that patrons could browse at their leisure. Four ranges of double shelving increased space in the reference room.

Periodical holdings were greatly expanded by the addition of 150 new periodical subscriptions. Current issues are placed on display for easy accessibility.

These new materials were especially appreciated during the session of the 59th Legislature, which lasted from January 12 to May 31, 1965. For the convenience of the Legislators, the division was open from 8 a.m. to 9 p.m. Monday through Friday and from 8 a.m. to 12 noon on Saturday. A librarian was on hand to assist patrons at all times.

The Governor's Committee on Aging, workers in the federal poverty program, and officials of state agencies found useful information in the division because an effort was made to buy books to assist them in their work. The need for new material was proved when circulation figures more than doubled those of the previous biennium.

A recent acquisition was 103 reels of microfilms of the World War II records of the 36th Infantry Division, which are now being used by an author who is preparing a history of this division.

Interlibrary Loan. The Reference Division is the general library for Texans who do not have access to a local library and serves as a supplemental source to the collection of public libraries through a system of interlibrary loans. This activity required a great amount of time, as the number of requests received exceeded by 5000 those of the preceding two years. More than 8800 books were sent to every part of the state. The addition of one clerical position and one seasonal helper expedited the service.

A new interlibrary loan policy was written and mailed to all public libraries in the state. A statement of services to schools was also prepared and sent to students and teachers who requested information.

Important factors in honoring loan requests were new indexes and books. These, together with Xerox copies of periodical articles, supplied information on subjects of current attention, such as lasers, LSD, and unidentified flying objects.

The number of requests for books of Texas history and biography reflected the interest of citizens in their state. For this reason, standing orders for all Texas items were placed with thirty-four publishers.

Third copies of books and works not related to Texas but held by the Archives Division were transferred to the Reference Division in 1965 and placed in a special collection on the seventh stack. These books are gradually being incorporated into the regular collection of the Reference Division. It is gratifying to know that the State Library now has Texas material available

for loan.

Genealogists. Many new books were added to the genealogy collection, and genealogists were enthusiastic about the purchase of microfilms of the federal population census schedules for all states for the years 1840 through 1880. The microfilms, a reader, and a reader-printer, recently acquired, constitute an important resource for family researchers. Patrons travel many miles in order to view these records.

The Austin Genealogical Society supported the genealogy collection through its gifts of books bought by members of the Society. This group also added periodicals to the collection. Housing the increasing volume of materials is a problem to be faced soon, as shelf space is very limited.

Two genealogy workshops, sponsored by the State Library and the local chapters of the Daughters of the American Revolution and the Sons of the American Revolution, were held in February, 1965 and April, 1966. As a result, a representative from the local chapters is now in the division each Wednesday to assist those who want to trace their family lineages. It is hoped that in the future a genealogy librarian will be added to the staff to take care of the many requests.

Projects. Two important projects are now underway. The task of organizing the pamphlet collection of the Extension Loan Library of the University of Texas is continuing. Periodicals holdings are being listed and will soon be available to the public. When completed, these projects will make more accessible the materials of the division.

U. S. Documents Section

The U. S. Documents Section has been operative as a separate section of the Reference Division since September 1, 1964. At that time a staff was assigned to provide documents reference and processing services and to administer the U.S. Regional Depository Program. The period since 1964 has seen the greatest expansion of the U.S. documents program at the Texas State Library since it became a depository over one hundred and twenty years ago.

The Texas State Library is now a regional depository for Government Printing Office publications. In addition, subscriptions have been entered for the Office of Education Cooperative Research Reports and the Library of Congress Documents Expediting Project materials. For publications such as Congressional Committee Prints and other documents not available through the sources mentioned above, acquisition procedures have been established and have proved effective.

A major accomplishment was the completion of the acquisitions checklist on June 7, 1966. Since June, 1966, a record has been made of every document received by the Texas State Library. Consideration was given to future plans for automatic processing, and existent data is designed to be fully used whenever such a system is established.

Another project is an inventory of topographic, geologic, geographic, and historic map holdings. Upon completion, the record will include compilations of numerical, geographic, and/or subject catalogs. The section has planned a complete listing of all U. S. documents holdings, which should be completed by the end of the 1966-1968 biennium.

The U. S. Regional Depository Program for Region II became fully operative in the 1964-66 period. Procedures were established for the exchange of duplicate government publications, and a statistical survey of depository collections in Region II was made.

The need for comprehensive documents surveys was evident from this preliminary survey. Such surveys would be possible with a larger staff. Plans are being made to coordinate the efforts of the documents depositories, the Texas Chapter of the Special Libraries Association, and the State Technical Services Office in providing adequate information on resources within the state.

Staff Activities. The preceding report surveys the work of the division by a staff that has also been active in professional activities. The director participated in a panel discussion at the Reference Round Table meeting of the Texas Library Association in 1965 and spoke to the Austin Genealogical Society in the same year. She attended the 1965 and 1966 meetings of the American Library Association, the 1965 and 1966 meetings of the Texas Library Association, the 1964 meeting of the Southwestern Library Association, and 1964 and 1965 meetings of the Texas State Genealogical Society.

The federal documents librarian, Mrs. Martha Cotera, participated in a nationwide workshop on acquisitions, organization, and administration of government publications, sponsored by the Drexel Institute of Technology in Philadelphia, Pennsylvania in 1966.

It is regrettable that the division is soon to lose the services of Mrs. Kay McMurrey, past president of the Austin Library Club. She was awarded the 1966 Texas Library Association scholarship for graduate study and will attend the University of Texas Graduate School of Library Science.

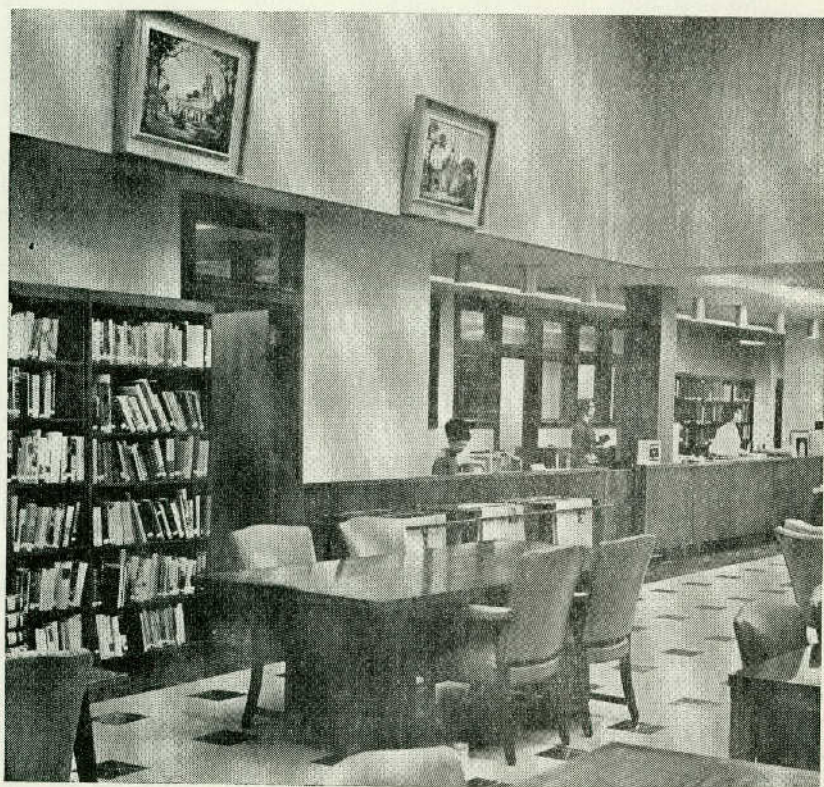
The entire staff has worked conscientiously and efficiently to promote the goals of the Reference Division. Without their help and cooperation, the progress achieved would not have been possible.

Technical Services

The 1964-66 biennium of the Texas State Library was a significant period of expansion for the Technical Services Division, with two new major programs begun.

The first new program was the installation of data processing equipment. After a year's study and design, IBM tabulating equipment was installed in May of 1965 to prepare all purchase orders for books, serials, newspapers, microfilm, and binding. A by-product of the purchase order writing was the bookkeeping for all acquisitions, prepared on punched cards at the same time the orders were printed. This program has allowed the Division to increase its output considerably while gaining complete control of all funds. Plans to prepare preliminary book catalogs, catalogers' shelf lists and work lists, and several other projects had to be abandoned after several months due to lack of staff and machine time to produce them.

The second major program initiated during the biennium by the Division was the Centralized Processing Center, opened in June of 1965, and financed through Title I of the federal Library Services and Construction Act. This Center now has agreements with forty-three public libraries in Texas to purchase, receive, catalog, classify, and further process books purchased under Title I of the LSCA for them and, in most cases, a large percent of their own locally-appropriated book funds. These processed books are shipped to the member libraries completely ready for circulation, except for adding copy numbers and property stamps, including call numbers on the spines, pockets pasted in the books, and plastic jackets applied in most cases.

By January of 1966, this service had increased to the extent that the Center was moved to separate quarters at 408 West 15th Street in February. It now has in that building 2,100 square feet (already inadequate). The data processing equipment was moved to the new location also, but all divisions of the State Library are served still by the ordering and bookkeeping functions of the Division.

Staff

The total staff of the Division now is twenty-four full-time and six part-time, an increase of seven full-time and four part-time since the last biennium. The turnover in staff is still considerable, due largely to the use of students and students' wives, who tend to work for short time periods, and the low salaries of all.

Equipment

Besides the data processing equipment, the Division has installed several new electric typewriters, two electric pasting machines, a labelling device developed by the Library Technology Project of the American Library Association, a rotary storage file for IBM cards, a new multilith machine for catalog card production, two Friden Flexowriters (leased) for catalog card, pocket, and label production in the Center. These machines have allowed the Division to increase its output further, to streamline its production facilities, and to serve as a testing ground for other libraries over the State for new machines and products.

Projections for the Next Biennium

The Technical Services Division will continue to expand and to improve its services, with the increase in federal funds under the Library Services and Construction Act and with the increased number of services being offered by the State Library. The expansion of the data processing program will be initiated during the next biennium, which will begin with a feasibility study in September of 1966. The equipment will be removed from Technical Services to the Administrative Division, where it can serve all divisions equally and impartially. A computer is on order for the State Library, for which the systems study will be made to develop the full capabilities of the equipment.

The processing center will be expanded somewhat to serve a few more members and to serve its present members better. Other processing centers over the State are being established and encouraged, these will supplement and extend this service to more libraries over a wider area.

Minutes of Texas State Board Of Library Examiners

December 4, 1964

The State Board of Library Examiners held its annual meeting on Friday, December 4, 1964, at 2:00 p.m., in Room 205A of the State Archives and Library Building. Present were Dr. Dorman H. Winfrey, Chairman, Mrs. Juanima Wells McLaughlin, Miss Mary Rice, Mrs. Mary Butler Owensby.

The Board approved the renewal of Temporary Certificates for the year 1965 for all individuals who have met the Board's requirements for continued professional improvement, including enrollment for workshops and the attendance of library conferences. It was noted that a large number of librarians had attended workshops conducted by State Library Field Consultants.

The following resolution was drawn up and unanimously passed honoring the late J. Frank Dobie, friend and supporter of the public libraries of Texas:

- WHEREAS the late J. Frank Dobie was widely recognized as a friend and supporter of the public library, and
- WHEREAS one of his great loves was the free public library and no challenge for library development was too great for him to tackle, whether for a community or a city, and
- WHEREAS this great man who belonged to the grass and the ground said "I'm still learning how to write. After a million words, writing still isn't easy." and
- WHEREAS his fame attracted international attention as a writer and folklorist. He was honored by the President of the United States by being selected to receive the Presidential Medal of Freedom and earlier he had been named as an honorary consultant by the Library of Congress in American Cultural History, and
- WHEREAS the legacy of his deeds are reflected in Clarence Day's great lines: "The world of books is the most remarkable creation of man, nothing else that he builds ever lasts, monuments fall, nations perish, civilizations grow old and die out and after an era of darkness new races build others, but in the world of books are volumes that have seen this happen again and again and yet live on,—still young—still as fresh as the day they were written still telling men's hearts of the hearts of men centuries dead," and
- WHEREAS the Board of Library Examiners has encouraged the upgrading of Texas libraries and has gloried in the individuality and the work done by the late J. Frank Dobie, now therefore be it resolved that the Texas State Board of Library Examiners adds these words to commemorate the memory of this great man. A copy of this resolution will be personally handed to
