DART schedules community meetings on proposed new transit fares

The first of 18 community meetings on a proposed Dallas Area Rapid Transit (DART) fare change is scheduled for Tuesday, June 5 at 6:30 p.m. in Richardson.

These meetings, plus a Tweet chat on the topic, will take place in advance of a public hearing before the DART Board of Directors. The hearing will have DART staff presenting suggestions for modifications to a fare structure that remains among the nation's lowest. Public input is encouraged and welcomed at any of the meetings or at the hearing on Tuesday, June 26, 6:30 p.m., DART Board Room, 1401 Pacific Avenue, Dallas (MAPSCO 45K).

Based on the outcome of the hearing, and in accordance with DART's 20-year financial plan, the proposed fares would go into effect, along with system wide service changes, on December 3, 2012 when the agency opens the second section of the Orange Line light rail from Las Colinas to DFW Airport property and an extension of the Blue Line from Garland to Rowlett.

The 18 meetings will be held throughout the Service Area.
