

1 AN ACT

2 relating to the licensing and regulation of pool-related electrical  
3 maintenance.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 1305.002, Occupations Code, is amended  
6 by amending Subdivisions (12-a), (12-b), (12-c), (12-d), and (12-e)  
7 and adding Subdivisions (14), (15), and (16) to read as follows:

8 (12-a) "Residential appliance" means a pool-related  
9 electrical device, or equipment that:

10 (A) is installed as a unit in a single-family or  
11 multifamily dwelling that does not exceed four stories;

12 (B) is directly connected to an electrical  
13 circuit; and

14 (C) performs a specific function.

15 (12-b) "Residential appliance installation" means  
16 electrical work that is limited to the connection or disconnection  
17 of a residential appliance, including a pool-related electrical  
18 device, to an existing electrical circuit other than by inserting  
19 or removing a plug from an electrical outlet.

20 (12-c) "Residential appliance installation  
21 contracting" means the business of residential appliance  
22 installation, including pool-related electrical maintenance.

23 (12-d) "Residential appliance installation  
24 contractor" means a business entity, other than an electrical

1 contractor or electrical sign contractor, that is engaged in  
2 residential appliance installation contracting, including  
3 pool-related electrical maintenance.

4 (12-e) "Residential appliance installer" means a  
5 person, other than a licensed electrician, who is licensed to  
6 perform residential appliance installation, including pool-related  
7 electrical maintenance.

8 (14) "Pool" means an outdoor or indoor structure  
9 intended for swimming or recreational bathing, including an  
10 inground structure, aboveground structure, hot tub, spa, portable  
11 spa, or non-portable wading pool.

12 (15) "Pool-related electrical device" means equipment  
13 for a pool that:

14 (A) is installed as a unit;

15 (B) is directly connected to an electrical  
16 circuit; and

17 (C) performs a specific function.

18 (16) "Pool-related electrical maintenance" means  
19 electrical work that is limited to the connection or disconnection  
20 of a pool-related electrical device to an existing electrical  
21 circuit other than by inserting or removing a plug from an  
22 electrical outlet.

23 SECTION 2. Section 1305.003(a), Occupations Code, as  
24 amended by Chapters 418 (S.B. 1222) and 649 (H.B. 1029), Acts of the  
25 80th Legislature, Regular Session, 2007, is reenacted and amended  
26 to read as follows:

27 (a) This chapter does not apply to:

1           (1) the installation of electrical equipment in a  
2 ship, watercraft other than a floating building, railway rolling  
3 stock, aircraft, motor vehicle, or recreational vehicle;

4           (2) the installation of electrical equipment  
5 underground in a mine and in self-propelled mobile surface mining  
6 machinery and its attendant electrical trailing cable;

7           (3) the installation of electrical equipment for  
8 generation, transformation, transmission, or distribution of power  
9 used exclusively to operate railway rolling stock or exclusively  
10 for signaling and communications purposes;

11           (4) the installation, maintenance, alteration, or  
12 repair of communications equipment provided by a  
13 telecommunications provider;

14           (5) the installation, maintenance, alteration, or  
15 repair of electrical equipment under the exclusive control of an  
16 electric utility, power generation company as defined by Sections  
17 31.002(1) and (10), Utilities Code, electric cooperative, or  
18 municipally owned utility and used for communications or metering,  
19 or for the generation, control, transformation, transmission, and  
20 distribution of electrical energy, and located:

21                   (A) in a building used exclusively by a utility  
22 or power generation company for those purposes;

23                   (B) outdoors on property owned or leased by the  
24 utility or power generation company;

25                   (C) on public highways, streets, roads, or other  
26 public rights-of-way; or

27                   (D) outdoors by established rights in vaults or

1 on private property;

2 (6) work not specifically regulated by a municipal  
3 ordinance that is performed in or on a dwelling by a person who owns  
4 and resides in the dwelling;

5 (7) work involved in the manufacture of electrical  
6 equipment that includes the on-site and off-site manufacturing,  
7 commissioning, testing, calibrating, coordinating,  
8 troubleshooting, or evaluating of electrical equipment, the  
9 repairing or retrofitting of electrical equipment with components  
10 of the same ampacity, and the maintenance and servicing of  
11 electrical equipment within the equipment's enclosure that is  
12 performed by an authorized employee or authorized representative of  
13 an electrical equipment manufacturer and limited to the type of  
14 products manufactured by the manufacturer;

15 (8) electrical work if:

16 (A) the work is performed by a person who does not  
17 engage in electrical work for the public;

18 (B) the work is performed by a person regularly  
19 employed as a maintenance person or maintenance electrician for a  
20 business; and

21 (C) the electrical work does not involve the  
22 installation of electrical equipment during new construction as  
23 defined by rules adopted under Chapter 151, Tax Code;

24 (9) the installation, maintenance, alteration, or  
25 repair of electrical equipment or associated wiring under the  
26 exclusive control of a gas utility and used for communications or  
27 metering or for the control, transmission, or distribution of

1 natural gas;

2 (10) thoroughfare lighting, traffic signals,  
3 intelligent transportation systems, and telecommunications  
4 controlled by a governmental entity;

5 (11) electrical connections supplying heating,  
6 ventilation, and cooling and refrigeration equipment, including  
7 any required disconnect exclusively for the equipment, if the  
8 service is performed by a licensed air conditioning and  
9 refrigeration contractor under Chapter 1302;

10 (12) the design, installation, erection, repair, or  
11 alteration of Class 1, Class 2, or Class 3 remote control,  
12 signaling, or power-limited circuits, fire alarm circuits, optical  
13 fiber cables, or communications circuits, including raceways, as  
14 defined by the National Electrical Code;

15 (13) landscape irrigation installers, as necessary to  
16 perform the installation and maintenance of irrigation control  
17 systems, and landscapers, as necessary to perform the installation  
18 and maintenance of low-voltage exterior lighting and holiday  
19 lighting excluding any required power source;

20 (14) electrical work performed at a business that  
21 operates:

22 (A) a chemical plant, petrochemical plant,  
23 refinery, natural gas plant, natural gas treating plant, pipeline,  
24 or oil and gas exploration and production operation by a person who  
25 works solely for and is employed by that business; or

26 (B) a chemical plant, petrochemical plant,  
27 refinery, natural gas plant, or natural gas treatment plant by a

1 person who under a contract of at least 12 months' duration performs  
2 electrical work for that plant and:

3 (i) the electrical work is not performed  
4 during new construction as defined by rules adopted under Chapter  
5 151, Tax Code; or

6 (ii) the person is not working for a  
7 contractor that has a principal place of business in another state  
8 or territory of the United States or a foreign country;

9 (15) the installation, maintenance, alteration, or  
10 repair of elevators, escalators, or related equipment, excluding  
11 any required power source, regulated under Chapter 754, Health and  
12 Safety Code;

13 (16) the installation, maintenance, alteration, or  
14 repair of equipment or network facilities provided or utilized by a  
15 cable operator, as that term is defined by 47 U.S.C. Section 522, as  
16 amended;

17 (17) the location, design, construction, extension,  
18 maintenance, and installation of on-site sewage disposal systems in  
19 accordance with Chapter 366, Health and Safety Code, or an on-site  
20 sewage facility installer licensed under Chapter 37, Water Code;

21 (18) electrical work performed on a building,  
22 structure, or equipment in agricultural use as defined by Section  
23 11.002, Water Code, other than the processing of an agricultural  
24 commodity;

25 (19) the installation, maintenance, alteration, or  
26 repair of well pumps and equipment in accordance with Chapter 1902;

27 (20) electrical work required for the construction and

1 assembly of HUD-code manufactured housing or modular housing and  
2 building units, other than the installation of service entrance  
3 conductors, that is performed by a licensed manufacturer or  
4 installer under Chapter 1201 or 1202, as applicable, if work  
5 performed is within the scope of the license as defined by  
6 applicable statutes and administrative rules; ~~and~~

7 (21) work performed by a plumber who holds a license or  
8 endorsement or is registered under Chapter 1301 that is necessary  
9 to install, service, maintain, repair, or replace any type of  
10 plumbing fixture or appliance, as described by Section 1301.002(7),  
11 including a water heater, food disposer, garbage disposal, water  
12 softener, dishwashing machine, and clothes washing machine on  
13 existing electrical circuits only;

14 (22) [~~—(21)~~] the maintenance or repair of a  
15 residential appliance by a residential appliance dealer or  
16 manufacturer or a person authorized by a residential appliance  
17 dealer or manufacturer using only components of the same type and  
18 ampacity as the original components; and

19 (23) the maintenance, alteration, or repair of a  
20 pool-related electrical device by, or pool-related electrical  
21 maintenance performed by, an employee of a municipality on a pool  
22 owned or operated by the municipality.

23 SECTION 3. Section 1305.162, Occupations Code, is amended  
24 by adding Subsection (d) to read as follows:

25 (d) In addition to the other requirements of this section,  
26 the department shall accept, develop, or contract for a residential  
27 appliance installer examination that tests an applicant's

1 knowledge of the materials and methods used in the installation of  
2 residential appliances and pool-related devices under this chapter  
3 and the National Electrical Code standards as adopted by the  
4 executive director.

5 SECTION 4. Not later than January 1, 2010, the Texas  
6 Commission of Licensing and Regulation shall adopt any rules  
7 necessary to implement the changes in law made by this Act.

8 SECTION 5. Section 1305.151, Occupations Code, applies only  
9 to a person who performs pool-related electrical maintenance, as  
10 defined by Section 1305.002, Occupations Code, as amended by this  
11 Act, or residential appliance installation that consists only of  
12 the connection or disconnection of a pool-related electrical  
13 device, as defined by Section 1305.002, Occupations Code, as  
14 amended by this Act, on or after March 1, 2010.

15 SECTION 6. (a) Except as provided by Subsection (b) of this  
16 section, this Act takes effect September 1, 2009.

17 (b) Section 1 of this Act takes effect March 1, 2010.
