

Chapter 715

AN ACT

relating to the expansion of the boundaries of the Cibolo Creek
Municipal Authority.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 4, Chapter 347, Acts of the 62nd
Legislature, Regular Session, 1971, is amended to read as follows:

Sec. 4. The district shall comprise all of the territory
contained within the following described area:

BEGINNING: At a point of intersection of the Southeasterly
line of Lower Seguin Road, with the approximate centerline of the
Cibolo Creek for a corner of this description, said point being on
the Eastern line of Bexar County and on the Western line of
Guadalupe County;

THENCE: Along the approximate centerline of the Cibolo Creek,
Northerly approximately 815 feet to a point for a corner, said point
being a corner;

THENCE: In a Southwesterly direction crossing a 22.4 acre
tract in Bexar County, Texas, and crossing the Northeastern line of
the Julian Diaz Survey, Abstract No. 187 in Bexar County, Texas, and
continuing on along the Northwestern right-of-way line of the Lower
Seguin Road, a distance of approximately 4800 feet to a turn in the
road, for a corner;

THENCE: In a Westerly direction, continuing along the
Northern right-of-way line of Lower Seguin Road, a distance of

1 approximately 2700 feet to a point on the Northern line of the
2 Julian Diaz Survey, Abstract No. 187 in Bexar County, Texas, said
3 point also being on the Southern line of the Miles S. Bennett Survey
4 No. 75, Abstract No. 61;

5 THENCE: Along the Northern line of the Diaz Survey, a
6 distance of approximately 3600 feet to the most Western corner of
7 the Julian Diaz Survey and an interior corner of the Jeronimo Leal
8 Survey No. 79, Abstract No. 424 in Bexar County, Texas;

9 THENCE: In a Northwesterly direction, following the Northern
10 right-of-way line of the Lower Seguin Road, a distance of
11 approximately 500 feet to a turn in said road, said turn also being
12 on the Southern line of a 100.7 acre tract in the name of Jewel
13 Lucas;

14 THENCE: Continuing along the Northern right-of-way line of
15 the Lower Seguin Road, at a distance of approximately 7200 feet
16 crossing the Southwestern line of the Jeronimo Leal Survey No. 79, a
17 total distance of approximately 8100 feet to a corner on the Western
18 line of the J. P. Hector Survey, Abstract No. 1147 in Bexar County,
19 Texas, said point also being on the Northeastern line of the Richard
20 Mockett Survey No. 316, Abstract No. 497;

21 THENCE: In a Northwesterly direction, along the Northeastern
22 line of the Richard Mockett Survey No. 316 and along the
23 Southwestern line of the J. P. Hector Survey, Abstract No. 1147, a
24 distance of approximately 2000 feet to a point on the Northeastern
25 line of the John C. Neal Survey No. 82, Abstract No. 549;

26 THENCE: In a Southwesterly direction, along the Northern
27 right-of-way line of a Public Road, a distance of approximately

1 1000 feet to a corner;

2 THENCE: In a Northwesterly direction, along the Northeastern
3 right-of-way line of a Public Road, a distance of approximately
4 1000 feet to a point on the common property line between Randolph
5 Air Force Base and the Amanda Ciebold 52.399 acre tract;

6 THENCE: In a Westerly direction, along the Southern boundary
7 line of the Randolph Field and the Northern boundary line of said
8 Amanda Ciebold 52.399 acre tract, a distance of approximately 1600
9 feet to a point on the Northeastern right-of-way line of F.M.
10 Highway No. 1604;

11 THENCE: In a Northwesterly direction, following the
12 Northeastern right-of-way line of F.M. Highway No. 1604, a distance
13 of approximately 6300 feet to the point where the Northwestern
14 boundary of Randolph Field property intersects the Northeastern
15 right-of-way line of F.M. Highway No. 1604;

16 THENCE: In a Northerly and Northeasterly direction,
17 following the Northwestern perimeter of Randolph Field, a distance
18 of approximately 4100 feet to a point on the Southern right-of-way
19 line of F.M. Highway No. 78;

20 THENCE: In a Northwesterly direction crossing F.M. Highway
21 No. 78 and the Southern Pacific Railroad right-of-way and along the
22 Southwestern line of Universal Parkway Subdivision and along the
23 Southwestern line of the Northview Park Subdivision, both being in
24 the City of Universal City, Texas, and continuing along this line a
25 distance of approximately 4900 feet to a point on the Northwestern
26 right-of-way line of Selma Road, in the City of Universal City,
27 Texas;

1 THENCE: In a Northeasterly direction, along the Northwestern
2 right-of-way line of Selma Road, a distance of approximately 700
3 feet to a corner;

4 THENCE: In a Northwesterly direction, along the Southwestern
5 right-of-way line of Selma Road, a distance of approximately 590
6 feet to the Southeast corner of Lot 11, Block 2 of Rose Garden
7 Estate Subdivision, Unit One;

8 THENCE: In a Southwesterly direction, along the Southeastern
9 line of Block 2 of Rose Garden Estate Subdivision, Unit One, a
10 distance of 469.81 feet to the most Southern corner of Lot 8, Block
11 2 of Rose Garden Estate Subdivision, Unit One;

12 THENCE: In a Northwesterly direction, along the common
13 boundary line between Lot 8 and Lot 7, Block 2 of Rose Garden Estate
14 Subdivision, Unit One, a distance of 184 feet to the most Western
15 corner of said Lot 8;

16 THENCE: In a Northwesterly direction, crossing Kimberley
17 Drive, a distance of approximately 90 feet to a point on the
18 Northwestern right-of-way line of Kimberley Drive, opposite the
19 centerline of a 16 foot wide utility easement;

20 THENCE: In a Northwesterly direction, along the centerline of
21 said utility easement, a distance of approximately 530 feet to a
22 point opposite the Southwest corner of Lot 10 and the Southeast
23 corner of Lot 9, Block 3 of the Rose Garden Estate Subdivision, Unit
24 Two;

25 THENCE: In a Northwesterly direction, along the common line
26 between the said Lots 9 and 10, a distance of 123 feet to a point on
27 the Southern right-of-way line of Sherry Drive;

1 THENCE: In a Northwesterly direction and crossing Sherry
2 Drive a distance of approximately 80 feet to the most Eastern corner
3 of Lot 10 and the Southwest corner of Lot 11, both in Block 4 of Rose
4 Garden Estate Subdivision, Unit Two;

5 THENCE: In a Northwesterly direction, following the common
6 line between the said Lots 10 and 11, Block 4, a distance of 132.8
7 feet to the most Northern corner of said Lot 10 and to the most
8 Western corner of Lot 11;

9 THENCE: In a Southwesterly direction, along the Northwestern
10 side of said Block 4, a distance of approximately 1180 feet to a
11 point in the Northeastern right-of-way line of State Highway 218
12 (Pat Booker Road);

13 THENCE: In a Northwesterly direction, following the
14 Northwestern right-of-way of State Highway 218, crossing the
15 Northeastern right-of-way of F.M. Highway No. 1604, a distance of
16 4083.61 feet to the intersection of this line with the Northwestern
17 line of Old Austin Road, said point being in the right-of-way of
18 F.M. Highway No. 1604;

19 THENCE: Along the Northwest line of Old Austin Road, S 30° 09'
20 00" W 1070.36 feet to the intersection of the Western line of F.M.
21 Highway No. 1604 and the Northwestern line of Interstate Highway
22 No. 35;

23 THENCE: Along the Northwestern line of Interstate Highway No.
24 35, S 37° 41' 30" W 258.20 feet, S 45° 23' 00" W 158.30 feet, S 45° 23'
25 00" W 209.10 feet, and S 45° 21' 00" W 568.11 feet to a point in same
26 at the beginning of a curve to the right, for a corner;

27 THENCE: Continuing along the Northwest line of Interstate

1 Highway No. 35 and said curve to the right, having a radius of
2 716.78 feet, an arc length of 375.72 feet, and a chord bearing and
3 distance of S 60° 22' 00" W 371.44 feet to the end of said curve, for
4 a corner;

5 THENCE: Continuing along the Northwest line of Interstate
6 Highway No. 35, S 75° 23' 00" W 386.25 feet to the beginning of a
7 curve to the left, for a corner;

8 THENCE: Continuing along the Northwest line of Interstate
9 Highway No. 35 and said curve to the left, having a radius of 716.78
10 feet, an arc length of 537.31 feet, and a chord bearing and distance
11 of S 53° 64' 30" W 524.82 feet to the end of said curve, for a corner;

12 THENCE: Continuing along the Northwest line of Interstate
13 Highway No. 35, S 32° 26' 00" W 860.87 feet to the beginning of a
14 curve to the right, for a corner;

15 THENCE: Continuing along the Northwest line of Interstate
16 Highway No. 35 and said curve to the right, having a radius of
17 5620.65 feet, an arc length of 820.76 feet, and a chord bearing and
18 distance of S 36° 37' 00" W 820.03 feet to the end of said curve, for
19 a corner;

20 THENCE: Continuing along the Northwest line of Interstate
21 Highway No. 35, S 42° 03' 45" W 247.65 feet, S 44° 20' 16" W 198.75
22 feet, and S 45° 21' 03" W 429.35 feet to the beginning of a curve to
23 the right, for a corner;

24 THENCE: Continuing along the Northwest line of Interstate
25 Highway No. 35 and said curve to the right, having a radius of
26 5620.65 feet, an arc length of 744.46 feet, and a chord bearing and
27 distance of S 47° 59' 08" W 743.92 to a flare corner leading from the

1 Northwest line of Interstate Highway No. 35 to the Easterly
2 right-of-way line of Toepperwein Road, for a corner;

3 THENCE: Along said cut-back line, N 78° 10' 12" W 66.27 feet to
4 the Eastern line of Toepperwein Road, for a corner;

5 THENCE: Along the Easterly line of Toepperwein Road, N 28° 54'
6 06" W 1823.79 feet to the beginning of a curve to the right, for a
7 corner;

8 THENCE: Continuing along the Easterly line of Toepperwein
9 Road and said curve to the right, having a radius of 2103.99 feet,
10 an arc length of 766.80 feet, and a chord bearing and distance of N
11 18° 43' 58" W 762.56 feet to the end of said curve, for a corner;

12 THENCE: Continuing along the Easterly line of Toepperwein
13 Road, N 08° 16' 49" W 228.73 feet to the beginning of a curve to the
14 left, for a corner;

15 THENCE: Continuing along the Easterly line of Toepperwein
16 Road and said curve to the left, having a radius of 1940.0 feet, an
17 arc length of 124.26 feet, and a chord bearing and distance of N 10°
18 02' 42" W 124.24 feet to the end of said curve and the beginning of
19 another curve to the left, for a corner;

20 THENCE: Continuing along said Easterly line of Toepperwein
21 Road and said curve to the left, having a radius of 1883.64 feet, an
22 arc length of 601.0 feet, and a chord bearing and distance of N 19°
23 59' 43" W 598.45 feet to the end of said curve, for a corner;

24 THENCE: Continuing along the Easterly line of Toepperwein
25 Road, N 30° 40' 10" W 375.60 feet and N 30° 31' 00" W 1695.64 feet to a
26 cut-back corner from Toepperwein Road to the Southerly line of
27 Lookout Road;

1 THENCE: Along said cut-back line, N 25° 21' 15" W 56.75 feet to
2 a point in the Southerly line of Lookout Road, for a corner;

3 THENCE: Along the Southerly line of Lookout Road, N 80° 48'
4 15" E 695.43 feet, N 81° 15' 30" E 168.37 feet, and N 78° 01' 45" E
5 820.85 feet to a point for a corner;

6 THENCE: In a Northwesterly direction, crossing Lookout Road
7 and crossing the Missouri-Kansas-Texas Railroad Company (now
8 Missouri-Pacific Railroad), a total distance of 1232.0 feet to a
9 point on the Northwestern line of the Jose Maria Ocon Survey No.
10 279, Abstract No. 864;

11 THENCE: In a Southwesterly direction, along the Southwestern
12 line of said Survey No. 279, a distance of approximately 600 feet to
13 a point for a corner;

14 THENCE: In a Northwesterly direction following the common
15 boundary line between the George Gerhart 18 acre tract and the Alice
16 Dietz 80.3 acre tract, a distance of approximately 1300 feet to the
17 most Northern corner of said Gerhart 18 acre tract;

18 THENCE: In a Southwesterly direction, along the Northwestern
19 line of the Gerhart 18 acre tract and the Southeastern line of the
20 Lester Gerhart 80 acre tract, a distance of 1100 feet to the
21 Southwestern line of the J. F. S. ValVerde Survey No. 277, Abstract
22 No. 782, for a corner;

23 THENCE: In a Northwesterly direction, along the Southwestern
24 line of said Survey No. 277 and also being along the Northeastern
25 line of the Joseph O. Carrion Survey No. 278, Abstract No. 141, a
26 distance of approximately 1300 feet to a corner;

27 THENCE: In a Northeasterly direction, along the Northwestern

1 line of the Lester Gerhart 80 acre tract and the Southeastern line
2 of the Fred Snowden 5 acre tract, a distance of approximately 800
3 feet to a corner;

4 THENCE: In a Northwesterly direction, along the common line
5 between the W. H. Tonne, Jr. 164.14 acre tract and the Harry
6 Schulmeyer 10.8 acre tract, a distance of approximately 900 feet to
7 the most Northern corner of the Schulmeyer tract;

8 THENCE: In a Southwesterly direction, along the Northwestern
9 line of said Schulmeyer tract and the Southeastern line of the Tonne
10 tract, a distance of approximately 800 feet to the Southwestern
11 line of said Survey No. 277;

12 THENCE: In a Northwesterly direction, following the
13 Southwestern line of Survey No. 277 and the Northeastern line of
14 Survey No. 278, at a distance of approximately 1100 feet crossing
15 the most Western corner of Survey No. 277 and the most Northern
16 corner of Survey No. 278 and continuing along the same line a total
17 distance of 1600 feet to a corner on the Northwestern right-of-way
18 line of a Public Road;

19 THENCE: In a Southwesterly direction, along the Northwestern
20 right-of-way line of said Public Road, a distance of 100 feet to a
21 corner;

22 THENCE: In a Northwesterly direction, following the common
23 boundary line between the E. S. C. Coppock 60 acre tract and the
24 Allen E. Autry 25 acre tract, a distance of approximately 2000 feet
25 to a corner;

26 THENCE: In a Northeasterly direction, following the common
27 boundary line between the Autry 25 acre tract and the Harry

1 Eisenhauer 25 acre tract, a distance of approximately 700 feet to a
2 corner on the Southwestern line of the Mrs. Edda Bineck 98.257 acre
3 tract;

4 THENCE: In a Northwesterly direction, following the
5 Southwestern line of the Bineck 98.257 acre tract and the
6 Northeastern line of the Eisenhauer 25 acre tract, a distance of
7 approximately 1100 feet to a point on the Northwestern line of the
8 James Conn Survey No. 196, Abstract No. 121;

9 THENCE: In a Southwesterly direction, along the Northwestern
10 line of said Survey No. 196, a distance of approximately 100 feet to
11 a corner;

12 THENCE: In a Northwesterly direction, following the common
13 boundary line between the Floyd Nunnelly tract and the Alfred
14 Nisbet 95.934 acre tract, a distance of approximately 2100 feet to a
15 point on the Southern right-of-way line of the Missouri-Pacific
16 Railroad Company;

17 THENCE: In an Easterly direction, following the Southern
18 right-of-way line of the Missouri-Pacific Railroad Company, a
19 distance of approximately 3200 feet to a point on the Northeastern
20 line of the W. A. Arthur Survey No. 86, Abstract No. 837;

21 THENCE: In a Northwesterly direction, following the
22 Northeastern line of said Survey No. 86 and the Southwestern line of
23 the Pedro Sanchez Survey No. 411, Abstract No. 677, a distance of
24 approximately 1700 feet to a corner;

25 THENCE: In a Northeasterly direction, following the
26 Northwestern boundary line of the William R. Castle, Jr. 80.86 acre
27 tract and crossing the right-of-way of F.M. Highway No. 1604 and

1 continuing along the same line which is the common line between the
2 John W. Stoepler 230 acre tract and the Mrs. N. E. McClelland Stagg
3 104.21 acre tract, a distance of approximately 5800 feet to a point
4 on the Northeast line of the Pedro Sanchez Survey No. 411;

5 THENCE: In a Northwesterly direction, along the Northeastern
6 line of the said Survey No. 411 and along the Southwestern line of
7 the Vicente Micheli Survey No. 114, Abstract No. 462, a distance of
8 approximately 150 feet to a corner;

9 THENCE: In a Northeasterly direction, on the common boundary
10 line between the Stella and the Frances O'Neil 63 acre tract and the
11 Gilbert Binz 54.5 acre tract at a distance of approximately 3000
12 feet crossing a Public Road, at a total distance of approximately
13 3400 feet to the center of the Cibolo Creek, for a corner;

14 THENCE: Up the center of the Cibolo Creek, with its meanders,
15 a distance of approximately 300 feet to a corner;

16 THENCE: In a Northeasterly direction which is parallel to and
17 approximately 2500 feet Southeast of the Northwest line of Survey
18 No. 114 in the name of Vicente Micheli in Comal County, Texas, a
19 distance of approximately 3600 feet to a corner;

20 THENCE: In a Southeasterly direction, which is parallel and
21 approximately 7200 feet Southwest of the Northeasterly line of said
22 Survey No. 114, a distance of approximately 1200 feet to a corner;

23 THENCE: In a Northeasterly direction, along the Southeast
24 line of the Paul Marbach 347 acre tract and along the Northwest line
25 of the Floyd and Lochman 110 acre tract, a distance of approximately
26 7200 feet to a point on the Northeastern line of said Survey No.
27 114;

1 THENCE: Southerly, along the Northeastern line of said Survey
2 No. 114, approximately 335 feet to the Northwest corner of the
3 George M. Dolson Survey No. 96, Abstract No. 120, for a corner;

4 THENCE: Continuing in a Northeasterly direction, along the
5 Northwestern line of Survey No. 96, a distance of approximately
6 2200 feet to a corner;

7 THENCE: In a Southeasterly direction, and along the
8 Southwestern line of the Victor O. Fritze 120 acre tract, a distance
9 of approximately 3142 feet to the intersection of the Southwest
10 line of F.M. Highway No. 2252, for a corner;

11 THENCE: Along the Southwestern line of F.M. Highway No. 2252,
12 S 74° 07' 30" E 534.78 feet to a cut-back corner from F.M. Highway
13 No. 2252 to Nacogdoches Loop Road;

14 THENCE: Along said cut-back line, S 04° 16' 30" E 65.25 feet to
15 a point in the North-west line of said Nacogdoches Loop Road, for a
16 corner;

17 THENCE: Crossing Nacogdoches Loop Road, N 71° 06' 19" E 329.59
18 feet to a point at the intersection of the Southeast line of
19 Nacogdoches Loop Road, with the Southeast line of F.M. Highway No.
20 2252, for a corner;

21 THENCE: Along the Southeast line of F.M. Highway No. 2252, N
22 77° 03' 00" E 212.17 feet, N 62° 08' 00" E 385.32 feet, N 62° 08' 00" E
23 372.12 feet, N 62° 08' 00" E 30.86 feet, and N 59° 16' 00" E 591.11
24 feet to a cut-back corner leading from F.M. Highway No. 2252 to F.M.
25 Highway No. 3009;

26 THENCE: Along said cut-back line, S 74° 26' 00" E 70.50 feet to
27 a point in the South-west line of F.M. Highway No. 3009, for a

1 corner;

2 THENCE: Crossing F.M. Highway No. 3009, N 57° 22' 50" E 120.12
3 feet to a point on the Northeast line of said F.M. Highway No. 3009,
4 for a corner;

5 THENCE: Along a cut-back line leading from F.M. Highway No.
6 3009 to the Southeast line of F.M. Highway No. 2252, N 13° 20' 00" E
7 108.63 feet to a point in the Southeast line of F.M. Highway No.
8 2252, for a corner;

9 THENCE: Along the Southeast line of F.M. Highway No. 2252, N
10 56° 50' 00" E 1140.42 feet, N 52° 13' 00" E 62.20 feet, N 64° 20' 00" E
11 38.30 feet, and N 56° 50' 00" E 149.40 feet to the beginning of a
12 curve to the right, for a corner;

13 THENCE: Continuing along said Southeast line and said curve
14 to the right, having a radius of 919.93 feet, an arc length of
15 397.65 feet and a chord bearing and distance of
16 N 69° 13' 00" E 394.56 feet to the end of said curve, for a
17 corner;

18 THENCE: Continuing along the Southeast line of F.M. Highway
19 No. 2252, N 81° 36' 00" E 635.70 feet to the beginning of a curve to
20 the left, for a corner;

21 THENCE: Continuing along said Southeast line and said curve
22 to the left, having a radius of 1672.02 feet, an arc length of
23 300.09 feet, and a chord bearing and distance of
24 N 76° 27' 30" E 299.69 feet to the end of said curve, for a
25 corner;

26 THENCE: Continuing along said Southeast line, N 71° 19' 00" E
27 414.10 feet to the beginning of a curve to the left, for a corner;

1 THENCE: Continuing along said Southeast line of F.M. Highway
2 No. 2252 and said curve to the left, having a radius of 607.96 feet,
3 an arc length of 334.07 feet, and a chord bearing and distance of N
4 55° 34' 30" E 329.88 feet to the end of said curve, for a corner;

5 THENCE: Continuing along said Southeast line, N 39° 50' 00" E
6 588.20 feet to the beginning of a curve to the right, for a corner;

7 THENCE: Continuing along said Southeast line and said curve
8 to the right, having a radius of 442.47 feet, an arc length of
9 234.25 feet, and a chord bearing and distance of

10 N 55° 00' 00" E 231.52 feet to the end of said curve, for a
11 corner;

12 THENCE: Continuing along the Southeast line of F.M. Highway
13 No. 2252, N 70° 10' 00" E 157.90 feet, N 65° 57' 00" E 286.0 feet, and
14 N 61° 44' 00" E 426.60 feet to the beginning of a curve to the right,
15 for a corner;

16 THENCE: Continuing along the Southeast line of F.M. Highway
17 No. 2252 and said curve to the right, having a radius of 1006.74
18 feet, an arc length of 153.15 feet, and a chord bearing and distance
19 of N 66° 05' 28" E 153.0 feet to a point in same, for a corner, said
20 corner being at the intersection of the existing City of Schertz CCN
21 #2271 and the Southeast right-of-way line of F.M. Highway No. 2252;

22 THENCE: Leaving said Southeast line and crossing F.M. Highway
23 No. 2252 and along said City of Schertz CCN line, N 27° 11' 57" W
24 2813.32 feet and in a Northeasterly direction, the following
25 courses: N 60° 26' 04" E 1841.06 feet, N 57° 35' 43" E 6498.46 feet, N
26 58° 21' 44" E 366.49 feet, and N 68° 28' 25" E 1669.06 feet to a point
27 for corner;

1 THENCE: In a Northwesterly direction, with a curve to the
2 left, having an arc length of 5780.08 feet, a radius of 26445.73
3 feet, a tangent of 2901.60 feet, and a chord bearing and distance of
4 N 48° 42' 44" W 5768.50 feet, to a corner;

5 THENCE: N 67° 10' 50" E 2245.19 feet to a point for corner;

6 THENCE: S 30° 34' 09" E 1168.67 feet to a point for corner;

7 THENCE: Along and with the City of New Braunfels and City of
8 Schertz ETJ lines, the following courses: N 58° 57' 27" E 2291.96
9 feet, N 60° 19' 48" E at 1408.54 feet passing the West right-of-way
10 line of Coyote Run, at 1460.86 feet passing the East line of Coyote
11 Run and continuing a total distance of 5189.84 feet to a point for
12 corner;

13 THENCE: S 30° 10' 50" E 4314.51 feet to a point for corner;

14 THENCE: N 57° 30' 24" E 1397.78 feet to a point for corner;

15 THENCE: S 29° 28' 51" E 2494.80 feet to a point on the North
16 line of the Union Pacific Railroad, for a corner;

17 THENCE: N 56° 45' 30" E 2360.05 feet, along the North line of
18 the Union Pacific Railroad, to a corner;

19 THENCE: Departing and crossing over said railroad, S 29° 42'
20 11 E, 2338.97 feet for a corner;

21 THENCE: S 39° 11' 12" E at 232.26 feet passing the North right
22 of way line of F.M. 482, at 285.59 feet passing the South line of
23 F.M. 482, and continuing a total distance of 300.37 feet to a point;

24 THENCE: S 34° 23' 06" E 862.76 to a point on the North line of
25 the Union Pacific Railroad;

26 THENCE: N 49° 27' 34" E along the North line of said Union
27 Pacific Railroad, at 2652.72 feet passing the South right-of-way
