- 19 Subsection (m) to read as follows:
- 20 (m) The tax rate in a county authorized to impose the tax
- 21 under Section 352.002(k) may not exceed two percent of the price
- 22 paid for a room in a hotel.
- SECTION 4. Section 352.003(h), Tax Code, as added by
- 24 Chapter 749 (H.B. 3132), Acts of the 80th Legislature, Regular
