

HOUSE CONCURRENT RESOLUTION

1           WHEREAS, Memories of a life filled with joyful times and  
2 meaningful accomplishments remain to comfort the family and friends  
3 of Thomas Shelby Justiss of Fort Worth, who passed away on March 16,  
4 2009, at the age of 82; and

5           WHEREAS, A native of Paris, Mr. Justiss was born in 1926 to  
6 Kathryn and Thomas Shelby Justiss, Sr.; active in school, church,  
7 and the Boy Scouts of America, he attained the rank of Eagle Scout  
8 at the age of 15; he went on to attend Paris Junior College and serve  
9 his country in the Army during World War II; and

10           WHEREAS, Following the war, he earned a bachelor's degree  
11 from Texas A&M University, where he majored in structural  
12 engineering and also participated in the Corps of Cadets and Ross  
13 Volunteers; and

14           WHEREAS, Mr. Justiss began his career as a field engineer for  
15 the Texas Company in Port Neches; recalled to active duty in 1950,  
16 he served in the U.S. Air Force during the Korean War; he left  
17 military service as a captain and settled in Fort Worth, joining the  
18 staff of Texas Industries; by virtue of his hard work and diligent  
19 service, he retired from the company in 1990 as a divisional vice  
20 president; and

21           WHEREAS, Mr. Justiss was an active and faithful member of  
22 St. Christopher Episcopal Church, serving the congregation as  
23 church treasurer; a registered professional structural engineer,  
24 he shared his time with the American Society of Civil Engineers and

1 the Texas Society of Professional Engineers; and

2 WHEREAS, Dedicated to his family, Mr. Justiss was a loving  
3 husband to his wife of 56 years, Jackie, and a devoted father to his  
4 four precious daughters, Kim, Marci, Gina, and Leanne; and

5 WHEREAS, Although Thomas Justiss is deeply missed, he will  
6 long be remembered with great affection by those fortunate enough  
7 to have shared in the richness of his life; now, therefore, be it

8 RESOLVED, That the 81st Legislature of the State of Texas  
9 hereby pay tribute to the life of Thomas Shelby Justiss and extend  
10 sincere sympathy to the members of his family: to his wife, Jackie  
11 Justiss; to his daughters, Kim and her husband, Jerry Hunter, Marci  
12 and her husband, Calvin Blankenship, Gina and her husband, Byron  
13 Lancaster, and Leanne and her husband, Keith Walker; to his  
14 grandchildren, Patrick Blankenship and his wife, Kailee, James and
