

HOUSE CONCURRENT RESOLUTION

1           WHEREAS, Family and friends are mourning the loss of Kenneth  
2 Helm of Sumner, who died on December 31, 2008, at the age of 78; and

3           WHEREAS, Kenneth Helm was born to Abner and Corinne Copening  
4 Helm on October 24, 1930, and grew up in Direct; after graduating  
5 from Direct High School in 1948, he attended Paris Junior College;  
6 and

7           WHEREAS, Answering his nation's call to duty during the  
8 Korean War, he enlisted in the U.S. Air Force in 1951 and served for  
9 four years; and

10          WHEREAS, Mr. Helm returned to Direct after his discharge from  
11 the military and joined Uarco, Inc.; following a 31-year tenure  
12 with that company, he retired in 1986 and opened an auto salvage  
13 service, which he operated from 1987 to 1999; he was a volunteer  
14 firefighter in the early years of the Direct Volunteer Fire  
15 Department; and

16          WHEREAS, Throughout his life, Mr. Helm was also a rancher,  
17 and he was widely respected as a jack-of-all-trades, capable of  
18 handling any job that needed doing; and

19          WHEREAS, Kenneth Helm worked hard all his life and made his  
20 own way in the world, and he will forever be remembered with deep  
21 affection by all who knew and loved him; now, therefore, be it

22          RESOLVED, That the 81st Legislature of the State of Texas  
23 hereby pay tribute to the life of Kenneth Helm and extend sincere  
24 condolences to the members of his family: to his former spouse,
