- 1 (2) the immediate family members of a first responder
- 2 to whom the first responder may transmit a vaccine-preventable

- 4 (c) The study must consider the feasibility of providing the
- 5 following vaccines:
- 6 (1) the hepatitis B vaccine for first responders who
- 7 may be in direct contact with blood and other bodily fluids;
- 8 (2) a tetanus-containing vaccine; and
- 9 (3) other vaccines or biologicals recommended by the
- 10 Centers for Disease Control and Prevention for disasters.
- 11 (d) The department shall:
- 12 (1) assess the vaccination status of first responders
- 13 and their immediate family members in this state;
- 14 (2) assess workplace immunization policies and
- 15 insurance coverage for first responders;
- 16 (3) make recommendations on educating first
- 17 responders and their immediate family members about available
- 18 options to obtain immunization services, regardless of insurance
- 19 coverage;
- 20 (4) assess the current ability of the department, in
- 21 conjunction with local health departments, to provide vaccines to
- 22 first responders and their immediate family members who are
- 23 uninsured or underinsured;
- 24 (5) identify and recommend funding sources for the
- 25 procurement of recommended vaccines for first responders and their
- 26 immediate family members who are uninsured or underinsured; and
- 27 (6) evaluate the potential use and cost of providing

- 1 other biologicals, such as immune globulin, to be used in
- 2 conjunction with vaccines to prevent the spread of
- 3 vaccine-preventable diseases.
- 4 (e) The statewide wellness coordinator designated under
- 5 Subsection (a), Section 664.053, Government Code, shall assist the
- 6 department in obtaining data from state agencies that employ first
- 7 responders by:
- 8 (1) consulting with the wellness liaison identified
- 9 under Subsection (d), Section 664.053, Government Code, for a state
- 10 agency that employs first responders to gain study-related
- 11 information from the state agency;
- 12 (2) assessing the readiness of each state agency to
- 13 administer vaccines to the agency's first responders before
- 14 deployment to a disaster area; and
- 15 (3) providing to the department appropriate
- 16 information from state agencies regarding the current immunization
- 17 policies of those agencies.
- 18 (f) A state agency that provides data to the department for
- 19 purposes of the study shall ensure that the data does not identify a
- 20 first responder or family member of a first responder to whom the
- 21 data pertains.
- 22 (g) Not later than August 1, 2011, the department shall
- 23 submit to the legislature a written report containing the findings
- 24 of the study and the department's recommendations.
- 25 (h) This section expires September 1, 2011.
- 26 SECTION 2. This Act takes effect immediately if it receives
- 27 a vote of two-thirds of all the members elected to each house, as
