Chapter 861

AN ACT

1
2 relating to the Parklands Municipal Utility District No. 1;
3 providing authority to impose a tax and issue bonds; granting a
4 limited power of eminent domain.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Subtitle F, Title 6, Special District Local Laws
7 Code, is amended by adding Chapter 8368 to read as follows:

8 CHAPTER 8368. PARKLANDS MUNICIPAL UTILITY DISTRICT NO. 1

9 SUBCHAPTER A. GENERAL PROVISIONS

10 Sec. 8368.001. DEFINITIONS. In this chapter:

- 11 (1) "Board" means the district's board of directors.
- 12 (2) "Director" means a board member.
- 13 (3) "District" means the Parklands Municipal Utility
14 District No. 1.

15 Sec. 8368.002. NATURE OF DISTRICT. The district is a
16 municipal utility district created under Section 59, Article XVI,
17 Texas Constitution.

18 Sec. 8368.003. CONFIRMATION AND DIRECTORS' ELECTION
19 REQUIRED. The temporary directors shall hold an election to
20 confirm the creation of the district and to elect five permanent
21 directors as provided by Section 49.102, Water Code.

22 Sec. 8368.004. ELECTION DATES. Section 41.001(a), Election
23 Code, does not apply to an election to:

- 24 (1) confirm the district's creation;

- (2) elect initial permanent directors; or
- (3) approve a maintenance tax, bond, or contract.

Sec. 8368.005. CONSENT OF MUNICIPALITY REQUIRED. The temporary directors may not hold an election under Section 8368.003 until each municipality in whose corporate limits or extraterritorial jurisdiction the territory described by Section 2 of the Act creating this chapter is located has consented by ordinance or resolution and to the inclusion of land in the district.

Sec. 8368.006. TERRITORY ADDED. (a) The territory described by Section 2 of the Act creating this chapter is added to the district's territory as of the effective date of this section.

(b) The boundaries and field notes contained in Section 2 of the Act creating this chapter form a closure. A mistake made in the field notes or in copying the field notes in the legislative process does not affect the district's:

- (1) organization, existence, or validity;
- (2) right to issue any type of bond for the purposes for which the district is created or to pay the principal of and interest on a bond;
- (3) right to impose a tax; or
- (4) legality or operation.

SUBCHAPTER B. BOARD OF DIRECTORS

Sec. 8368.051. GOVERNING BODY; TERMS. (a) The district is governed by a board of five elected directors.

(b) Except as provided by Section 8368.052, directors serve

2 Sec. 8368.052. TEMPORARY DIRECTORS. (a) The temporary
3 board consists of:

- 4 (1) Benjamin B. Tolson;
- 5 (2) Jordan R. Smith;
- 6 (3) Shad Schmid;
- 7 (4) Ryan N. Stevens; and
- 8 (5) Janet Cobbel.

9 (b) Temporary directors serve until the earlier of:

- 10 (1) the date permanent directors are elected under
- 11 Section 8368.003; or
- 12 (2) the fourth anniversary of the effective date of
- 13 the Act creating this chapter.

14 (c) If permanent directors have not been elected under
15 Section 8368.003 and the terms of the temporary directors have
16 expired, successor temporary directors shall be appointed or
17 reappointed as provided by Subsection (d) to serve terms that
18 expire on the earlier of:

- 19 (1) the date permanent directors are elected under
- 20 Section 8368.003; or
- 21 (2) the fourth anniversary of the date of the
- 22 appointment or reappointment.

23 (d) If Subsection (c) applies, the owner or owners of a
24 majority of the assessed value of the real property in the district
25 may submit a petition to the Texas Commission on Environmental
26 Quality requesting that the commission appoint as successor
27 temporary directors the five persons named in the petition. The

4 SUBCHAPTER C. POWERS AND DUTIES

5 Sec. 8368.101. MUNICIPAL UTILITY DISTRICT POWERS AND
6 DUTIES. The district has the powers and duties provided by the
7 general law of this state, including Chapters 49 and 54, Water Code,
8 applicable to municipal utility districts created under Section 59,
9 Article XVI, Texas Constitution.

10 Sec. 8368.102. AUTHORITY FOR ROAD PROJECTS. Under Section
11 52, Article III, Texas Constitution, the district may design,
12 acquire, construct, finance, issue bonds for, improve, operate,
13 maintain, and convey to this state, a county, or a municipality for
14 operation and maintenance macadamized, graveled, or paved roads,
15 including bridges, storm drainage, and other improvements or
16 appurtenances in aid of those roads.

17 Sec. 8368.103. ROAD STANDARDS AND REQUIREMENTS. (a) A
18 road project must meet all applicable construction standards,
19 zoning and subdivision requirements, and regulations of each
20 municipality in whose corporate limits or extraterritorial
21 jurisdiction the road project is located.

22 (b) If a road project is not located in the corporate limits
23 or extraterritorial jurisdiction of a municipality, the road
24 project must meet all applicable construction standards,
25 subdivision requirements, and regulations of each county in which
26 the road project is located.

27 (c) If a municipality or county will maintain and operate

1 the road, the municipality or county must approve the plans and
2 specifications of the road project.

3 (d) If the state will maintain and operate the road, the
4 Texas Transportation Commission must approve the plans and
5 specifications of the road project.

6 Sec. 8368.104. DIVISION OF DISTRICT. (a) The district may
7 be divided into two or more new districts only if the district:

- 8 (1) has no outstanding bonded debt; and
- 9 (2) is not imposing ad valorem taxes or assessments.

10 (b) This chapter applies to any new district created by the
11 division of the district, and a new district has all the powers and
12 duties of the district, including the power to divide in accordance
13 with this section.

14 (c) Any new district created by the division of the district
15 may not, at the time the new district is created, contain any land
16 outside:

- 17 (1) the territory of the district at the time the
18 district was created; or
- 19 (2) the area described by Section 2 of the Act creating
20 this chapter.

21 (d) The board, on its own motion or on receipt of a petition
22 signed by the owner or owners of a majority of the assessed value of
23 the real property in the district according to the most recent
24 certified appraisal roll for each county in which the district is
25 located, may adopt an order dividing the district.

26 (e) The board may adopt an order dividing the district
27 before or after the date the board holds an election under Section

1 8368.003 to confirm the district's creation.

2 (f) An order dividing the district shall:

3 (1) name each new district;

4 (2) include the metes and bounds description of the
5 territory of each new district;

6 (3) appoint temporary directors for each new district;

7 and

8 (4) provide for the division of assets and liabilities
9 between or among the new districts.

10 (g) On or before the 30th day after the date of adoption of
11 an order dividing the district, the district shall file the order
12 with the Texas Commission on Environmental Quality and record the
13 order in the real property records of each county in which the
14 district is located.

15 (h) Any new district created by the division of the district
16 shall hold a confirmation and directors' election as required by
17 Section 8368.003.

18 (i) Any new district created by the division of the district
19 must hold an election as required by Chapters 49 and 54, Water Code,
20 and this chapter to obtain voter approval before the district may
21 impose a maintenance tax or issue bonds payable wholly or partly
22 from ad valorem taxes.

23 Sec. 8368.105. LIMITATION ON USE OF EMINENT DOMAIN. The
24 district may not exercise the power of eminent domain outside the
25 district to acquire a site or easement for:

26 (1) a road project authorized by Section 8368.102; or

27 (2) a recreational facility as defined by Section

1 49.462, Water Code.

3 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

4 Sec. 8368.151. TAX TO REPAY BONDS. The district may impose
5 a tax to pay the principal of or interest on bonds issued under
6 Section 8368.201.

7 [Sections 8368.152-8368.200 reserved for expansion]

8 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

9 Sec. 8368.201. BONDS FOR ROAD PROJECTS. (a) The district
10 may not issue bonds payable from ad valorem taxes to finance a road
11 project unless the issuance is approved by a vote of a two-thirds
12 majority of the district voters voting at an election held for that
13 purpose.

14 (b) At the time of issuance, the total principal amount of
15 bonds or other obligations issued or incurred to finance road
16 projects and payable from ad valorem taxes may not exceed
17 one-fourth of the assessed value of the real property in the
18 district.

19 SECTION 2. The Parklands Municipal Utility District No. 1
20 includes all the territory contained in the following area in

22 effective date of this Act:
