AN ACT

relating to the creation of the Fort Bend County Municipal Utility District No. 200; providing authority to impose a tax and issue bonds; granting a limited power of eminent domain.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle F, Title 6, Special District Local Laws Code, is amended by adding Chapter 8337 to read as follows:

CHAPTER 8337. FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 200

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 8337.001. DEFINITIONS. In this chapter:

(1) "Board" means the district's board of directors.

(2) "Director" means a board member.

(3) "District" means the Fort Bend County Municipal Utility District No. 200.

Sec. 8337.002. NATURE OF DISTRICT. The district is a municipal utility district created under Section 59, Article XVI, Texas Constitution.

Sec. 8337.003. CONFIRMATION AND DIRECTORS' ELECTION REQUIRED. The temporary directors shall hold an election to confirm the creation of the district and to elect five permanent directors as provided by Section 49.102, Water Code.

Sec. 8337.004. FINDINGS OF PUBLIC PURPOSE AND BENEFIT.

(a) The district is created to serve a public purpose and benefit.

(b) The district is created to accomplish the purposes of:

1 (1) a municipal utility district as provided by
2 general law and Section 59, Article XVI, Texas Constitution; and

3 (2) Section 52, Article III, Texas Constitution, that
4 relate to the construction, acquisition, or improvement of
5 macadamized, graveled, or paved roads described by Section 54.234,
6 Water Code, or improvements, including storm drainage, in aid of
7 those roads.

8 Sec. 8337.005. INITIAL DISTRICT TERRITORY. (a) The
9 district is initially composed of the territory described by
10 Section 2 of the Act creating this chapter.

11 (b) The boundaries and field notes contained in Section 2 of
12 the Act creating this chapter form a closure. A mistake made in the
13 field notes or in copying the field notes in the legislative process
14 does not affect the district's:

15 (1) organization, existence, or validity;

16 (2) right to issue any type of bond for the purposes
17 for which the district is created or to pay the principal of and
18 interest on a bond;

19 (3) right to impose a tax; or

20 (4) legality or operation.

22 SUBCHAPTER B. BOARD OF DIRECTORS

23 Sec. 8337.051. GOVERNING BODY; TERMS. (a) The district is
24 governed by a board of five elected directors.

25 (b) Except as provided by Section 8337.052, directors serve
26 staggered four-year terms.

27 Sec. 8337.052. TEMPORARY DIRECTORS. (a) The temporary

1 board consists of:

2 (1) Alan Lee;

3 (2) U. L. Edwards;

4 (3) Danny Wilbanks;

5 (4) Jim Taylor; and

6 (5) John West.

7 (b) Temporary directors serve until the earlier of:

8 (1) the date permanent directors are elected under
9 Section 8337.003; or

10 (2) the fourth anniversary of the effective date of
11 the Act creating this chapter.

12 (c) If permanent directors have not been elected under
13 Section 8337.003 and the terms of the temporary directors have
14 expired, successor temporary directors shall be appointed or
15 reappointed as provided by Subsection (d) to serve terms that
16 expire on the earlier of:

17 (1) the date permanent directors are elected under
18 Section 8337.003; or

19 (2) the fourth anniversary of the date of the
20 appointment or reappointment.

21 (d) If Subsection (c) applies, the owner or owners of a
22 majority of the assessed value of the real property in the district
23 may submit a petition to the Texas Commission on Environmental
24 Quality requesting that the commission appoint as successor
25 temporary directors the five persons named in the petition. The
26 commission shall appoint as successor temporary directors the five
27 persons named in the petition.

2 SUBCHAPTER C. POWERS AND DUTIES

3 Sec. 8337.101. GENERAL POWERS AND DUTIES. The district has
4 the powers and duties necessary to accomplish the purposes for
5 which the district is created.

6 Sec. 8337.102. MUNICIPAL UTILITY DISTRICT POWERS AND
7 DUTIES. The district has the powers and duties provided by the
8 general law of this state, including Chapters 49 and 54, Water Code,
9 applicable to municipal utility districts created under Section 59,
10 Article XVI, Texas Constitution.

11 Sec. 8337.103. AUTHORITY FOR ROAD PROJECTS. (a) Under
12 Section 52, Article III, Texas Constitution, the district may
13 design, acquire, construct, finance, issue bonds for, improve, and
14 convey to this state, a county, or a municipality for operation and
15 maintenance macadamized, graveled, or paved roads described by
16 Section 54.234, Water Code, or improvements, including storm
17 drainage, in aid of those roads.

18 (b) The district may exercise the powers provided by this
19 section without submitting a petition to or obtaining approval from
20 the Texas Commission on Environmental Quality as required by
21 Section 54.234, Water Code.

22 Sec. 8337.104. APPROVAL OF ROAD PROJECT. (a) The district
23 may not undertake a road project authorized by Section 8337.103
24 unless:

25 (1) each municipality or county that will operate and
26 maintain the road has approved the plans and specifications of the
27 road project, if a municipality or county will operate and maintain

1 the road; or

2 (2) the Texas Transportation Commission has approved
3 the plans and specifications of the road project, if the state will
4 operate and maintain the road.

5 (b) Except as provided by Subsection (a), the district is
6 not required to obtain approval from the Texas Transportation
7 Commission to design, acquire, construct, finance, issue bonds for,
8 improve, or convey a road project.

9 Sec. 8337.105. LIMITATION ON USE OF EMINENT DOMAIN. The
10 district may not exercise the power of eminent domain outside the
11 district to acquire a site or easement for:

- 12 (1) a road project authorized by Section 8337.103; or
- 13 (2) a recreational facility as defined by Section
14 49.462, Water Code.

15 [Sections 8337.106-8337.150 reserved for expansion]

16 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

17 Sec. 8337.151. ELECTIONS REGARDING TAXES OR BONDS.

18 (a) The district may issue, without an election, bonds and other
19 obligations secured by:

- 20 (1) revenue other than ad valorem taxes; or
- 21 (2) contract payments described by Section 8337.153.

22 (b) The district must hold an election in the manner
23 provided by Chapters 49 and 54, Water Code, to obtain voter approval
24 before the district may impose an ad valorem tax or issue bonds
25 payable from ad valorem taxes.

26 (c) The district may not issue bonds payable from ad valorem
27 taxes to finance a road project unless the issuance is approved by a

1 vote of a two-thirds majority of the district voters voting at an
2 election held for that purpose.

3 Sec. 8337.152. OPERATION AND MAINTENANCE TAX. (a) If
4 authorized at an election held under Section 8337.151, the district
5 may impose an operation and maintenance tax on taxable property in
6 the district in accordance with Section 49.107, Water Code.

7 (b) The board shall determine the tax rate. The rate may not
8 exceed the rate approved at the election.

9 Sec. 8337.153. CONTRACT TAXES. (a) In accordance with
10 Section 49.108, Water Code, the district may impose a tax other than
11 an operation and maintenance tax and use the revenue derived from
12 the tax to make payments under a contract after the provisions of
13 the contract have been approved by a majority of the district voters
14 voting at an election held for that purpose.

15 (b) A contract approved by the district voters may contain a
16 provision stating that the contract may be modified or amended by
17 the board without further voter approval.

18 [Sections 8337.154-8337.200 reserved for expansion]

19 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

20 Sec. 8337.201. AUTHORITY TO ISSUE BONDS AND OTHER
21 OBLIGATIONS. The district may issue bonds or other obligations
22 payable wholly or partly from ad valorem taxes, impact fees,
23 revenue, contract payments, grants, or other district money, or any
24 combination of those sources, to pay for any authorized district
25 purpose.

26 Sec. 8337.202. TAXES FOR BONDS. At the time the district
27 issues bonds payable wholly or partly from ad valorem taxes, the

1 board shall provide for the annual imposition of a continuing
2 direct ad valorem tax, without limit as to rate or amount, while all
3 or part of the bonds are outstanding as required and in the manner
4 provided by Sections 54.601 and 54.602, Water Code.

5 Sec. 8337.203. BONDS FOR ROAD PROJECTS. At the time of
6 issuance, the total principal amount of bonds or other obligations
7 issued or incurred to finance road projects and payable from ad
8 valorem taxes may not exceed one-fourth of the assessed value of the
9 real property in the district.

10 SECTION 2. The Fort Bend County Municipal Utility District
11 No. 200 initially includes all the territory contained in the
12 following area:

8 SECTION 3. (a) The legal notice of the intention to
9 introduce this Act, setting forth the general substance of this
10 Act, has been published as provided by law, and the notice and a
11 copy of this Act have been furnished to all persons, agencies,
12 officials, or entities to which they are required to be furnished
13 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
14 Government Code.

15 (b) The governor, one of the required recipients, has
16 submitted the notice and Act to the Texas Commission on
17 Environmental Quality.

18 (c) The Texas Commission on Environmental Quality has filed
19 its recommendations relating to this Act with the governor, the
20 lieutenant governor, and the speaker of the house of
21 representatives within the required time.

22 (d) All requirements of the constitution and laws of this
23 state and the rules and procedures of the legislature with respect
24 to the notice, introduction, and passage of this Act are fulfilled
25 and accomplished.

26 SECTION 4. This Act takes effect immediately if it receives
27 a vote of two-thirds of all the members elected to each house, as
