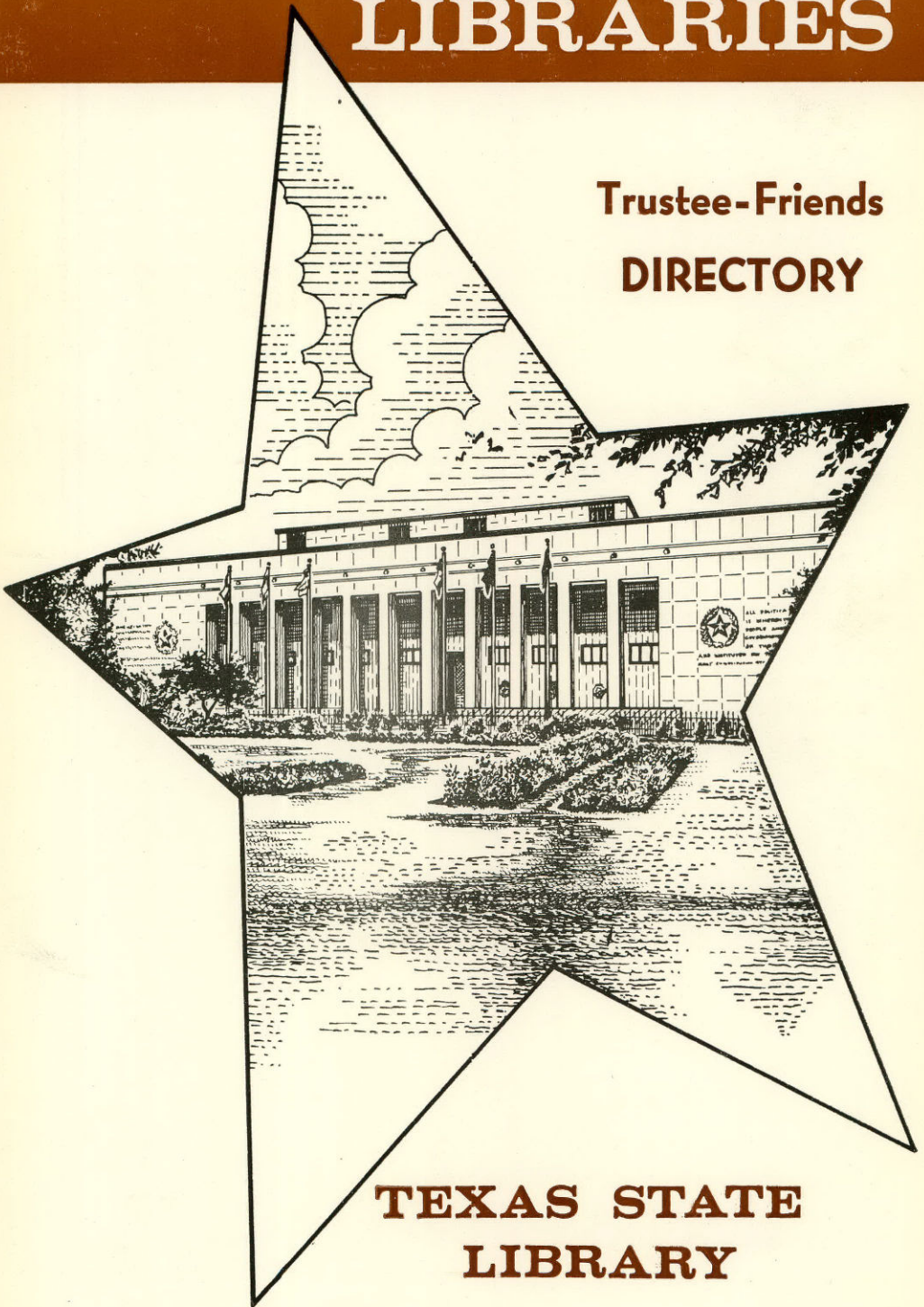

Maryland Library Receives First LSCA Construction Payment

The first payment for library construction under the expanded Library Services and Construction Act passed earlier this year was made Dec. 5 by the Office of Education, U. S. Department of Health, Education and Welfare.

The payment, \$15,750, will be used toward construction of the Annapolis Area Library of the Anne Arundel County Library System in Annapolis, Maryland. Remaining payments of the total \$70,000 Federal share will be made as construction proceeds. Overall cost of the project is \$438,904. The library is expected to be completed in August 1965.

Scholarships Offered

The Graduate Library School of The University of Chicago will offer approximately 15 fellowships and scholarships for the academic year 1965-66, of varying amounts up to \$4,000 for study leading to the master's degree or the Ph.D.

Recipients of awards are not required to perform any service in return and the awards do not prevent them from accepting part-time employment.

Awards will be made on a competitive basis with consideration given to the applicant's research objectives and academic record.

Texas Ranks 37th in Expenditures

For Library Services in Cities

With More than 35,000 Populations

Recently the Department of Health, Education and Welfare, Office of Education, Library Services Branch, Washington, was asked to compile a list of library expenditures by the 50 states. The results of this compilation, based on reports of 49 states, from library systems serving populations of more than 35,000, are shown.

Texas ranked 37th with a per capita expenditure of \$1.15 in the population bracket stated. Massachusetts ranked first with a per capita investment in library services at \$3.71 and Alabama ranked in 49th position with a per capita expenditure of only 66¢.

The mean per capita expenditure is \$2.14 and the median per capita expenditure is \$1.78.
