Rice & Co of the County of Harris State aforesaid, the following described negroes slaves, to wit - Grun a man about 31 years of age, Harry a man about 40 years of age, Reese a boy about 19 years of age, Antony or Judge a boy about 17 years of age, George a boy about 12 years of age, Maria a woman about 40 years of age, Sarah a woman about 38 years of age, Laura a girl about 15 years of age and Adeline a girl about 14 years of age, to have and to hold the above described slaves together with their natural increase unto them the said W. M. Rice & Co their, heirs, assigns and legal representatives forever, And we the said Thomas E. Bowdre and F. A. Bowdre warrant and guaranty that the said negroes are slaves for life, and sound and that we have a good title to the same and a perfect right to convey the same. Upon condition nevertheless

that if we the said Thomas E. and F. A. Bowdre pay or cause to be paid said several promissory notes with interest thereon accordingly as they severally fall due then these presents shall become void and determine, but if we shall make default in the payment of said notes and interest or either of them then and in that event these presents shall remain in full force and effect. And for the more effectually carrying out the conditions of these presents we hereby mortgage and pledge our crops of cotton hereafter to be grown until the said notes are paid and discharged to the said W. M. Rice & Co, their heirs, assigns and legal representatives, and hereby bind ourselves to ship our said cotton to them the said W. M. Rice & Co at the City of Houston Texas for their disposal â€" The words "and one dollar to us in hand paid by the said W. M. Rice & Co." between the 15th and 16th lines on the first page and the words "together with their natural increase" between the 27 and 28th lines on first page and the word "notes" 2d & 3d lines on 2d page interlined before signing.
