CRCG State Office Updates

Preview of 2016-2018 Report

The State CRCG Office prepares a statewide report on CRCG activities every two years for the Texas Legislature, Governor, and chief executive officers of state agencies. The report summarizes the number of people served by CRCGs, barriers to services, and other information related to improving the delivery of services to people with complex needs.

As of January 2019, there were 125 distinct CRCGs covering 221 counties in Texas. A web-based survey collected information from CRCGs due to changes in state data reporting systems over the past few years. Results of the survey and report highlights will be shared in early summer after the report is released.

Many CRCGs shared success stories related to successful resource coordination, improved agency collaboration, avoiding placement in facilities, increasing self-sufficiency, and meeting the needs of entire families. These stories will be featured in the Spotlight on CRCGs section of this newsletter.

Partnering Helps Everyone

The Stephens County CRCG learned that school counselors in the area needed more mentors for students. To help meet this need, CRCG members volunteered as mentors. This strengthens the relationship between the CRCG and schools while assisting youth and children in the community.

Collaborating to Fund Services

The Permian Basin CRCG, supporting Midland and Ector counties, coordinated with a family and Child Protective Services (CPS) to allow CPS to acquire joint managing conservatorship of a child who was already in placement for treatment for a severe emotional disturbance. CPS intervened to help pay for the remaining cost of that placement. The child completed the program successfully and returned home. There have been no new incidents and the family has been functioning successfully for over a year.

CRCG Partner Agency Updates

HHSC Intellectual & Developmental Disabilities and Behavioral Health Services

HHSC released an update to the *Statewide Behavioral Health Strategic Plan* and the *Foundation for the IDD Strategic Plan*. The <u>Second Edition</u> is available online.

HHSC Office of Mental Health Coordination

The Office of Mental Health Coordination coordinates policy and delivery of mental health services throughout Texas. The following topical resources are recommended for providers, community organizations, and the public.

Suicide Prevention Resources

The Suicide Prevention Resource Center offers a new series of <u>micro-learning</u> <u>videos</u> about lived experiences, safety plans, and aftercare. A more detailed video regarding <u>evidence-based treatments and brief interventions</u> is also available on the <u>Suicide Prevention Resource Center website.</u>

Veterans Resources

<u>TexVet.org</u> is an online clearinghouse of resources for veterans and their families. All listed resources are assessed to assure they truly serve veterans and do not mislead, misrepresent, or profit from veterans.

Trauma-Informed Care

Two guides are available related to trauma-informed care in Texas. The Children's Commission released <u>Building a Trauma-Informed Child Welfare System: A Blueprint</u>, a framework for improving outcomes by creating a system that is trauma-informed and trauma-responsive. The Center for Health Care Strategies created a brief that outlines practical steps health care organizations can take to become trauma-informed, titled <u>Laying the Groundwork for Trauma-Informed Care</u>.

Mental Health Wellness for Individuals with Intellectual and Developmental Disabilities

The Mental Health Wellness for Individuals with Intellectual and Developmental Disabilities e-learning training series has been updated. Three new training modules are included that teach about integrated approaches for working with people who have an intellectual or developmental disability and co-occurring behavioral health challenges.

DSHS Children with Special Health Care Needs Systems Development Group

The Texas Department of State Health Services (DSHS) Children with Special Health Care Needs (CSHCN) Systems Development Group supports population-based services for children with special health care needs related to the Title V Block Grant. CSHCN partners with community-based contractors around Texas to provide support for families with children and youth with special health care needs and disabilities. Services may include inhome or center-based respite, parent to parent connections, educational trainings and workshops, support groups, community recreational activities, and more. Not all services are available in all parts of the state. Case management for families is also available through DSHS regional offices.

Needs Assessment Survey

Every five years, DSHS conducts a statewide needs assessment of families of CSHCN and disabilities and young adults with disabilities. Survey distribution will begin in April and the findings will guide work through 2025.

Learning Collaboratives

The CSHCN Systems Development Group leads two statewide learning collaboratives that meet quarterly by teleconference call to share knowledge, implementation strategies, and best practices. Providers, youth, young adults, parents, caregivers, representatives from health care plans, hospital and university systems, and local community organizations are invited to participate. Texas Department of Housing and Community Affairs

Did you know Texas Department of Housing and Community Affairs (TDHCA) helped make 69 renter- and owner-occupied homes accessible for persons with disabilities in 2018? That is just one fact included in the recently released 2019 State of Texas Low Income Housing Plan and Annual Report, an in-depth look at Texas housing needs and distribution of TDHCA resources. TDHCA commits more than \$1 billion annually to help serve extremely low- to moderate-income families and individuals. Through multiple programs, such as the Amy Young Barrier Removal Program, the Homeowner Rehabilitation Assistance Program, or the Weatherization Assistance Program, staff work hand-in-hand with partners around the state to meet the needs of vulnerable Texans.

<u>TDHCA's website</u> offers additional information about programs and the <u>Help for Texans</u> online database provides contact information for housing and housing-related programs funded or operated by TDHCA and other service providers.
