CRCG State Office Updates

Highlights from 2016-2018 Report

Each biennium, the State CRCG Office prepares a statewide report on CRCG activities for the Texas Legislature, Governor, and chief executive officers of state agencies. The report summarizes the number of people served by CRCGs, barriers to services, and other information related to improving the delivery of services to people with complex needs.

As of January 2019, there were 125 distinct CRCGs covering 221 counties in Texas. A web-based survey collected information from CRCGs. Eighty-three percent (104) of the CRCGs completed the survey, representing 190 counties. Only eight of the CRCGs had paid positions assigned to support the CRCG.

CRCGs reported over 4,000 case staffings conducted during the three-year period. About 66 percent of these staffings related to first-time encounters and 34 percent were follow-up sessions. Eighty-one percent of all staffings conducted resulted in a community-based solution. Individuals referred to CRCGs most often expressed needs or concerns regarding mental health care (78 percent), risk behaviors (75 percent), academics or school (72 percent), risk for placement in a residential facility (69 percent), and family therapy or family-based services (61 percent).

Approximately half of CRCGs reported barriers with service availability (53 percent), physical access (50 percent), and agency capacity (46 percent). Just over one-third of CRCGs (37 percent) reported barriers related to client choice or preference. CRCGs also reported which partners regularly attended staffings. The most frequent attendees were juvenile probation officers (80 percent), local mental health authorities (70 percent), school districts (64 percent), and HHSC state benefits offices (60 percent).

Many CRCGs shared success stories related to successful resource coordination, improved agency collaboration, avoiding placement in facilities, increasing self-sufficiency, and meeting the needs of entire families. These stories will be featured in the Spotlight on CRCGs section of this newsletter. The full report is available online on the HHS website.

CRCG Site Visits

The State CRCG Office and Workgroup welcomes the opportunity to engage and visit with local CRCG partners. Local meetings increase our awareness of community strengths and needs, which improves our ability to provide effective technical assistance and support.

State CRCG Office staff members recently visited three Texas regions (Jackson County, McLennan County, and six counties in the Brazos Valley). In April, the Jackson County CRCG came together to reestablish their CRCG. The meeting was attended by many members of their community including school districts, the Red Cross, a local hospital, and others joining the conversation. A case staffing was also completed during the meeting.

The McLennan County Adult CRCG held a monthly meeting in May. Because there were no community members requesting CRCG support at the time, the group learned from a partner about Maximus benefit enrollment services.

Finally, six counties from the Brazos Valley area gathered to launch a peer learning group in June. Leaders from Brazos, Burleson, Grimes, Leon, Madison, and Robertson counties discussed the roles and responsibilities of CRCGs and helped each other identify the best ways to gain participation from key partners.

Senate Bill 241 was passed during the 86th Texas Legislature, Regular Session, 2019. The bill amends language in Sections 531.421(3) and (4) of the Government Code by repealing the word "consortium" and replacing it with "commission." The State CRCG Office is developing an implementation plan and will update local CRCGs as more information is gathered.

He enjoys the structure and routine of the academy and developed an interest in a military career. His adoptive father and mentor work together to encourage his success while also continuing to maintain contacts in the community for when he returns home from the program. The young man is focused on his future and fulfilling his goals. The family is thankful the CRCG helped them find another option that provides him with additional opportunities.

CRCG Partner Agency Updates

HHSC Early Childhood Intervention

<u>Early Childhood Intervention (ECI)</u> is a statewide program for families with children from birth to 36 months of age with developmental delays, disabilities, or certain medical diagnoses that may impact development.

ECI works with other state agencies and organizations to provide services for children and families in Texas. ECI builds partnerships with state and local organizations to help ensure families are connected to the resources and supports they need. One valuable resource for families is the Navigate Life
Texas (NLT) website. HHSC created the NLT website to inform and empower parents of children with disabilities or special healthcare needs. The website was developed by parents, for parents. The NLT website includes information on many topics, such as health care, education, insurance, medical diagnoses, and transition to adulthood.

There is also a section on the website about connecting with other parents. To find additional resources for families of children with developmental delays or disabilities, professionals, and anyone interested in the well-being of young children and their families, visit the ECI Resource Guide.

HHSC Office of Mental Health Coordination

The Office of Mental Health Coordination coordinates policy and delivery of mental health services throughout Texas. The following topical resources are recommended for providers, community organizations, and the public.

Suicide Prevention Resources

The <u>Suicide Prevention Resource Center</u> released, "<u>After Suicide: A Toolkit for Schools</u>," to help schools implement a coordinated response to the suicide death of a student. This second edition contains new information and tools.

Veterans Resources

The Military Veteran Peer Network (MVPN) provides peer-to-peer support and resource awareness for service members, veterans, and their families through embedded Peer Service Coordinators (PSCs) at 37 local mental health authorities throughout Texas. PSCs coordinate and provide training on military-informed care, military cultural competency, and specific evidence-based methods of identifying and addressing mental health issues to create a statewide network of military trauma-affected veteran peer support. Department of Family and Protective Services

The Texas Department of Family and Protective Services (DFPS) hosts the HelpandHope.org website to compile parenting information, tips, and a resource directory. Click on "find help" to search for available programs. DFPS created the Texas Prevention Network (TPN) to bring together experts and prevention partners to combine intellectual and material resources to guide state efforts in preventing child abuse and neglect. Go to the TPN subscription page to sign up for information from the group.

Department of State Health Services

The Texas Department of State Health Services (DSHS) Children with Special Health Care Needs (CSHCN) Systems Development Group supports population-based services for children with special health care needs related to the Title V Block Grant. CSHCN partners with community-based contractors around Texas to provide support for families with children and youth with special health care needs and disabilities. Services may include inhome or center-based respite, parent to parent connections, educational trainings and workshops, support groups, community recreational activities, and more. Not all services are available in all parts of the state. Case management for families is also available through DSHS regional offices.

Needs Assessment Survey

Every five years, DSHS conducts a statewide needs assessment of families of CSHCN and disabilities and young adults with disabilities. Survey distribution will begin in April and the findings will guide work through 2025.

Learning Collaboratives

The CSHCN Systems Development Group leads two statewide learning collaboratives that meet quarterly by teleconference call to share knowledge, implementation strategies, and best practices. Providers, youth, young adults, parents, caregivers, representatives from health care plans, hospital and university systems, and local community organizations are invited to participate.
