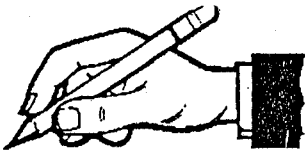

..... EXAM UPDATE

To all of those testing in late 1992 or early 1993: the Texas Comprehensive Exam will no longer be given after March 1993. Testing will be given the second Thursday of the following months only (this includes the NAB and the Texas State Standards Exam). Testing months will be January, April, July and October. In addition to the \$250 application fee, a check for \$125 (payable by cashier's check or money order made out to NAB) will be required the day of the test.
