To all of those testing in late 1992 or early 1993: the Texas Comprehensive Exam will no longer be given after March 1993. Testing will be given the second Thursday of the following months only (this includes the WAB and the Texas State Standards Exam). Testing months will be January, April, July and October. In addition to the \$250 application fee, a check for \$125 (payable by cashier's check or money order made out to WAB) will be required the day of the test.

ATTORNEY GENERAL'S OPINION NO. DM-219

RE: Authority of the Board of Licensure for Nursing Home Administrators to charge and "collect a \$10.00 fee for each administrator-participant in all education courses approved by the (board) for continuing education units" (RQ-492)

SUMMARY

The Board of Licensure for Nursing Home Administrators is not authorized to impose and collect a \$10.00 fee from administrators or participants in courses conducted by outside sources and approved by the board as continuing education units.*
