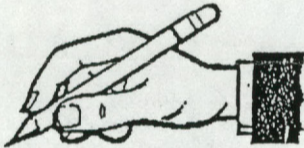

EXAM UPDATE

To all of those testing in 1993: The Texas Comprehensive Exam will no longer be given after March 1993. Testing will be given the second Thursday of the following months only: January, April, July and October (this includes the NAB and the Texas State Standards Exam). In addition to the \$250 application fee, a check for \$125 (payable by cashier's check or money order only made out to NAB) will be required the day of the test.
