OPEN FORUM

This is a reminder that individuals or representatives of groups have an opportunity to communicate directly with the Board of Nurse Examiners during Open Forum, which is held during each Board meeting.

Interested persons are requested to notify the Executive Secretary in writing or by telephone prior to the scheduled Board meeting so that the request to address the Board is assured and to confirm the time, date and location of the open forum.

MANDATORY CONTINUING EDUCATION

The second meeting of the Joint Advisory Committee on Mandatory Continuing Education was held January 19, 1990, at the Ramada Inn, North IH-35, Austin, Texas. The Joint Advisory Committee was appointed by the Board of Nurse Examiners and the Board of Vocational Nurse Examiners to assist the Boards in developing one set of rules for continuing education which will apply to RN's and LVN's. The Committee is composed of 21 members representing various practice sites, geographic regions of the state, LVN and RN organizations, and consumer interest.

The Advisory Committee is in the process of defining the purpose of

mandatory continuing education. Members are reviewing rules and regulations for other states which have implemented continuing education. The committee will be studying the issues related to CE by dividing itself into two subgroups. One group will consider the many issues related to program/provider approval. The second group will consider implementation in regard to what nurses will be required

process will occur, enforcement of the rules and numerous other concerns.

Senate Bill 622 allows both Boards to require not more than 20 hours of continuing education per two-year licensure renewal period.

Once rules are approved, RN's/LVN's will be allowed ample time to complete CE requirements.

USE OF FENTANYL AND VERSED

Recently we have received many inquiries regarding the administration of Fentanyl and Versed by RN's. As with the administration of any medication, it is the RN's responsibility to know the proper dosage, route, side effects, and precautions prior to administration. RN's who are knowledgeable about Fentanyl and Versed may administer these drugs under a physician's order.

The Board does prohibit an RN from administering any agents for the purpose of anesthesia. Administration of anesthesia should be performed by a CRNA or anesthesiologist.

SPEAKING TOUR OF TEXAS

In October, 1989, the Board of Nurse Examiners began its series of workshops entitled "The BNE and You: Current Perspectives on Regulation and Practice." The workshops are designed to inform RN's around the state about the Nurse Practice Act; roles and functions of the Board; current legislation, such as mandatory continuing education and prescriptive authority; mandatory reporting; peer review; and various other topics.

Thusfar, workshops have been offered in Fort Worth, El Paso, Austin, and Galveston. Over 800 RN's have attended.

Each RN licensed and residing in the state will receive a brochure announcing the workshop when it is scheduled for the site nearest his/her home address. Due to the number of RN's and the size of the state, brochures are being grouped by county and mailed to RN's residing in the counties surrounding each workshop site. Please plan to register early when the workshop is offered in your area. We are unable to accommodate you at other sites, and we will only be able to accept original registration forms.

However, dates have not been confirmed for these sites: Amarillo, Lubbock, Midland, San Angelo, Abilene, Wichita Falls, Del Rio, Corpus Christi, Victoria, San Antonio, Houston, Bryan, Waco, Dallas, Beaumont, Texarkana, and Denton.

EDUCATION REPORT

At the November 28-30, 1989, meeting of the Board of Nurse Examiners, the Board approved the following:

 The development of Collin County Community College Associate Degree Nursing Program;

2. An extended campus at Brownsville/Harlingen of The University of Texas Health Science Center at San Antonio Baccalaureate Degree Nursing Program;

3. A curriculum change for Baylor University Baccalaureate

Degree Nursing Program; and

4. A policy allowing staff to approve requests for use of cooperating agencies as major clinical resources for nursing students. Cooperating agencies will need to submit information on the Board's forms and meet the Board's requirements according to §215.17 of the Rules and Regulations Relating to Professional Nurse Education, Licensure and Practice.

Student enrollment in Texas professional nursing programs continues to increase. In fall, 1988, there were 11,419 enrolled, and in Fall 1989, there were 12,271 enrolled. However, an insufficient number of qualified faculty continues to compound the nursing shortage. Directors of nursing programs in most parts of Texas report having difficulty recruiting qualified faculty. Therefore, 1,375 prospective students were placed on a waiting list.

LICENSING/SUPPORT SERVICES DÉPARTMENT

As of September 1, 1989, two departments of the Board of Nurse Examiners were consolidated into the Licensing and Support Services Department supervised by Mark W. Majek (512) 835-8670 as the Program Administrator. The department has four divisions and is supervised by the following personnel:

Each division covers the following areas:

ACCOUNTING - The Accounting Division is responsible for processing all financial transactions of the Board, recording these transactions, and assisting management in its decisions by providing useful financial reports, budgets and projections.

CONTINUING EDUCATION - The staff member in this division is working with the Advisory Committee on Mandatory CE and will assist in implementing rules on mandatory CE once they are established. This division also handles registration for the series of speaking tours in Texas that are planned during the next two years.

DATA PROCESSING - The Data Processing Division is responsible for producing computerized lists on floppy diskettes, magnetic tape, hard copy, or on mailing labels. The department is also responsible for updating and maintaining all information in the RN file, including renewal updates, changes of address, and name changes. The permanent RN files are microfilmed and maintained by Data Processing staff.

LICENSING - The Licensing Division is responsible for endorsement, renewal, and verification of licenses.

The endorsement section processes applications of registered nurses coming to Texas from other states within the U.S. or Canada. Temporary permits for nurses currently registered in another state or first time candidates from other states or Canada scheduled to take the upcoming NCLEX-RN or CNATSE examination are also processed in the endorsement department.

The renewal section processes all Texas RN renewals. This includes all current, inactive, and delinquent status license renewals. Duplicate licenses requested due to loss or name change are processed in the renewal department.

The verification section processes verification of Texas licensure to other state boards of nursing. Transcripts and Board scores for registered nurses licensed in Texas by examination are sent out by this department. Requests for the Board's publications: Rules and Regulations Relating to Professional Nurse Education, Licensure, and Practice, the Nurse Practice Act, and the quarterly newsletter, are handled by this department. The verification department maintains a list of individuals, agencies and hospitals that subscribe to the quarterly newsletter.

DID YOU KNOW?

- License renewal forms are mailed approximately 60 days prior to expiration of current licensure. Many are returned as undeliverable because the registered nurse has moved and failed to notify the Board of the address change. The nurse cannot depend upon the post office to forward his/her renewal application. It is the responsibility of each nurse to notify the Board of address or name changes. Failure to receive a renewal application form does not excuse a nurse from the requirement for renewal of licensure or from the fee for reinstatement of a lapsed license.
- An employer has no jurisdiction over licensure. Action against a license can be taken only by the Board after due process as provided for by the Texas Administrative Procedures Act and if the nurse is in violation of the Nurse Practice Act.
- An institution may formulate a policy that is stricter than the Nurse Practice Act, but it may not be more lenient.
- According to the Nurse Practice Act, the registered nurse is directly accountable and responsible to the individual consumer for the quality of nursing care rendered. This responsibility cannot be avoided by accepting the order or directions of another.
- There are 73 nursing education programs accredited by the Board of Nurse Examiners: 2 are diploma programs, 44 are associate degree nursing programs, 21 are baccalaureate degree nursing programs, 1 is a master's degree nursing program, 4 are baccalaureate degree programs for RN's, and 1 is an advanced nurse practitioner program. During the past year, the Board has granted initial accreditation to 3 nursing programs. Three colleges and universities are currently seeking initial accreditation for new nursing programs. There are 3 nursing schools who are currently developing extended campuses.
- Texas is one of only six states to have separate practice acts and boards governing RN's and LVN's.
- As of December, 1989, there are approximately 2,970 advanced nurse practitioners approved by the Board.

PRACTICE RELATED QUESTIONS AND ANSWERS

The Board receives numerous calls and letters regarding practice issues. One of the functions of the nursing consultants is to advise consumers and RN's concerning these matters. In this column, Cady Crismon, M.S.N., R.N., responds to frequently asked questions.

Q: May RN's peripherally insert central venous catheters?

A: The Practice Committee of the Board of Nurse Examiners has determined that the procedure for peripherally inserting central venous catheters would be within the scope of practice of the registered nurse provided the following conditions are met:

- (1) The registered nurse has received appropriate education and supervised practice, is competent to perform the procedure, and is competent to respond appropriately to complications and/or untoward effects of the procedure.
- (2) The record of education is maintained in the nurse's file.
- (3) The Employer, through written policy, has agreed upon well defined protocols for the performance of the procedure; and
- (4) The procedure has been ordered for the patient by an appropriate licensed practitioner.

The Board does not set requirements for physician backup; however, this should be addressed in the facility's policies and procedures. These policies and procedures may be more restrictive than the Nurse Practice Act and the Board's rules and regulations, but not less restrictive.

Q: May an RN accept an order transmitted by an individual other than the physician?

A: A registered nurse may accept and carry out a physician's, dentist's, or podiatrist's order for the administration of medications or treatments when that order <u>originates</u> with one of the above licensed practitioners and is merely relayed or communicated to the RN through another person. The RN who carries out the order is responsible for assuring that the order is correct. He/she is required to question any order which he/she suspects is not correct.

Q: Can a graduate of a nursing program in another state practice in Texas under the other state's permit while awaiting results of the licensure exam?

A: No, new graduates wishing to practice professional nursing in Texas must hold a permit issued by the Board of Nurse Examiners for the State of Texas. Only those graduates holding a Texas permit may use the title Graduate Nurse (G.N.).

Q: I am a school nurse responsible for providing care to children at three schools in my district. Am I responsible for accidents that occur on one campus when I am at another school?

A: You, as an RN, are accountable for your nursing practice. You are not liable for accidents which occur in your absence.

ATTENTION ADVANCED NURSE PRACTITIONERS

Did you know that in order to hold yourself out to be an advanced nurse practitioner or use a title that implies you are an advanced nurse practitioner, your credentials must be approved by the Board of Nurse Examiners. If you are practicing as an advanced nurse practitioner (ANP) and using a title that implies that you are an ANP, then you could be violating the Board's rules and regulations.

Exactly what is an advanced nurse practitioner? ANP's are "...prepared for advanced nursing practice by virtue of knowledge and skills obtained through a post-basic or advanced educational program of study acceptable to the Board." (Rule 221.1). "Advanced Nurse Practitioner" is a generic term which includes the categories of Nurse Anesthetists, Nurse Midwives, Nurse Practitioners and Clinical Nurse Specialists. Educational preparation requirements vary but, in general, Nurse Anesthetists, Nurse Midwives, and Nurse Practitioners have attended either post-basic certificate programs or nursing graduate level programs to prepare them to practice in advanced roles. Clinical Nurse Specialists have attended nursing graduate level programs with a specific clinical focus.

The specialty areas in which nurse practitioners (NP's) can be recognized by the Board include:

School NP

Women's Health Care NP

Pediatric NP

Gerontological NP

Family NP

Neonatal NP

The specialty areas in which Clinical Nurse Specialists (CNS's) can be recognized by the Board include:

Maternal Child Health CNS

Oncology CNS

Medical-Surgical CNS

Pediatric CNS

Neonatal CNS

Psychiatric/Mental Health CNS

ADVANCED NURSE PRACTITIONERS WHO MANAGE MEDICAL ASPECTS OF CARE

Advanced Nurse Practitioners (ANP's) who manage medical aspects of care are required by the Board's rules to do so under standing delegation orders or protocols. Protocols are simply a very specific strategy for assessing and managing health care problems which address data collection and the various therapeutic measures which should be considered. The protocol serves as a guide from which the nurse practitioner selects therapeutic interventions based on the individual patient's presenting symptoms, needs, and other factors.

The Board's rules require that protocols must be jointly developed by the nurse practitioner and the delegating physician and reviewed at least annually. The Board does not recommend any particular format for protocols, but many published materials are available on the subject of writing protocols for various specialty practices. The scope of these protocols will vary in relation to the practice setting, population, and complexity of client problems. Protocols should be maintained by the ANP who manages medical aspects of care in the practice setting.

MODEL SYSTEM TO VERIFY LICENSES

Since the number of registered nurse impostors is on the rise in Texas, employers of nurses are concerned about how to ensure that the nurses they hire are currently licensed. The Texas Department of Corrections (TDC) has developed a system of verification which has been successful in identifying a nurse with fraudulent credentials. When beginning employment at TDC, the nurse presents her/his original license, which is inspected. The license is then verified with the Board of Nurse Examiners. The license number, expiration date, and any disciplinary codes are placed on a master log, which is reviewed monthly. Whenever a license is up for renewal, a reminder letter is sent to the nurse. After the nurse renews her/his license, she/he must present it for the employer's inspection and verification again. Nurses without current licensure are not allowed to work for the facility in any capacity.

HOUSE BILL 18: PRESCRIPTION DRUG ORDERS

House Bill 18, the Omnibus Rural Health Rescue Act of 1989. was passed by the 71st Legislature. A major component of HB 18 provided that the Board of Nurse Examiners (BNE) must adopt rules establishing the educational requirements for Registered Nurses to be approved to carry out prescription drug orders. The bill further defined the circumstances under which the RN would be eligible for these "prescriptive privileges" as follows:

- The population served must be medically indigent and clinic sites must be approved by the Texas Department of Health.
- The physician delegating prescription drug orders under standing delegation orders or protocols must visit the clinic site once a week, be informed of complications on a daily basis, and be available to the RN by telecommunications.
- The prescription format utilized must contain some essential information such as the name, address, and identification number assigned to the RN by the BNE. The prescription must also be presigned by the physician.
- The intention of this legislation was to increase services available to clients who are not receiving adequate health care services. The educational requirements of the RN, including pharmacology, will be defined by the BNE. The Board has appointed an advisory committee to assist in the writing of rules and regulations for the RN's initiating prescription drug orders under provisions of HB 18.

The Prescription Drug Order Advisory Committee first met on December 1, 1989. The committee reviewed the charge from the Board and made recommendations for each charge. The second meeting was scheduled for January 5, 1990, at the Board's office in Austin. The committee reviewed proposed rules which were recommended for the Board's consideration.

When the Board takes action on proposed rules, they will be published in the Texas Register and comments from the public will be invited. SCHOLARSHIP FUND UPDATE

Senate Bill 1351 established a comprehensive education financial aid program for RN's and LVN's. This will include scholarships, loan repayment and employer matching funds. The program is being funded through a one time assessment of \$10 for RN's and \$5 for LVN's during license renewal during the next two years.

PLEASE NOTE: for RN's whose licenses expire between September, 1989 through August 1991, the \$10 is already included in the renewal fee of \$32.

TEXAS PEER ASSISTANCE PROGRAM FOR **IMPAIRED NURSES**

Representatives of the Texas Peer Assistance Program for Impaired Nurses (TPAPIN) requested and received a funding increase at the November 30, 1989, meeting of the Board of Nurse Examiners. The increase is to be used to hire additional staff, provide additional office space and equipment, and allow for additional training for TPAPIN advocates. The extra funding will also be used for: (1) implementation of mental health services for impaired nurses and (2) implementation of a nursing education program that provides information regarding chemical dependency and mental illness in the nursing population.

DO YOU KNOW A REGISTERED NURSE WHO NEEDS HELP?

If you know a registered nurse who is depressed, drinking more than moderate amounts of alcohol, or is abusing drugs and is not practicing nursing in a manner that is in the public's best interest, give the Texas Peer Assistance Program for Impaired Nurses (TPAPIN) an opportunity to help. Dear Legal Eagle:

Is there any protection against a libel action being brought against an individual who reports an RN to the Board?

Worry about something else. Pursuant to the Nurse Practice Act, an individual that, without malice, makes a report required or permitted, is immune from civil liability and may not be subjected to any other retaliatory action as a result of making the report.

What are my legal privileges and liabilities if I write to the Board and make a complaint against a registered nurse?

Considering that an individual that makes a complaint to the Board incurs no liability, and that there is a privilege of confidentiality for the name of the complainant, there is no reason not to report a suspected violation of the Nurse Practice Act to the Board.

Dear Legal Eagle:

What will the Board do to someone who threatens members of the hospital staff with termination, and thwarts the reporting process, by threatening an employee who is merely trying to report illegal/unprofessional conduct as mandated by state statute?

Dear Threatened:

The statute forbids retaliation against a complainant. If the individual who has threatened, thwarted, and almost terminated you is a registered nurse, report the conduct to the Board. The Board will investigate the complaint and, if a violation of the Nurse Practice Act is substantiated, will take disciplinary action against the license of that nurse.

Dear Legal Eagle:

The Peer Review Process in one small hospital has turned into a "witch hunt." The process is being used as a vehicle for public humiliation, attended by all who would like to watch a mock trial, and the resulting execution is enjoyed by all. Very few people here will attend an in-service, but on "fry a nurse day," it is standing room only - packed three deep. It doesn't matter what you may or may not have done, it only matters who you are.

The process is tailor made for gossip-ridden, clique controlled, vendetta oriented, small town hospitals. When these vicious, malicious, power hungry, jealous people could only inflict mental anguish upon a job, a person could resign and go to another job. Now, however, you have given them a process whereby they can cause permanent damage to a nurse's right to work, i.e. messing with the Nurse's License! The public should be served and protected but who is serving and protecting the Nurse?

No Name Because Nurse Advocates GET Peer Reviewed AND Reported

Dear Nurse Advocate:

Peer Review was not designed to be a witch hunt, a mock trial, or a vehicle for public humiliation. The designers of peer review did not envision "fry a nurse day" to be the result of a properly implemented peer review committee.

According to the law, "Peer Review" means the evaluation of professional nursing services, the qualifications of professional nurses, the quality of patient care rendered by professional nurses, the merits of complaints concerning professional nurses and professional nursing care, and determinations or recommendations regarding complaints including: the accuracy of nursing assessments and observations; appropriateness and quality of the care rendered by a professional nurse; reports made to a professional nursing peer review committee concerning activities under the committee's review authority; reports by a professional nursing peer review committee to other committees or to the Board as permitted or required by law; and implementation of the duties of a professional nursing peer review committee by its members, agents, or employees.

Pursuant to the statute, all proceedings of a professional nursing peer review committee are <u>confidential</u> and all communications made to a professional nursing peer review committee are privileged. Peer review should <u>never</u> be "standing room only - three deep." It is the responsibility of the facility to establish the peer review committee and ensure that it operates in conformance with statutory law. If your hospital is operating its peer review committee in contravention of the law, the Texas Department of Health has the authority to take action against the hospital. RESULTS OF THE BOARD'S EVALUATION OF MANDATORY REPORTING, PEER REVIEW AND THE DELEGATION RULES

The Board of Nurse Examiners has conducted an evaluation of the implementation of mandatory reporting, peer review, and the Board's Delegation Rules. The Board mailed surveys to Texas registered nurses, nurse administrators, chairpersons of peer review committees, and nurse surveyors employed by the Texas Department of Health and the Texas Department of Mental Health and Mental Retardation. In addition, selected staff members of the Board and TPAPIN were interviewed, and a record review of the Board's disciplinary cases was conducted. Overall, responses obtained from the surveys and interviews indicated no serious problems with the implementation of mandatory reporting, peer review, and the Delegation Rules.

A brief summary of the results of the surveys follows. If you need further information or have questions, please contact Wendy Francik, research assistant for the Board, at 512/835-8650.

Survey Results from Nurse Administrators

Of the 580 nurse administrators receiving surveys, 33% (\underline{n} = 190) returned usable questionnaires. Nurse administrators reported that the most frequently used sources for mandatory reporting facts were the BNE Newsletter (89%) and the Texas Nurse Practice Act (78%). For the Delegation Rules facts, they most frequently used the BNE Newsletter (80%) and the BNE Rules and Regulations (67%). For details on peer review, 187 of the nurse administrators most frequently used the BNE Newsletter (87%) and the Texas NPA (76%).

Nurse administrators were asked to rate descriptive statements about mandatory reporting, peer review, and the Delegations Rules. On the average, responses showed that the administrators did not think mandatory reporting caused an increase in interpersonal conflicts among RNs and that both hospital and nursing administration supported peer review.

<u>Survey Results from Chairpersons of Peer Review</u> <u>Committees</u>

The Board surveyed 580 chairpersons of peer review committees (PRC) of whom 25% (n = 146) returned usable surveys.

When asked about sources for information about peer review requirements, 143 chairpersons indicated that they most frequently consulted colleagues (55%), the BNE guidelines (53%), or attended a Peer Review Workshop (50%).

Regarding the composition of their PRCs, 80% of the chairpersons reported that members were appointed to their PRCs. Also, 60% of the PRC chairs indicated that members on their

PRCs served for a specific term, while 58% indicated that terms typically lasted one to two years.

Regarding the presence of RNs on PRCs, an average of 3.16 staff RNs and 2.67 nurse administrators/managers served on PRCs. The average total for number of PRC members was 7.36.

On the average, peer review chairpersons rated descriptive statements about peer review. Their ratings showed that peer review committees and others involved in peer review did not encounter serious interpersonal conflict, provided adequate opportunity for rebuttal, and that nursing administration and hospital administration were supportive of peer review. Demographic data from chairpersons indicate that 63% were nurse administrators or managers, whereas only 11% were staff RNs.

Survey Results from Texas Registered Nurses

Of the 1,042 Texas RNs surveyed, 29% (n = 297) returned usable questionnaires. RNs responded to questions about their sources of information on mandatory reporting, peer review, and the Delegation Rules. Of the respondents, 291 RNs reported that the most frequent sources of mandatory reporting facts were the BNE Newsletter (51%), employers providing information (39%), and the Texas NPA (38%).

For peer review facts, 287 RNs most frequently used the BNE Newsletter (44%), information from employers (39%), Texas NPA (33%), and in-service presentations (33%). For facts about the Delegation Rules, 295 RNs reported most frequently using the BNE Newsletter (38%), information from employers (26%), and the BNE Rules and Regulations (24%).

Of the 297 RNs responding to survey items about an employer's written policy for the mandatory reporting of unsafe or unprofessional nursing care, 47% reported having read an employer's policy, 15% reported that an employer did not have a policy, and 21% reported not knowing whether an employer had such a policy.

RNs also rated descriptions of mandatory reporting and peer review. In general, RNs rated support for peer review from nurse administrators and hospital administrators just slightly lower than nurse administrators and peer review chairpersons. Overall, RNs expressed moderate concern about the confidentiality of the peer review process and did not think they had sufficient input into selecting PRC members.

Survey Results from Nurse Surveyors

The Board distributed the survey to 104 nurse surveyors who worked for the Texas Department of Health or the Texas Department of Mental Health and Mental Retardation, of whom 41% ($\underline{n} = 43$) returned usable surveys.

Nurse surveyors identified a number of sources for obtaining facts about mandatory reporting, peer review, and the Delegation Rules. For mandatory reporting facts, surveyors most frequently consulted the BNE Newsletter (70%), the Texas NPA (63%), and colleagues (61%). Of the surveyors, 41 indicated most frequently using these same sources, BNE Newsletter (60%), Texas NPA (58%), and colleagues (56%), in obtaining information about peer review. For information on the Delegation Rules, 42 surveyors most frequently consulted the BNE Newsletter (51%), the Board's Rules and Regulations (49%), and colleagues (49%).

Survey results show much variability in surveyors' practices in monitoring facilities' compliance with mandatory reporting, peer review, and the Delegation Rules. For example, standard surveys conducted by nurse surveyors do not necessarily address mandatory reporting and peer review per se. Therefore, 44% of the 43 respondents indicated that obtaining information about mandatory reporting and peer review were not part of the survey process.

Of 39 surveyors who answered a question about monitoring compliance with peer review, 37% indicated that obtaining such information was not part of the survey visit. In addition, when asked about the delegation of nursing tasks in accordance with the Delegation Rules, 44% of 42 surveyors responded that they consistently monitored delegation, 26% indicated sometimes monitoring delegation, and 14% did not monitor the delegation of nursing tasks. Surveyors indicated they become aware of reportable situations during surveys or inspections in a number of ways: walk-through inspections (12%), review of records (23%), complaint investigations (33%), and other sources (21%).

When asked about the delegation of nursing tasks in accordance with the Delegation Rules, 44% of the surveyors reported that they consistently monitored delegation, 26% sometimes monitor delegation, and 14% did not monitor the delegation of nursing tasks.

Based on the survey data, recommendations to improve the implementation of mandatory reporting, peer review, and the Delegation Rules will be made.

The Board wishes to thank all the Texas Registered Nurses who participated in our evaluation. Your responses were crucial to the evaluation's success, and we are most appreciative.
