### Dr. Fisher Passes Gavel

## Schultz Elected Board Chairman

J. M. "Mark" Schultz is the new chairman of the Board of Directors of Gulf Coast Waste Disposal Authority. He was elected to that position by his fellow board members at a meeting September 13.

Schultz was nominated for the position by Dr. Frank Fisher, chairman since 1984, who announced it was time for another member to take on the chairman's responsibilities. Following his election, Schultz complimented Dr. Fisher for his leadership "during some tough times, times that have seen significant changes for Gulf Coast Authority."

Representing the Chambers County Commissioners Court, Schultz was appointed in 1979 and had served as vice chairman since September, 1988.

A graduate of North Texas State University, Schultz held positions at Republic National Bank in Dallas and Texas Commerce Bank. In the mid 70's he joined the family rice farming enterprise.

Dr. Fisher, Harris County Commissioner's Court appointee, was elected vice chairman; Ossie Matthews, Galveston County Commissioner's Court appointee, was elected secretary; and Gail Bradley, Galveston County Mayors' appointee was re-elected treasurer.

GCWDA has recently worked with Chambers County on a study of the county's landfill needs.



- adopted a Resolution finding and declaring that certain property owned by the Authority, consisting of components of the Union Carbide Aqueous Waste Treatment Facilities, commonly known as the "40-Acre Facility", in Galveston County, Texas, specifically the primary treatment facility and pipeline facilities. together with the land, easements, and improvements thereon and used in connection therewith, are no longer required to carry out the plans of the Authority; and authorizing the publication of notice of the Authority's intent to sell said property and the receipt of bids in accordance therewith.
