6	SECTION 1. Chapter 113, Natural Resources Code, is amended
7	by adding Subchapter M to read as follows:
8	SUBCHAPTER M. CONSUMER SAFETY NOTIFICATION
9	Sec. 113.401. NOTICE REQUIRED. (a) A person holding a
10	license to install or repair an LPG system who sells, installs, or
11	repairs an LPG system, piping or other equipment that is part of a
12	system, or an appliance that is connected or attached to a system
13	shall provide the following notice to the purchaser or owner of the
14	system, piping or other equipment, or appliance:
15	WARNING: Flammable Gas. The installation, modification, or
16	repair of an LPG system by a person who is not licensed or
17	registered to install, modify, or repair an LPG system may cause
18	injury, harm, or loss. Contact a person licensed or registered to
19	install, modify, or repair an LPG system. A person licensed to
20	install or repair an LPG system may not be liable for damages caused
21	by the modification of an LPG system by an unlicensed person except
22	as otherwise provided by applicable law.
23	(b) The commission shall adopt rules relating to the notice
24	required by Subsection (a).

- 1 SECTION 2. Section 113.301, Natural Resources Code, is
- 2 amended to read as follows:
- 3 Sec. 113.301. LIMITATION OF LIABILITY OF LICENSED INSTALLER
- 4 OR SERVICER. A person is not liable for damages caused solely by a
- 5 malfunction or the installation, modification, or improper
- 6 operation of an LPG system that the person delivered for
- 7 <u>installation</u>, installed, or serviced in a residential, commercial,
- 8 or public building or in a motor vehicle if:
- 9 (1) the person was licensed by the commission to
- 10 perform the installation or service or was a registrant;
- 11 (2) the <u>delivery</u>, installation, or service was
- 12 performed in compliance with the safety rules and standards adopted
- 13 by the commission;
- 14 (3) the person has no control over the operation or use
- 15 of the LPG system;
- 16 (4) the person was not negligent; and
- 17 (5) the person did not supply a defective product
- 18 which was a producing cause of harm.
- 19 SECTION 3. Section 113.301, Natural Resources Code, as
- 20 amended by this Act, applies only to a cause of action that accrues
- on or after the effective date of this Act. A cause of action that
- 22 accrued before the effective date of this Act is covered by the law
- 23 in effect when the cause of action accrued, and that law is
- 24 continued in effect for that purpose.
- 25 SECTION 4. Section 113.301, Natural Resources Code, as
- 26 amended by this Act, is an exercise of authority under Section
- 27 66(c), Article III, Texas Constitution, and takes effect only if

- 1 this Act receives a vote of three-fifths of all the members elected
- 2 to each house, as provided by Subsection (e) of that section.
- 3 SECTION 5. (a) Except as provided by Subsection (b) of
- 4 this section, this Act takes effect immediately if it receives a
- 5 vote of two-thirds of all the members elected to each house, as
- 6 provided by Section 39, Article III, Texas Constitution. If this
- 7 Act does not receive the vote necessary for immediate effect, this
- 8 Act takes effect September 1, 2007.
