7 SECTION 1. Section 111.002, Natural Resources Code, is

9 Sec. 111.002. COMMON CARRIERS UNDER CHAPTER. A person is a

common carrier subject to the provisions of this chapter if it:

11 (1) owns, operates, or manages a pipeline or any part

petroleum to or for the public for hire, or engages in the business

of transporting crude petroleum by pipeline;

- 21 rights acquired, it becomes a common carrier subject to the duties

- (7) owns, operates, or manages a pipeline or any part

- 5 SECTION 2. Section 111.013, Natural Resources Code, is
- 6 amended to read as follows:
- 7 Sec. 111.013. CONTROL OF PIPELINES. A pipeline subject to
- 8 the provisions of this chapter not exempt under Section 111.003 [of
- 9 this code], which is used in connection with the business of
- 10 purchasing or purchasing and selling crude petroleum, or in the
- 11 business of transporting coal, carbon dioxide, [ex] hydrogen,
- 12 <u>feedstock</u> for carbon gasification, the products of carbon
- 13 gasification, or the derivative products of carbon gasification in
- 14 whatever form by pipeline for hire in Texas, shall be operated as a
- 15 common carrier and shall be subject to the jurisdiction of the
- 16 commission.
- SECTION 3. This Act takes effect September 1, 2007.
