- Sec. 285.302. COMPLIANCE BY NONPROFIT CORPORATION WITH
- 14 CERTAIN LAWS. A nonprofit corporation created or formed under this
- subchapter or other law by a hospital district that is created under
- 16 general or special law shall comply with Chapter 2258, Government
- 17 Code, in the same manner and to the same extent that the hospital
- 18 district that created or formed the corporation is required to
- 19 comply with that chapter.
- SECTION 5. This Act takes effect immediately if it receives
- 21 a vote of two-thirds of all the members elected to each house, as
- 22 provided by Section 39, Article III, Texas Constitution. If this
- 23 Act does not receive the vote necessary for immediate effect, this
- 24 Act takes effect September 1, 2007.
