2 relating to authorizing the lease or conveyance of certain real

- 3 property owned by Amarillo College.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. DEFINITION. In this Act, "college" means
- 6 Amarıllo College.
- 7 SECTION 2. REAL PROPERTY DESCRIPTION. This Act applies to
- 8 the real property that is the subject of the Special Warranty Deed
- 9 appearing in Volume 3231, Pages 40-42, of the Deed Records of Potter
- 10 County, Texas, and is described as follows:
- Any and all real property, and all improvements thereof or
- 12 thereon, owned by Amarillo College in Potter County, Texas, in
- 13 Sections 27, 28, 39, and 40, all in Block 2 of the Adams, Beaty and
- 14 Moulton Survey, Potter County, Texas, said tract being
- 15 approximately 1,500 acres, more or less.
- 16 SECTION 3. AUTHORIZATION FOR LEASE OR CONVEYANCE.
- Notwithstanding any other law, on or after September 1, 2007, the
- 18 college, without limitations or conditions except those conditions
- 19 described by Section 4 of this Act, may lease or convey the real
- 20 property described by Section 2 of this Act or any portion of that
- 21 real property to any other party.
- 22 SECTION 4. CONDITIONS OF LEASE OR CONVEYANCE. (a) Cash
- 23 consideration received under a lease of or in a conveyance of the
- 24 property described by Section 2 of this Act may be used only to

- 1 accomplish a state public purpose, including furthering the
- 2 educational purposes of the college.
- 3 (b) If the college leases or conveys the real property
- 4 described by Section 2 of this Act for consideration other than
- 5 cash, the college shall enter into an agreement with the party to
- 6 whom the real property is being leased or conveyed that:
- 7 (1) requires the party to whom the real property is
- 8 leased or conveyed to use the property in a manner that serves a
- 9 state public purpose; and
- 10 (2) stipulates that possession or ownership of the
- 11 real property, as applicable, automatically reverts to the college
- 12 If the party to whom the real property is leased or conveyed uses
- 13 the property for a purpose other than one that serves a state public
- 14 purpose.
- 15 SECTION 5. RELEASE OF REVERSIONARY INTEREST. Simultaneous
- 16 to any conveyance described by Section 3 of this Act, the
- 17 reversionary interest held by the Texas State Technical College
- 18 System and established under Chapter 481, Acts of the 77th
- 19 Legislature, Regular Session, 2001, and the Special Warranty Deed
- 20 appearing in Volume 3231, Pages 40-42, of the Deed Records of Potter
- 21 County, Texas, is released only as to the real property conveyed or
- 22 leased.
- 23 SECTION 6. EFFECTIVE DATE. This Act takes effect
- 24 immediately if it receives a vote of two-thirds of all the members
- elected to each house, as provided by Section 39, Article III, Texas
- 26 Constitution. If this Act does not receive the vote necessary for
- 27 immediate effect, this Act takes effect September 1, 2007.
