

1 AN ACT

2 relating to an exemption from tuition and fees at public
3 institutions of higher education for children of certain volunteer
4 peace officers who are killed or disabled in the line of duty.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. The heading to Section 54.204, Education Code,
7 is amended to read as follows:

8 Sec. 54.204. CHILDREN OF DISABLED FIREFIGHTERS [~~FIREMEN~~]
9 AND LAW ENFORCEMENT [~~PEACE~~] OFFICERS.

10 SECTION 2. Sections 54.204(a), (b), (g), and (h), Education
11 Code, are amended to read as follows:

12 (a) In this section:

13 (1) "Eligible firefighter or law enforcement officer
14 [~~employee~~]" means:

15 (A) a full-paid or volunteer firefighter;

16 (B) [~~or~~] a full-paid or volunteer municipal,
17 county, or state peace officer, including [~~or a custodial employee~~
18 ~~of the Texas Department of Corrections, or~~] a game warden; or

19 (C) a custodial officer of the Texas Department
20 of Criminal Justice.

21 (2) "Disability" means inability to engage in any
22 substantial gainful activity by reason of a a [~~any~~] medically
23 determinable physical or mental impairment that [~~which~~] can be
24 expected to result in death or to be of long-continued and

1 indefinite duration. A person is [~~An individual shall~~] not [~~be~~]
2 considered to be under a disability unless the person provides any
3 [~~he furnishes such~~] proof of the [~~its~~] existence of the disability
4 as may be required.

5 (b) The governing board of each institution of higher
6 education shall exempt from the payment of all dues, fees, and
7 charges any person whose parent is an eligible firefighter or law
8 enforcement officer [~~employee~~] who has suffered an injury,
9 resulting in death or disability, sustained in the line of duty
10 according to the regulations and criteria then in effect governing
11 the department or agency in which the eligible firefighter or law
12 enforcement officer volunteered or [~~he~~] was employed. The
13 exemption does not apply to general property deposits or to fees or
14 charges for lodging, board, or clothing.

15 (g) An eligible firefighter or law enforcement officer
16 [~~employee~~] whose injury results in a disability shall submit to a
17 physical examination by a physician designated by the United States
18 Social Security Administration to conduct physical examinations
19 and to make disability reports to the Social Security
20 Administration. If the physician decides the injury received has
21 resulted in a disability, the physician [~~he~~] shall certify that
22 [~~this~~] fact to the head of the department in which the eligible
23 firefighter or law enforcement officer volunteers or is employed
24 [~~employs the employee~~].

25 (h) The head of the department in which the eligible
26 firefighter or law enforcement officer volunteered or was employed
27 [~~the eligible employee~~] at the time the firefighter or law

1 enforcement officer [~~he~~] sustained the injury shall file a
2 certificate with the Texas Higher Education Coordinating Board[~~r~~
3 ~~Texas College and University System,~~] on a form prepared by the
4 board for the purpose. The head of the department shall attach the
5 certificate of the examining physician if an examination is
6 required by Subsection (g) of this section. A copy of the
7 certificate on file with the coordinating board is sufficient
8 evidence for the institution to grant the exemption.

9 SECTION 3. The change in law made by this Act applies
10 beginning with dues, fees, and charges imposed by a public
11 institution of higher education for the 2007 fall semester. Dues,
12 fees, and charges imposed in a semester or session before the 2007
13 fall semester are governed by the applicable law in effect before
14 the effective date of this Act, and that law is continued in effect
15 for that purpose.

16 SECTION 4. This Act takes effect immediately if it receives
17 a vote of two-thirds of all the members elected to each house, as
18 provided by Section 39, Article III, Texas Constitution. If this
19 Act does not receive the vote necessary for immediate effect, this
20 Act takes effect September 1, 2007.
