10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 8242.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the board of directors of the
13	district.
14	(2) "Commission" means the Texas Commission on
15	Environmental Quality or its successors.
16	(3) "Director" means a member of the board.
17	(4) "District" means Booth Ranch Municipal Utility
18	District of Fort Bend County, Texas.
19	Sec. 8242.002. NATURE OF DISTRICT. Booth Ranch Municipal
20	Utility District of Fort Bend County, Texas, is created as a
21	municipal utility district created under and essential to
22	accomplish the purposes of Section 59, Article XVI, Texas
23	Constitution.
24	Sec. 8242.003. CONFIRMATION ELECTION REQUIRED. The board

- 3 Sec. 8242.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE.
- 4 (a) All land and other property included in the district will
- 5 benefit from the improvements and services to be provided by the
- 6 district.
- 7 (b) The district is created to accomplish the purposes of a
- 8 municipal utility district as provided by general law.
- 9 Sec. 8242.005. INITIAL DISTRICT TERRITORY. (a) The
- 10 <u>district is initially composed of territory described by Section 2</u>
- of the Act creating this chapter.
- 12 (b) The boundaries and field notes of the district form a
- 13 closure. A mistake in the field notes or in copying the field notes
- 14 in the legislative process does not in any way affect the
- 15 <u>district's:</u>
- (1) organization, existence, or validity;
- 17 (2) right to issue any type of bond for the purposes
- 18 for which the district is created or to pay the principal of and
- 19 interest on a bond;

- 2 election date in May of each even-numbered year, the appropriate
- 3 number of directors shall be elected.
- 4 Sec. 8242.053. INITIAL DIRECTORS. (a) The initial board
- 5 shall be appointed by the commission upon petition of any landowner
- 6 in the district.
- 7 (b) Unless otherwise agreed, the directors shall decide the
- 8 initial terms of office by lot, with a simple majority of directors
- 9 serving until the second succeeding directors election and the

- 20 Article XVI, Texas Constitution.
- 21 Sec. 8242.103. MUNICIPAL CONSENT ORDINANCES OR
- 22 RESOLUTIONS. (a) Subject to the limitations of Section 54.016,
- 23 Water Code, the district shall comply with all applicable
- 24 requirements of any ordinance or resolution adopted by the
- 25 governing body of the municipality that consents to the creation of
- 26 the district or to the inclusion of lands within the district.

- 9 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
- 10 Sec. 8242.151. ELECTIONS REGARDING TAXES OR BONDS.
- 11 (a) The district may issue, without an election, bonds and other
- 12 obligations secured by revenues or contract payments from any
- 13 lawful sources other than ad valorem taxation.
- 14 (b) The district must hold an election in the manner
- provided by Chapters 49 and 54, Water Code, to obtain voter approval
- 16 before the district may impose an operation and maintenance tax or
- issue bonds payable from ad valorem taxes.
- 18 Sec. 8242.152. OPERATION AND MAINTENANCE TAX. (a) If
- 19 authorized at an election held in accordance with Section 8242.151,
- 20 the district may impose an operation and maintenance tax on taxable
- 21 property in the district in accordance with the provisions of
- 22 Section 49.107, Water Code.
- (b) The board shall determine the tax rate. The rate may not
- 24 exceed the rate approved at the election.

- SUBCHAPTER E. BONDS OR OTHER OBLIGATIONS
- 27 Sec. 8242.201. OBLIGATIONS. The district may issue bonds,

- 1 notes, or other obligations payable in whole or in part from ad
- 2 valorem taxes, impact fees, revenues, grants, or other district
- 3 money, or any combination of those sources, to pay for any
- 4 <u>authorized district purpose.</u>
- 5 Sec. 8242.202. TAXES FOR BONDS. At the time bonds payable
- 6 <u>in whole or in part from ad valorem taxes are issued:</u>
- 7 (1) the board shall impose a continuing direct annual
- 8 ad valorem tax, without limit as to rate or amount, for each year
- 9 that all or part of the bonds are outstanding; and
- 10 (2) the district annually shall impose an ad valorem
- 11 tax on all taxable property in the district in an amount sufficient
- 12 <u>to:</u>
- 13 (A) pay the interest on the bonds as the interest
- 14 becomes due;
- 15 (B) create a sinking fund for the payment of the
- 16 principal of the bonds when due or the redemption price at any
- 17 <u>earlier required redemption date; and</u>
- 18 (C) pay the expenses of imposing the taxes.

- 26 SECTION 3. The legislature finds that:
- 27 (1) proper and legal notice of the intention to

- 1 introduce this Act, setting forth the general substance of this
- 2 Act, has been published as provided by law, and the notice and a
- 3 copy of this Act have been furnished to all persons, agencies,
- 4 officials, or entities to which they are required to be furnished by
- 5 the constitution and laws of this state, including the governor,
- 6 who has submitted the notice and Act to the Texas Commission on
- 7 Environmental Quality;
- 8 (2) the Texas Commission on Environmental Quality has
- 9 filed its recommendations relating to this Act with the governor,
- 10 the lieutenant governor, and the speaker of the house of
- 11 representatives within the required time;
- 12 (3) the general law relating to consent by political
- 13 subdivisions to the creation of districts with conservation and
- 14 reclamation powers and the inclusion of land in those districts has
- 15 been complied with; and
- 16 (4) all requirements of the constitution and laws of
- 17 this state and the rules and procedures of the legislature with
- 18 respect to the notice, introduction, and passage of this Act have
- 19 been fulfilled and accomplished.
- 20 SECTION 4. The legislature finds and declares that the
- 21 Booth Ranch Municipal Utility District of Fort Bend County, Texas,
- 22 will not be officially created until passage of a confirmation
- 23 election, and that securing consent by political subdivisions to
- 24 the creation of the district prior to the introduction or passage of
- 25 this Act is impractical due to the uncertainties of the legislative
- 26 process, and that the constitutional requirement for compliance by
- 27 the district with the provisions of the general laws now in effect



- 1 relating to the consent by political subdivisions to the creation
- 2 and inclusion of land within the district will be met and satisfied
- 3 if such consent is secured prior to the date and hour of canvassing
- 4 the returns and declaring the results of such confirmation
- 5 election.
- 6 SECTION 5. This Act takes effect immediately if it receives
- 7 a vote of two-thirds of all the members elected to each house, as
- 8 provided by Section 39, Article III, Texas Constitution. If this
- 9 Act does not receive the vote necessary for immediate effect, this
- 10 Act takes effect September 1, 2007.
