

1 AN ACT

2 relating to funding for, and benefits provided under, the Teacher  
3 Retirement System of Texas.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 825.402, Government Code, is amended to  
6 read as follows:

7 Sec. 825.402. RATE OF MEMBER CONTRIBUTIONS. (a) The rate  
8 of contributions for each member of the retirement system is:

9 (1) five percent of the member's annual compensation  
10 or \$180, whichever is less, for service rendered after August 31,  
11 1937, and before September 1, 1957;

12 (2) six percent of the first \$8,400 of the member's  
13 annual compensation for service rendered after August 31, 1957, and  
14 before September 1, 1969;

15 (3) six percent of the member's annual compensation  
16 for service rendered after August 31, 1969, and before the first day  
17 of the 1977-78 school year;

18 (4) 6.65 percent of the member's annual compensation  
19 for service rendered after the last day of the period described by  
20 Subdivision (3) and before September 1, 1985; and

21 (5) 6.4 percent of the member's annual compensation  
22 for service rendered after August 31, 1985, subject to Subsection  
23 (b).

24 (b) Subject to Subsection (c), the board of trustees may by

1 order require that the rate of contributions for each member of the  
2 retirement system under Subsection (a) is increased to not more  
3 than 6.58 percent of the member's annual compensation for service  
4 rendered after the date of the order if:

5 (1) the legislature by law requires or authorizes the  
6 board of trustees to pay a supplemental payment to specified  
7 annuitants; and

8 (2) the board of trustees finds, as of the time the  
9 payment is to be made, that after the payment is made the  
10 amortization period for the unfunded actuarial liabilities of the  
11 retirement system would exceed 30 years by one or more years.

12 (c) Notwithstanding any other law, the board of trustees may  
13 not make a supplemental payment required or authorized by the  
14 legislature by law, and may not impose an increase in the rate of  
15 contributions under Subsection (b), if the board of trustees finds  
16 that after making the payment and imposing the increase the  
17 amortization period for the unfunded actuarial liabilities of the  
18 retirement system would exceed 30 years by one or more years.

19 (d) Notwithstanding any other law, the board of trustees may  
20 delay making a supplemental payment required or authorized by the  
21 legislature by law as necessary to make the determinations required  
22 under Subsections (b) and (c).

23 SECTION 2. Section 825.404, Government Code, is amended by  
24 amending Subsection (a) and adding Subsection (a-1) to read as  
25 follows:

26 (a) During each fiscal year, the state shall contribute to  
27 the retirement system an amount equal to at least six and not more

1 than 10 percent of the aggregate annual compensation of all members  
2 of the retirement system during that fiscal year. The amount of the  
3 state contribution made under this section may not be less than the  
4 amount contributed by members during that fiscal year in accordance  
5 with Section 825.402.

6 (a-1) During each fiscal year of the state fiscal biennium  
7 beginning September 1, 2007, the state shall contribute to the  
8 retirement system an amount equal to 6.58 of the aggregate annual  
9 compensation of all members of the retirement system during that  
10 fiscal year. This subsection expires September 1, 2009.

11 SECTION 3. Subsection (e), Section 825.4092, Government  
12 Code, is amended to read as follows:

13 (e) The amounts required to be paid under Subsections (b)  
14 and (c) are not required to be paid by a reporting employer for a  
15 retiree who retired from [~~was reported under~~] the retirement system  
16 [~~rules in effect for the report month of January 2005 by:~~

17 [~~(1) that reporting employer, or~~

18 [~~(2) another employer, if both employers are school~~  
19 ~~districts that consolidated into a consolidated school district on~~  
20 ~~or~~] before September 1, 2005.

21 SECTION 4. Subsection (b), Section 1575.204, Insurance  
22 Code, is amended to read as follows:

23 (b) Each state fiscal year, each employer who reports to the  
24 retirement system under Section 824.6022, Government Code, the  
25 employment of a retiree who is enrolled in the group program shall  
26 contribute to the fund the difference, if any, between the  
27 contribution amount that the reported retiree is required to pay

1 for the retiree and any enrolled dependents to participate in the  
2 group program and the full cost of the retiree's and enrolled  
3 dependents' participation in the group program, as determined by  
4 the trustee. The amounts required to be paid under this subsection  
5 are not required to be paid by a reporting employer for a retiree  
6 who retired from the [~~was reported by that employer under~~  
7 retirement system before September 1, [~~rules in effect for the~~  
8 ~~report month of January~~] 2005.

9 SECTION 5. (a) The Teacher Retirement System of Texas  
10 shall make a one-time supplemental payment of a retirement or death  
11 benefit, as provided by this section.

12 (b) The supplemental payment is payable not later than  
13 September 2007 and, to the extent practicable, on a date or dates  
14 that coincide with the regular annuity payment payable to each  
15 eligible annuitant.

16 (c) The amount of the supplemental payment is equal to the  
17 lesser of:

18 (1) the gross amount of the regular annuity payment to  
19 which the eligible annuitant is otherwise entitled for the month of  
20 August 2007; or

21 (2) \$2,400.

22 (d) The supplemental payment is payable without regard to  
23 any forfeiture of benefits under Section 824.601, Government Code.  
24 The Teacher Retirement System of Texas shall make applicable tax  
25 withholding and other legally required deductions before  
26 disbursing the supplemental payment. A supplemental payment under  
27 this section is in addition to and not in lieu of the regular

1 monthly annuity payment to which the eligible annuitant is  
2 otherwise entitled.

3 (e) Subject to Subsection (f) of this section, to be  
4 eligible for the supplemental payment, a person must be, for the  
5 month of August 2007, and disregarding any forfeiture of benefits  
6 under Section 824.601, Government Code, an annuitant eligible to  
7 receive:

8 (1) a standard retirement annuity payment;

9 (2) an optional retirement annuity payment as either a  
10 retiree or beneficiary;

11 (3) a life annuity payment under Subdivision (4),  
12 Subsection (a), Section 824.402, Government Code;

13 (4) an annuity for a guaranteed period of 60 months  
14 under Subdivision (3), Subsection (a), Section 824.402, Government  
15 Code; or

16 (5) an alternate payee annuity payment under Section  
17 804.005, Government Code.

18 (f) If the annuitant is a retiree or a beneficiary under an  
19 optional retirement payment plan, to be eligible for the  
20 supplemental payment, the effective date of the retirement of the  
21 member of the Teacher Retirement System of Texas must have been on  
22 or before December 31, 2006. If the annuitant is a beneficiary  
23 under Subdivision (3) or (4), Subsection (a), Section 824.402,  
24 Government Code, to be eligible for the supplemental payment, the  
25 date of death of the member of the retirement system must have been  
26 on or before December 31, 2006. The supplemental payment shall be  
27 made to an alternate payee who is an annuitant under Section

1 804.005, Government Code, only if the annuity payment to the  
2 alternate payee commenced on or before December 31, 2006. The  
3 supplemental payment is in addition to the guaranteed number of  
4 payments under Subdivision (3), Subsection (a), Section 824.402,  
5 Government Code, Subdivision (3) or (4), Subsection (c), Section  
6 824.204, Government Code, or Subdivision (3) or (4), Subsection  
7 (c), Section 824.308, Government Code, and may not be counted as one  
8 of the guaranteed monthly payments.

9 (g) The supplemental payment does not apply to payments  
10 under:

11 (1) Subsection (a), Section 824.304, Government Code,  
12 relating to disability retirees with less than 10 years of service  
13 credit;

14 (2) Subsection (b), Section 824.804, Government Code,  
15 relating to participants in the deferred retirement option plan  
16 with regard to payments from their deferred retirement option plan  
17 accounts;

18 (3) Subsection (a), Section 824.501, Government Code,  
19 relating to retiree survivor beneficiaries who receive a survivor  
20 annuity in an amount fixed by statute; or

21 (4) Subsection (a), Section 824.404, Government Code,  
22 relating to active member survivor beneficiaries who receive a  
23 survivor annuity in an amount fixed by statute.

24 (h) Except as provided by this section, the board of  
25 trustees of the Teacher Retirement System of Texas shall determine  
26 the eligibility for and the amount and timing of a supplemental  
27 payment and the manner in which the payment is made.

1           SECTION 6. Subsection (a), Section 825.404, Government  
2 Code, as amended by this Act, applies beginning with the fiscal year  
3 that begins September 1, 2007.

4           SECTION 7. Section 825.4092, Government Code, as amended by  
5 this Act, applies only to an employer contribution required to be  
6 made under that section on or after September 1, 2007. An employer  
7 contribution required to be made before September 1, 2007, is  
8 governed by the law as it existed at the time the contribution was  
9 required to be made, and that law is continued in effect for that  
10 purpose.

11           SECTION 8. This Act takes effect September 1, 2007.
