3 recognize Andrew C. Solomon, who has been elected student
4 government president of The University of Texas at Austin for the
5 2007-2008 school year; and

6 WHEREAS, A junior in the Plan II Honors Liberal Arts program,
7 Andrew arrived at the university already with stellar credentials;
8 in high school he had served four years as a class officer, had been
9 a varsity athlete, had served as president of the National Honor
10 Society, had performed in a University Interscholastic League One
11 Act Play, and had participated in many other activities; and

12 WHEREAS, Since his arrival at the university, Andrew has been
13 a vital part of student life on campus; he took part in the Freshman
14 Leadership Organization, is a member of Sigma Alpha Epsilon
15 Fraternity, and has served in student government as a liberal arts

18 and a Robert C. Byrd Scholar; and

22 work, commitment, and talent have led him to this position of
23 leadership, and he is truly deserving of recognition for his many
