Update on House Bill 2, relating to the regulation of abortion procedures, providers, and facilities

On October 28th, District Judge Lee Yeakel, United States District Court for the Western District of Texas, ruled House Bill 2, the special session abortion bill, unconstitutional. Specifically citing requirements for doctors who perform an abortion to have admitting privileges at area hospitals, Judge Yeakel held that the provision in the bill violates the rights of abortion doctors to do what they think is best for their patients and would unreasonably restrict a woman's access to abortion clinics.

Three days later, on October 31st, the U.S. 5th Circuit Court of Appeals reversed part of Judge Yeakel's ruling, meaning those provisions of H.B. 2 can now take effect immediately. The appellate court lifted the permanent injunction placed on the abortion regulations by the lower court, arguing that the state was likely to succeed in its legal arguments.

In the state's request for a stay of Yeakel's Monday ruling, attorneys wrote that the district court took an "extraordinary step" by ruling that the provisions caused an undue burden on women seeking abortion, as 90 percent of patients would still be able to receive an abortion within 100 miles of their residence. The state called the move "so aggressive that it ignores those concessions and sweeps more broadly than even the plaintiffs were willing to argue."

The Attorney General 's office will continue its appeal, arguing that the provision will protect the life of the unborn, as well as all women throughout the state. My office will continue to closely follow these events as they proceed along the appellate procedure.

Attention: Waller County Residents

In November of last year, Electro Purification filed an application with Bluebonnet Groundwater Conservation District to drill 7 wells in Waller County.

A preliminary hearing was held in the Electro Purification case on October 28 to establish jurisdiction, name the parties, and establish a procedural schedule. My office attended this hearing and will make our best effort to attend all subsequent hearings.

Parties were preliminary established during this hearing, but the administrative law judge is leaving the record open until at least November 20 so that parties have time to submit proper resolutions.
