On February 9th, Speaker of the House, Joe Straus, named committees for members of the Texas House. The Speaker assigned Representative Bailes to three committees.

(1) The House Committee on Economic & Small Business Development which focuses on topics such as workforce training, commerce, trade, manufacturing, supporting small businesses, and job creation. As a business owner, Representative Bailes clearly understands the importance of small business and economic development in our area. This committee will provide an excellent opportunity for him to impact legislation which will benefit local citizens and our area in general.

(2) The House Committee on Land & Resource Management addresses the issues of annexation and zoning, the management of public lands, the power of eminent domain, and works closely with the General Land Office.

As HD18 grows we will see more legislation which will impact our area. Many of the issues Representative Bailes is currently working on tie directly to private property rights, annexation and zoning. This assignment is an excellent fit for issues we face in HD 18.

(3) The House Committee on Rules & Resolutions is a procedural committee that does not hear bills, but instead, has jurisdiction over the Rules of Procedure in the House of Representatives and all proposed amendments as well as Joint Rules of the House and Senate.

Representative Bailes' strong leadership skills will be an asset on these committees. He looks forward to the work ahead and bringing about positive legislation that will support and protect HD 18 and the entire state of Texas.



#### LEGISLATIVE UPDATE: Legislation Filed by Representative Bailes:

- **HB1028** Relating to the designation of Farm-to-Market Road 2666 in San Jacinto Co. as the Josey Scott Memorial Highway.
- **HB1469** Relating to qualifications for certain teachers employed by open-enrollment charter schools. **HB1479** — Relating to the small-sized district under the Foundation School Program.

#### Joint and Co-Authored Legislation:

**HB 435 by Representative Ken King** — Relating to the application of certain laws to and liability for certain actions of volunteer emergency services personnel licensed to carry a handgun.

- **HB 1290 by Representative Kevin Roberts** Relating to the required repeal of a state agency rule before adoption of a new state agency rule.
- HB 1390 by Representative Trent Ashby Relating to the small-sized district under the Foundation School Program.

# A Quick Glimpse...

### Bailes Joins fellow Legislators on Handgun Legislation

Representative Bailes joined his colleagues Ken King and Drew Springer in sponsoring HB 435. This legislation addresses volunteer emergency services personnel (volunteer firefighters and emergency medical services volunteers) who are legally carrying a handgun.

This bill would provide protection to such volunteer personnel for the purpose of carrying handguns while on duty.

### Equitable School Funding Bill

For more than 40 years, small school districts have been penalized with less funding simply because of their size. Representative Bailes knows this is wrong.

After reaching out to the local Superintendents and school board members in HD 18 concerning this issue he filed HB 1479. This legislation addresses equitable school funding and benefits more than half of the school districts in HD 18. To highlight the importance of this issue, five fellow legislators have filed similar bills.

Representative Bailes looks forward to working with his colleagues to get this important legislation passed.

# Local Open-Enrollment Charter School Bill to Support Vocational Ed.

HB 1469, which applies to Local Open-Enrollment Charter Schools, was recently filed by Representative Bailes. As a strong supporter of vocational education he believes career and vocational training is instrumental in preparing our students for the work force.

Gulf Coast Trades Center, located outside of New Waverly in Walker County, is an open-enrollment charter school.

This bill would allow schools such as Gulf Coast Trades Center to employ individuals with highly skilled trades experience as teachers for noncore and academic career and technical education courses, waiving the standard requirement of a baccalaureate degree.

# A Strong Voice for HD18 through Republican Rural Caucus

Understanding that a strong, unified voice is more effective for our rural area than going it alone, soon after his swearing in Representative Bailes joined the Republican Rural Caucus.

He was recently elected by his peers to serve as the Caucus's Vice Chairman, a position which will allow him a stronger voice for HD 18.

# Texas Association of School Administrators

At the end of January, the Texas Association of School Administrators (TASA) held their annual Midwinter Conference in Austin.

Rep. Bailes was grateful for the opportunity to share a few words at the conference regarding his thoughts and hopes for the future of public education. This included discussion on a fair, locally controlled accountability system as well as equitable school funding.

On December 28, 2016, Texas Army National Guard Chief Warrant Officer II Lucas Lowe of Hardin, Texas—a resident of HD18, passed away during a training flight when the Apache Helicopter he was flying in crashed into Galveston Bay.

On February 7th Representative Bailes honored the life of Officer Lowe by introducing and reading a memorial resolution on the floor of the House of Representatives. The resolution was unanimously adopted by all 150 legislators.

Family members and close family friends, Dr. Rachel Myers Childs, and Tommy and Jennilea Chase gathered at the Speaker's dias for the reading of the memorial.

Officer Lowe leaves behind his wife, Kami, sons, Clayton and Lance, daughter, Alysen, and twins on the way.

Also lost in the accident was Officer Dustin Mortenson. May God bless these fallen soldiers, their families and friends and all who serve our country.
