Highlights from the February 24, 2017 Board Meeting

Review of TBPG FY 2016 performance measures data. The Legislative Budget Board works with each state agency to establish Performance Measures and targets for attainment to measure each agency's performance on key tasks (timely review of applications, timely investigation and adjudication of complaints, dissemination of agency information to the public, etc.). Operations Manager, Molly Roman, reported TBPG's performance measure data for fiscal year 2016, from September 1, 2015-August 31, 2016. TBPG met or exceeded the targets for its performance on most of its measures.

The Appointed Board reviewed the following applications for P.G. license received from the following individuals:
