Do YOU HAVE UNCLAIMED PROPERTY?

What is Unclaimed Property?

Since 1963, Texas has required institutions, businesses and governmental entities to report to the state any personal property that has been unclaimed for up to five years, depending on the property in question. Unclaimed property can be abandoned assets.

Some examples:

- dividend, payroll or cashier's checks
- stocks, bonds or mutual fund accounts
- utility deposits and other refunds
- bank accounts and safe deposit box contents
- insurance proceeds
- mineral interest or royalty payments
- court deposits, trust funds or escrow accounts
- overpayments on insurance, utilities and other bills

Unclaimed property does not include real estate or vehicles.

There is no statute of limitations for unclaimed property. Funds reported will remain here indefinitely until returned to their rightful owner. Search the Comptroller's Unclaimed Property: https://claimittexas.org/

Campus Crime Stoppers is not only an anonymous reporting tool but is also a prevention method, helping to stop harmful, illegal, and suspicious activity on campuses without the fear of retaliation. Reports of weapons, drugs, bullying, stolen property, vandalism, dating violence, harassment, fighting, sexual misconduct, child abuse, and self safety risks (suicide) can all be reported by students which protects our youth and allows them to focus on their academics and personal success instead of fearing for their personal safety while in class.

Featured Fugitive



Carlos Rafael BENITEZ is charged with Aggravated Assault of a Public Servant against an Amarillo Police Department officer and Evading Arrest with a Vehicle stemming from a traffic stop on August 2, 2016.

BENITEZ was indicted in Potter County on October 12, 2016, and charged with the offenses. On March 8, 2017, multiple arrest warrants were issued in Potter County for BENITEZ for Bond Surrender (Original Offenses: Aggravated Assault Against a Public Servant and Evading Arrest or Detention with a Vehicle) after BENITEZ failed to appear in court.

BENITEZ has ties to Amarillo, Texas, and Donley County (including the town of Hedley), Dallas, Grand Prairie, and Arlington. He has a history of working in the tire service business.

John Wayne STONEHAM, a high-risk sex offender, was taken into custody on December 14, 2017, in Houston, Texas. Working off tip information, members of the U.S. Gulf Coast Violent Offender Fugitive Task Force, including DPS Special Agents, located and apprehended STONEHAM without incident.

In 1985, STONEHAM was convicted of Indecency with a Child-Sexual Contact after an incident in Grimes County involving a 13-year-old girl. He was discharged from TDCJ in April 1991. Later that same year, STONEHAM was convicted of multiple counts of Burglary of a Habitation with Intent to Commit Sexual Assault after two incidents in Pasadena, Texas, in which he broke into the residence of a 25-year-old female during the nighttime hours. STONEHAM subsequently was sentenced to 25 years in TDCJ prison.

STONEHAM had been wanted for parole violation since May 21, 2017, after he absconded from the Southeast Texas Transitional Center in Houston. In addition, he was also wanted out of Harris County for Failure to Comply with Sex Offender Registration Requirements. The arrest was the result of tip information received through Texas Crime Stoppers and a reward will be paid.
