## HOUSE CONCURRENT RESOLUTION

1 WHEREAS, The Texas Maritime Museum is celebrating a proud 2 milestone in 2007 when it marks the 20th anniversary of its 3 designation as the official State Maritime Museum of Texas; and 4 WHEREAS, Situated next to the harbor in Rockport, the museum was created to foster public interest in and understanding of the 5 6 rich maritime history of this state; that epic begins with the 7 Native Americans who made their home on the Texas coast and includes 8 the story of the French explorer La Salle, who established Fort St. 9 Louis near Lavaca Bay after missing his planned destination, the 10 Mississippi River; roughly a century and a half later, during the 11 Mexican War, Zachary Taylor launched several campaigns from the 12 Texas coast, and Palmito Creek, near Brownsville, witnessed the 13 last battle of the Civil War; during the 19th century, thousands of 14 settlers entered Texas by way of the coast, and today the Gulf 15 Intracoastal Waterway, whose Texas section stretches for 426 miles, 16 plays a major role in the economy of both Texas and the nation; and 17 WHEREAS, In fulfilling its mission, the Texas Maritime Museum 18 focuses on four broad areas: the exploration and settlement of the 19 Texas Gulf Coast; the history and development of Texas seaports, maritime communities, and maritime commerce; the history of the 20 Texas seafood and fishing industry; and the history and technology 21 22 of offshore petroleum production and transportation; and 23 WHEREAS, Since opening its doors to the public on July 1, 1989, the museum has captured the interest of countless visitors 24

- 1 with its wide-ranging exhibits, interactive displays, and
- 2 educational programming; highlights include a permanent exhibit
- 3 related to one of the most important shipwreck excavations in North
- 4 America, that of La Salle's flagship the Belle, which sank in
- 5 Matagorda Bay in 1686; also featured are historic maritime
- 6 photographs and fishing equipment, a life-size re-creation of the
- 7 bridge of a merchant ship, and a survival capsule such as offshore
- 8 oil-rig personnel would use in case of an emergency; and
- 9 WHEREAS, The Texas Maritime Museum pursues an active
- 10 collecting program and currently houses more than 2,000 objects,
- 11 most of which are on display and all of which are catalogued in a
- 12 searchable computer database; in 2003, the museum opened a new
- 13 addition, which has increased its exhibit space and which also
- serves as a functioning lighthouse; and
- WHEREAS, This outstanding museum received accreditation from
- 16 the American Association of Museums in 2005, becoming the 38th
- institution in Texas to be so recognized; and
- WHEREAS, Through their efforts to preserve a heritage of
- 19 immeasurable importance to the Lone Star State, the directors,
- 20 staff, and volunteers of the Texas Maritime Museum are performing a
- 21 significant public service, and their exceptional achievements are
- indeed to be commended; now, therefore, be it
- 23 RESOLVED, That the 80th Legislature of the State of Texas
- 24 hereby honor the Texas Maritime Museum on the occasion of its 20th
- 25 anniversary as the official State Maritime Museum of Texas and
- 26 extend to all associated with that institution sincere best wishes
- 27 for continued success; and, be it further
