

HOUSE CONCURRENT RESOLUTION

1 WHEREAS, The State of Texas continues to endure substantial
2 economic losses due to a prolonged drought that has crippled the
3 state for nearly two years; the loss of crops and livestock and
4 drought-induced fires have left the state's farmers and ranchers in
5 desperate need of continued federal assistance to offset the losses
6 suffered as a result of this natural disaster; and

7 WHEREAS, The drought has cost the state nearly \$2.5 billion
8 in total crop loss, more than \$1 billion of which is attributed to a
9 decrease in the cotton harvest, the state's number one cash crop; in
10 addition, the latest forecasts for 2006 show the state's wheat
11 harvest has decreased by more than 60 percent, corn production is
12 down by 26 percent, soybean production has decreased by more than 30
13 percent, and the state's production of peanuts and sorghum is
14 expected to be down by 40 percent; and

15 WHEREAS, An estimated \$1.6 billion in livestock losses, as
16 well as the rising cost of hay and supplemental feed, have forced
17 many ranchers to sell their cattle earlier than anticipated, which
18 will undoubtedly cause a decrease in the beef supply for several
19 years; all told, the total agricultural loss to the state stands at
20 more than \$4 billion; and

21 WHEREAS, This dire economic impact is shared by the
22 businesses that support the agriculture community, specifically
23 those in rural areas, where projections estimate the loss to be
24 nearly \$8 billion; the businesses affected include those that

1 provide equipment or machinery, supplies, feed, and professional
2 services such as veterinarians; and

3 WHEREAS, Adding insult to injury, the drought has resulted in
4 more than 21,000 fires, burning in excess of two million acres
5 between January and November, 2006, and contributing to the loss of
6 5,000 miles of fence and 5,000 cattle in the Panhandle alone; the
7 fires in the northern regions of the state have certainly
8 contributed to the diminution in hay production, and the United
9 States Department of Agriculture (USDA) estimates that 77 percent
10 of Texas' hay production was lost during the same period; and

11 WHEREAS, To alleviate this financial burden, the Texas
12 Department of Agriculture will administer a total of \$16.1 million
13 in assistance received from the USDA to eligible livestock
14 producers in 216 drought-stressed counties, but with more than \$12
15 billion in total economic loss as a direct result of the drought,
16 more assistance is needed; the devastation to crops and livestock
17 in the number two agricultural state in the nation has put a
18 financial strain on Texas farmers and ranchers, and it is
19 imperative that the federal government continue to assist the
20 individuals and families that have suffered during this time; now,
21 therefore, be it

22 RESOLVED, That the 80th Legislature of the State of Texas
23 hereby respectfully urge the Congress of the United States to
24 provide further drought relief to Texas; and, be it further

25 RESOLVED, That the Texas secretary of state forward official
26 copies of this resolution to the president of the United States, to
27 the speaker of the house of representatives and the president of the

1 senate of the United States Congress, and to all the members of the
 2 Texas delegation to the congress with the request that this
 3 resolution be officially entered in the Congressional Record as a
 4 memorial to the Congress of the United States of America.
