- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. DISTRICT TO BE DISSOLVED. The Aransas County
- 6 Conservation and Reclamation District shall be dissolved as
- 7 provided by this Act.
- 8 SECTION 2. TRANSFER OF ASSETS. The board of directors of
- 9 the Aransas County Conservation and Reclamation District shall pay
- or provide for the payment of any debts or liabilities incurred by
- the district and transfer all of the district's remaining assets to
- 12 the City of Rockport:
- 13 (1) not later than July 1, 2007, if this Act receives a
- 14 vote of two-thirds of all the members elected to each house, as
- provided by Section 39, Article III, Texas Constitution; or
- 16 (2) not later than October 1, 2007, if this Act does
- 17 not receive the vote necessary for immediate effect.
- 18 SECTION 3. DATE OF DISSOLUTION. (a) The Aransas County
- 19 Conservation and Reclamation District is dissolved on:
- 20 (1) July 1, 2007, if this Act receives a vote of
- 21 two-thirds of all the members elected to each house, as provided by
- 22 Section 39, Article III, Texas Constitution; or
- 23 (2) October 1, 2007, if this Act does not receive the
- 24 vote necessary for immediate effect.

- 1 (b) Any unsatisfied debt or legally established liability
- of the Aransas County Conservation and Reclamation District shall
- 3 be a charge on the assets transferred until paid.
- 4 SECTION 4. REPEALER. On the dissolution of the Aransas
- 5 County Conservation and Reclamation District, Chapter 9302,
- 6 Special District Local Laws Code, as added by Section 1.09, Chapter
- 7 729, Acts of the 79th Legislature, Regular Session, 2005, is
- 8 repealed.
- 9 SECTION 5. EFFECTIVE DATE. This Act takes effect
- immediately if it receives a vote of two-thirds of all the members
- elected to each house, as provided by Section 39, Article III, Texas
- 12 Constitution. If this Act does not receive the vote necessary for
- 13 immediate effect, this Act takes effect September 1, 2007.
