- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 552.029, Government Code, is amended to
- 6 read as follows:
- 7 Sec. 552.029. RIGHT OF ACCESS TO CERTAIN INFORMATION
- 8 RELATING TO INMATE OF DEPARTMENT OF CRIMINAL
- 9 JUSTICE. Notwithstanding Section 508.313 or 552.134, the
- 10 following information about an inmate who is confined in a facility
- 11 operated by or under a contract with the Texas Department of
- 12 Criminal Justice is subject to required disclosure under Section
- 13 552.021:
- 14 (1) the inmate's name, identification number, age,
- 15 birthplace, department photograph, physical description, or
- 16 general state of health or the nature of an injury to or critical
- 17 illness suffered by the inmate;
- 18 (2) the inmate's assigned unit or the date on which the
- 19 unit received the inmate, unless disclosure of the information
- 20 would violate federal law relating to the confidentiality of
- 21 substance abuse treatment:
- 22 (3) the offense for which the inmate was convicted or
- 23 the judgment and sentence for that offense;
- 24 (4) the county and court in which the inmate was

- 1 convicted:
- 2 (5) the inmate's earliest or latest possible release
- 3 dates;
- 4 (6) the inmate's parole date or earliest possible
- 5 parole date;
- 6 (7) any prior confinement of the inmate by the Texas
- 7 Department of Criminal Justice or its predecessor; or
- 8 (8) basic information regarding the death of an inmate
- 9 in custody, an incident involving the use of force, or an alleged
- 10 crime involving the inmate.
- 11 SECTION 2. This Act takes effect immediately if it receives
- 12 a vote of two-thirds of all the members elected to each house, as
- 13 provided by Section 39, Article III, Texas Constitution. If this
- 14 Act does not receive the vote necessary for immediate effect, this
- 15 Act takes effect September 1, 2005.
