<u>CHAPTER 1022</u> H.B. No. 984

1	AN ACT
2	relating to the care of elementary and secondary school students
3	with diabetes.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle H, Title 2, Health and Safety Code, is
6	amended by adding Chapter 168 to read as follows:
7	CHAPTER 168. CARE OF STUDENTS WITH DIABETES
8	Sec. 168.001. DEFINITIONS. In this chapter:
9	(1) "Diabetes management and treatment plan" means the
10	document required by Section 168.002.
11	(2) "Individualized health plan" means the document
12	required by Section 168.003.
13	(3) "Principal" includes the principal's designee.
14	(4) "School" means a public elementary or secondary
15	school. The term does not include an open-enrollment charter
16	school established under Subchapter D, Chapter 12, Education Code.
17	(5) "School employee" means a person employed by:
18	(A) a school;
19	(B) a local health department that assists a
20	school under this chapter; or
21	(C) another entity with which a school has
22	contracted to perform its duties under this chapter.
23	(6) "Unlicensed diabetes care assistant" means a
24	school employee who has successfully completed the training

1	required by Section 168.005.
2	Sec. 168.002. DIABETES MANAGEMENT AND TREATMENT PLAN. (a)
3	A diabetes management and treatment plan must be developed and
4	implemented for each student with diabetes who will seek care for
5	the student's diabetes while at school or while participating in a
6	school activity. The plan shall be developed by:
7	(1) the student's parent or guardian; and
8	(2) the physician responsible for the student's
9	<u>diabetes treatment.</u>
10	(b) A diabetes management and treatment plan must:
11	(1) identify the health care services the student may
12	<pre>receive at school;</pre>
13	(2) evaluate the student's ability to manage and level
14	of understanding of the student's diabetes; and
15	(3) be signed by the student's parent or guardian and
16	the physician responsible for the student's diabetes treatment.
17	(c) The parent or guardian of a student with diabetes who
18	seeks care for the student's diabetes while the student is at school
19	shall submit to the school a copy of the student's diabetes
20	management and treatment plan. The plan must be submitted to and
21	reviewed by the school:
22	(1) before or at the beginning of the school year;
23	(2) on enrollment of the student, if the student
24	enrolls in the school after the beginning of the school year; or
25	(3) as soon as practicable following a diagnosis of
26	diabetes for the student.
27	Sec. 168.003. INDIVIDUALIZED HEALTH PLAN. (a) An

- individualized health plan is a coordinated plan of care designed
 to meet the unique health care needs of a student with diabetes in
 the school setting.
- 4 (b) An individualized health plan must be developed for each student with diabetes who will seek care for diabetes while at 5 school or while participating in a school activity. The school 6 principal and the school nurse, if a school nurse is assigned to the 7 8 school, shall develop a student's individualized health plan in 9 collaboration with the student's parent or guardian and, to the extent practicable, the physician responsible for the student's 10 diabetes treatment and one or more of the student's teachers. 11
 - (c) A student's individualized health plan must incorporate components of the student's diabetes management and treatment plan, including the information required under Section 168.002(b). A school shall develop a student's individualized health plan on receiving the student's diabetes management and treatment plan.

- Sec. 168.004. UNLICENSED DIABETES CARE ASSISTANT. (a) At each school in which a student with diabetes is enrolled, the school principal shall:
- 20 <u>(1) seek school employees who are not health care</u>
 21 <u>professionals to serve as unlicensed diabetes care assistants and</u>
 22 <u>care for students with diabetes; and</u>
- (2) make efforts to ensure that the school has:
- 24 (A) at least one unlicensed diabetes care
- 25 assistant if a full-time nurse is assigned to the school; and
- 26 <u>(B) at least three unlicensed diabetes care</u>
 27 <u>assistants if a full-time nurse is not assigned to the school.</u>

1	(b) An unlicensed diabetes care assistant shall serve under
2	the supervision of the principal.
3	(c) A school employee may not be subject to any penalty or
4	disciplinary action for refusing to serve as an unlicensed diabetes
5	care assistant.
6	Sec. 168.005. TRAINING FOR UNLICENSED DIABETES CARE
7	ASSISTANT. (a) The Texas Diabetes Council shall develop
8	guidelines, with the assistance of the following entities, for the
9	training of unlicensed diabetes care assistants:
10	(1) the department's School Health Program;
11	(2) the American Diabetes Association;
12	(3) the Juvenile Diabetes Research Foundation
13	<pre>International;</pre>
14	(4) the American Association of Diabetes Educators;
15	(5) the Texas Nurses Association;
16	(6) the Texas School Nurse Organization; and
17	(7) the Texas Education Agency.
18	(b) If a school nurse is assigned to a campus, the school
19	nurse shall coordinate the training of school employees acting as
20	unlicensed diabetes care assistants.
21	(c) Training under this section must be provided by a health
22	care professional with expertise in the care of persons with
23	diabetes or by the school nurse. The training must be provided
24	before the beginning of the school year or as soon as practicable
25	following:
26	(1) the enrollment of a student with diabetes at a
27	campus that previously had no students with dishetes, or

1	(2) a diagnosis of diabetes for a student at a campus
2	that previously had no students with diabetes.
3	(d) The training must include instruction in:
4	(1) recognizing the symptoms of hypoglycemia and
5	hyperglycemia;
6	(2) understanding the proper action to take if the
7	blood glucose levels of a student with diabetes are outside the
8	target ranges indicated by the student's diabetes management and
9	treatment plan;
10	(3) understanding the details of a student's
11	individualized health plan;
12	(4) performing finger-sticks to check blood glucose
13	levels, checking urine ketone levels, and recording the results of
14	those checks;
15	(5) properly administering glucagon and insulin and
16	recording the results of the administration;
17	(6) recognizing complications that require seeking
18	emergency assistance; and
19	(7) understanding the recommended schedules and food
20	intake for meals and snacks for a student with diabetes, the effect
21	of physical activity on blood glucose levels, and the proper
22	actions to be taken if a student's schedule is disrupted.
23	(e) The school nurse or principal shall maintain a copy of
24	the training guidelines and any records associated with the
25	training.
26	Sec. 168.006. REQUIRED INFORMATION FOR CERTAIN EMPLOYEES.
27	A school district shall provide to each district employee who is

- 1 responsible for providing transportation for a student with
- 2 diabetes or supervising a student with diabetes during an
- 3 off-campus activity a one-page information sheet that:
- 4 (1) identifies the student who has diabetes;
- 5 (2) identifies potential emergencies that may occur as
- 6 a result of the student's diabetes and the appropriate responses to
- 5 such emergencies; and
- 8 (3) provides the telephone number of a contact person
- 9 in case of an emergency involving the student with diabetes.
- Sec. 168.007. REQUIRED CARE OF STUDENTS WITH DIABETES. (a)
- 11 If a school nurse is assigned to a campus and the nurse is
- 12 available, the nurse shall perform the tasks necessary to assist a
- 13 student with diabetes in accordance with the student's
- 14 individualized health plan. If a school nurse is not assigned to
- 15 the campus or a school nurse is not available, an unlicensed
- diabetes care assistant shall perform the tasks necessary to assist
- 17 the student with diabetes in accordance with the student's
- 18 individualized health plan and in compliance with any guidelines
- 19 provided during training under Section 168.005. An unlicensed
- 20 diabetes care assistant may perform the tasks provided by this
- 21 <u>subsection only if the parent or guardian of the student signs an</u>
- 22 agreement that:
- 23 (1) authorizes an unlicensed diabetes care assistant
- 24 to assist the student; and
- 25 (2) states that the parent or guardian understands
- 26 that an unlicensed diabetes care assistant is not liable for civil
- 27 <u>damages as provided by Section 168.009.</u>

1	(b) If a school nurse is not assigned to a campus:
2	(1) an unlicensed diabetes care assistant must have
3	access to an individual with expertise in the care of persons with
4	diabetes, such as a physician, a registered nurse, a certified
5	diabetes educator, or a licensed dietitian; or
6	(2) the principal must have access to the physician
7	responsible for the student's diabetes treatment.
8	(c) Each school shall adopt a procedure to ensure that a
9	school nurse or at least one unlicensed diabetes care assistant is
LO	present and available to provide the required care to a student with
11	diabetes during the regular school day.
L2	(d) A school district may not restrict the assignment of a
L3	student with diabetes to a particular campus on the basis that the
L 4	campus does not have the required unlicensed diabetes care
L5	assistants.
16	(e) An unlicensed diabetes care assistant who assists a
L7	student as provided by Subsection (a) in compliance with a
L8	student's individualized health plan:
19	(1) is not considered to be engaging in the practice of
20	professional or vocational nursing under Chapter 301, Occupations
21	Code, or other state law; and
22	(2) is exempt from any applicable state law or rule
23	that restricts the activities that may be performed by a person who
24	is not a health care professional.
25	(f) An unlicensed diabetes care assistant may exercise
26	reasonable judgment in deciding whether to contact a health care
27	provider in the event of a medical emergency involving a student

- 1 with diabetes. 2 Sec. 168.008. INDEPENDENT MONITORING AND TREATMENT. In 3 accordance with the student's individualized health plan, a school shall permit the student to attend to the management and care of the 4 student's diabetes, which may include: 5 6 (1) performing blood glucose level checks: 7 (2) administering insulin through the insulin 8 delivery system the student uses; 9 (3) treating hypoglycemia and hyperglycemia; 10 (4) possessing on the student's person at any time any supplies or equipment necessary to monitor and care for the 11 12 student's diabetes; and 13 (5) otherwise attending to the management and care of 14 the student's diabetes in the classroom, in any area of the school or school grounds, or at any school-related activity. 15 16 Sec. 168.009. IMMUNITY FROM DISCIPLINARY ACTION OR LIABILITY. (a) A school employee may not be subject to any 17 disciplinary proceeding, as defined by Section 22.0512(b), 18 19 Education Code, resulting from an action taken in compliance with 20 this subchapter. The requirements of this subchapter are 21 considered to involve the employee's judgment and discretion and 22 are not considered ministerial acts for purposes of immunity from 23 liability under Section 22.0511, Education Code. Nothing in the 24 subchapter shall be considered to limit the immunity from liability 25 afforded under Section 22.0511, Education Code. 26
 - (b) A school nurse is not responsible for and may not be subject to disciplinary action under Chapter 301, Occupations Code,

- 1 for actions performed by an unlicensed diabetes care assistant.
- 2 SECTION 2. Chapter 168, Health and Safety Code, as added by
- 3 this Act, applies beginning with the 2005-2006 school year.
- 4 SECTION 3. This Act takes effect immediately if it receives
- 5 a vote of two-thirds of all the members elected to each house, as
- 6 provided by Section 39, Article III, Texas Constitution. If this
- 7 Act does not receive the vote necessary for immediate effect, this
- 8 Act takes effect September 1, 2005.
