2 Legislative Reference Library in 1998, Sally Reynolds has allegedly

5 Austin whenever the legislature comes to town would seem to dismiss
6 any notion that she's permanently gone fishin'; and

7 WHEREAS, Mrs. Reynolds directed the Capitol's Legislative
8 Reference Library for 12 years, during which time she proved that
9 there is much more to the task of running a library than merely
10 shushing its patrons; initiating numerous positive and productive






