

HOUSE CONCURRENT RESOLUTION

1 WHEREAS, The well-being of the people of Texas depends on
2 economic prosperity throughout the state, and independent
3 businesses that employ Texans and contribute to local trade and
4 industry are important components of a healthy economy and a
5 successful future; and






