- 2 relating to the validation and confirmation of the boundaries and
- 3 acts of Dallas County Water Control and Improvement District No. 6.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. VALIDATION. (a) The following are validated 6 and confirmed in all respects:
- 7 (1) the boundaries of Dallas County Water Control and
- 8 Improvement District No. 6, as provided by Section 5 of this Act;
- 9 and
- 10 (2) any act or proceeding of the district, including
- 11 elections and annexations, not excepted by Subsection (b) of this
- 12 section and taken not more than five years before the effective date
- of this Act, effective as of the date on which the act or proceeding
- 14 occurred.
- 15 (b) This section does not apply to an act or proceeding that
- 16 is the subject of litigation pending on the effective date of this
- 17 Act or to an act that, under a statute of this state or the United
- 18 States, was a misdemeanor or a felony at the time the act occurred.
- 19 SECTION 2. DEFINITION. In this Act, "district" means
- 20 Dallas County Water Control and Improvement District No. 6.
- 21 SECTION 3. BOUNDARIES. (a) The district is composed of
- the territory described by Section 5 of this Act.
- 23 (b) The boundaries and field notes contained in Section 5 of
- 24 this Act form a closure. A mistake made in the field notes or in

- 1 copying the field notes in the legislative process does not affect:
- 2 (1) the organization, existence, or validity of the
- 3 district;
- 4 (2) the right of the district to impose taxes; or
- 5 (3) the legality or operation of the district board.
- 6 SECTION 4. FINDING OF BENEFIT. All of the land and other
- 7 property included within the boundaries of the district will be
- 8 benefited by the works and projects that are to be accomplished by
- 9 the district under the powers conferred by Section 59, Article XVI,
- 10 Texas Constitution. The district serves a public use and benefit.
- 11 SECTION 5. The district includes the following area:

- 9 SECTION 6. NO ADDITIONAL POWERS OR DUTIES; RETAIL WATER
- 10 UTILITY SERVICE. (a) This Act does not grant any additional
- 11 powers or duties to the district.
- 12 (b) The district may not provide additional retail water
- 13 utility service in the corporate boundaries of the City of Mesquite
- 14 other than the service provided on the effective date of this Act
- 15 without obtaining the city's consent.
- 16 SECTION 7. FINDINGS RELATED TO PROCEDURAL REQUIREMENTS.
- 17 The legislature finds that:
- 18 (1) the proper and legal notice of the intention to
- 19 introduce this Act, setting forth the general substance of this
- 20 Act, has been published as provided by law, and the notice and a
- 21 copy of this Act have been furnished to all persons to which they
- 22 are required to be furnished by the constitution and laws of this
- 23 state; and
- 24 (2) all requirements of the constitution and laws of
- 25 this state and rules and procedures of the legislature with respect
- 26 to the notice, introduction, and passage of this Act are fulfilled
- 27 and accomplished.
