WHEREAS, The Legislature of the State of Texas is pleased to 2 recognize the General Motors Arlington Assembly Plant on the 3 occasion of its 50th anniversary, which will be celebrated in 4 January of 2004; and 5 WHEREAS, Since January of 1954, when the plant first 6 assembled the Pontiac Chieftain, it has produced a total of 7.5 7 8 million vehicles; and WHEREAS, An innovative leader in the industry, the General .9 Motors Arlington Assembly Plant converted during the late 1990s 10. from assembling cars to assembling the 400 series pickup trucks and 11 such sports utility vehicles as the Chevrolet Suburban and the 12 Chevrolet Tahoe; it is the sole producer of the luxury sports 13 utility vehicle, the Cadillac Escalade; and 14 WHEREAS, By consistently upgrading its facilities, the plant 15 has always operated a state-of-the-art production site; a new 16 building for tire, wheel, and seat assembly was built in 1974; in 17 1988, it added a new building for a paint shop; and in 2000, a new 18 body shop building for the 800 series sports utility vehicles was 19. 20 also added; and WHEREAS, In tribute to its high standards of craftsmanship, 21 the assembly plant has been recognized with numerous awards, 22

including the Harbour Benchmark recognition for the full-size
