Your **Minimum Sales Goal** is your weekly sales*** average during the AEP (deducted for seasonality) x 13 weeks + 4.4% + \$500. MSG = ((AEP Savg (adj) x 13) + 4.4%) + \$500.

*If total retailer incentive payments exceed the allocated program budget, all payments will be reduced by an equal percentage in order to meet the total program budget. Drawing entries and drawing prizes will not be affected.

**Minimum Sales Goal for eligible retailers will never be less than \$1,000.

***Minimum sales goal does not include Mega Millions®, All or Nothing®, Powerball®, or Power Play®.

FREQUENTLY ASKED QUESTIONS

Q. Does my lottery license need to be renewed? If so, how do I do that?

A. Yes, state law (the Texas Lottery Act) requires that you renew your lottery license every two years, and the renewal application and renewal fee of \$15 must be submitted before your license expiration date.

You may complete your renewal online by visiting our website at txlottery.org/Retailers and registering on the Lottery Services Portal or you may complete and return the license renewal application mailed to you 60 days prior to the expiration date of your license.

Q. Who is responsible for the maintenance and repair of lottery equipment?

A. The retailer is responsible for keeping lottery equipment clean and for minor maintenance like changing paper and clearing jams. If your equipment is disabled or you are not sure how to fix the problem, please call the IGT Hotline at 800-458-0884 for support. The hotline is available 24 hours, 7 days a week. The hotline staff can often help retailers fix minor problems over the phone. Hotline staff can also dispatch service technicians to address more significant problems and provide repair and maintenance services.
