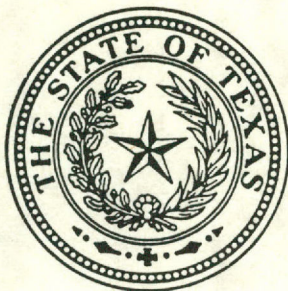

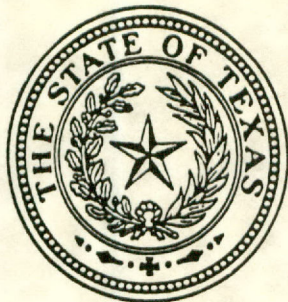

Dear Recipient:

The Interagency Council on Sex Offender Treatment is directed by the Legislature to:

"...establish and maintain a registry of individuals who provide mental health or medical services for rehabilitation of sex offenders...  
...develop procedures and eligibility requirements for registration...set a reasonable fee for registration ... annually...prepare a list of the treatment providers registered under this Act."

- Article 4413(51), Section 13 & 15, V.A.T.S.

The following is a supplement to the first edition of the Registry published in accordance with this law. Registered Sex Offender Treatment Providers meet the requirements established in the Rules (see 1st Edition). Individuals are listed by city; experience, training, individual and group therapy hours are listed as reported by the treatment provider.

A list of residential programs that treat sex offenders and have a registered Sex Offender Treatment Provider on site are included in the latter part of this document. Also, changes that have occurred to listings since the printing of the first edition are included.
