# Texas to Celebrate 9-1-1 Day Sept. 11

The Advisory Commission on State Emergency Communications (ACSEC) will celebrate 9-1-1 Day in Texas Monday, Sept. 11, beginning with a 9 a.m. ceremony on the state capitol grounds.

The program will include the proclamation of 9-1-1 Day, a brief overview of the State of Texas 9-1-1 program and observance of the day by local school children. In addition, outstanding Public Safety Telecommunicators will be honored and lifesaving 9-1-1 episodes recognized.

As mandated in 1987 by the Texas Legislature's House Bill 9-1-1, the Alamo Area Council of Governments, together with the other 23 planning commissions of the state, submitted its plan to ACSEC on schedule Sept. 1 for the operation of the Enhanced 9-1-1 emergency telephone service across the region.

# Alcohol & Drug Abuse Regional Institute to Open October 22

he 16th Annual Regional Institute on Alcohol and Drug Abuse, "Perspectives' 89," will run Sunday through Tuesday, Oct. 22-24, at the Plaza San Antonio, 555 South Alamo in downtown San Antonio.

Sponsoring the institute along with the Alamo Area Council of Governments are the Office for Substance Abuse Prevention (OSAP) of the Alcohol, Drug Abuse and Mental Health Administration, Our Lady of the Lake University and The University of Texas Health Science Center at San Antonio School of Nursing.

The institute will provide 14 clock hours of accredited training in effective programming for high-risk youth, medical research on addictions, beginning and advanced counseling skills and mental health issues related to chemical addiction. Although open to the general public, workshops are principally directed toward professionals in the fields of alcohol and drug abuse, social work, adult and juvenile probation, guidance and counseling, psychotherapy and law enforcement.

The program will commence Sunday morning with a featured presentation by Eric N. Goplerud, Ph.D., entitled, "The Leading Edge of Prevention." Later that day Goplerud, evaluation coordinator for the Office for Substance Abuse Prevention (OSAP), will offer practical suggestions for program directors, managers and monitors/evaluators or. developing evaluation components to show the effort, effectiveness and efficiency of programs seeking funding from private and governmental sources.

Presenting the conference keynote address at lunch on Tuesday, Oct. 24, will be Elaine M. Johnson, Ph.D., director of OSAP. Johnson will speak to the promise of community partnerships in prevention programming.

Workshops during the three days will deal with the assessment and treatment of victim behaviors, counseling the eating disorder client, risk reduction counseling regarding AIDS and fetal drug syndromes. Other sessions will be devoted to contemporary research in domestic violence, prevention education and alternatives for high-risk black youth, interventions with Hispanic high-risk youth and family effectiveness training.

The registration fee of \$80 includes all materials, brunch on Sunday, Oct. 22, and lunch on Tuesday, Oct. 24. Workshop assignments will be made on a first-come-first-served basis determined by registration receipt date. Pre-registration is strongly encouraged by Oct. 13. A limited number of reduced-fee registrations are available.

# Executive Committee Review: August 23, 1989

Executive Director Al J. Notzon III reported on items including two August workshops directed by AACOG on child abuse and substance abuse, a drug abuse briefing by President Bush and Drug Czar William Bennett at the White House attended by agency manager Martha Reyes and the upcoming Texas Association of Regional Councils Annual Conference to be held in San Antonio Sept. 27-30.

Recommendations accepted from the Budget & Workplan Committee included the approval of a FY 90 section 18 contract and subcontracts for rural transportation; authorization of subcontracts under the Office for Substance Abuse Prevention demonstration grant; consent to facilitate the decision making process involving artesian well J-21 and the Salado Creek Foundation; acceptance of a Texas Department of Human Services planning contract; and the re-allocation of \$10,000 of Title III-B funds to the Visiting Nurse Association/Supportive Services for the Elderly Program.

The Executive Committee then passed favorable

review on the following:

from the Bexar Senior Advisory Committee, an application for three vans submitted to UMTA through the State Department of Highways and Public Transportation by Senior Community Services, Inc.;

from the Regional Development & Review Committee, a City of Fredericksburg Market Square & Municipal Creeks Park development project for Texas Parks & Wildlife funding, as well as a consensus to proceed on phase 1 of a Kelly Air Force Base installation restoration program;

from the Criminal Justice Planning Committee, 11 grant projects seeking Victims of Crime Assistance (VOCA) funding from the State of Texas Criminal Justice Division for efforts involved in rape crisis and intervention, family sex abuse treatment and battered women's advocacy, among other issues; and

from the Human Resources Advisory Committee, 10 applications from organizations as The University of Texas Health Science Center at San Antonio, the Intercultural Development Research Association and Avance-San Antonio, Inc. requesting federal funding from the Departments of Health and Human Services and of Education for projects ranging from pediatric AIDS health care to computer-based education in Somerset, Texas.

Before adjourning, the Executive Committee passed a resolution endorsing the selection of San Antonio as the site of the 1990 Economic Summit, noting that its selection would be in full keeping with the tradition of holding the Summit in a city rich in historical legacy, resonant in cultural convergence and reminiscent of the vigilant aspiration for honor.

#### Texas Association of Regional Councils to Convene in San Antonio

The Texas Association of Regional Councils (TARC) will hold its 24th annual conference Wednesday through Saturday, Sept. 27-30, at the Marriott Rivercenter in downtown San Antonio, Texas.

With the conference theme of "regionalism & recovery," the program will focus on the role that councils of government play in leading Texas forward from a period of economic downturn in the 1980s to a future of opportunity, growth and stability in the 1990s.

On Wednesday, Sept. 27, the agenda opens with a technology workshop exploring the issues and considerations in mapping and locational addressing development, including data resources, the organization of projects and case studies of implementation. Other sessions for Thursday will be directed toward regional council economic development innovations, solid and hazardous waste, the AACOG/Bexar Metro 9-1-1 network and air quality.

Entertainment and special events for the three-day conference will begin Wednesday night with a fiesta and dance, continue with a spouse tour of the King William Historical District on Thursday and culminate with a gala

at Sea World of Texas Friday evening.
