#### NOVEMBER PERMITS

In November the State Securities Board issued permits for 136 issuers to sell \$122,056,263 in securities -- a \$24 Million gain over the same month last year.

Total dollar amount of securities applications processed for the first three months of the fiscal year was \$384,396,664. Total number of applications processed for the first three months of the fiscal year was 347.

#### LICENSE INFORMATION

During November a total of 136 examinations were administered to 122 applicants for licensing under The Texas Securities Act. This included 13 examinations on the Texas Securities Act, and 4 examinations on the Special Bond examination. There were 69.2% of the applicants who passed the general securities section on first attempt, 93.3% who passed the Texas Law portion on first attempt, and 50.0% who passed the Special Bond examination on first attempt.

#### CEASE PUBLICATION NOTICE

On November 7, 1972, the Commissioner ordered Corporation International De Juarez S. A. to cease publishing advertisements in the State of Texas since it had not registered any securities in the State of Texas nor had it registered as a securities dealer or investment adviser in the State of Texas. The Commissioner also found that the advertisement in question had not been filed in compliance with Section 22 of the Texas Securities Act and that it failed to disclose material facts necessary in order to make the representations made not misleading to purchasers and prospective purchasers.

#### ORDER REVOKING THE SECONDARY TRADING EXEMPTION OF SECTION 5.0 OF THE TEXAS SECURITIES ACT WITH RESPECT TO SECURITIES ISSUED BY SPENCE & GREEN CHEMICAL COMPANY

The Commissioner found from information available that he had reasonable cause to believe that the sale of securities of Spence & Green Chemical Company would tend to work a fraud and deceit upon any purchaser thereof. He therefore ordered that any secondary trading exemption that might be claimed under Section 5.0 of The Securities Act be revoked.

#### CONVICTIONS

James C. Rodgers, Sr. was convicted of the unlawful sale of unregistered securities on November 29, 1972, in the 167th District Court of Travis County, in Austin, Texas. The case involved the sale of securities of Scientific Engineering, Inc. which went bankrupt shortly after the securities were sold. The case involved the sale to John Robb Sutherland made in the spring of 1969 in which Sutherland testified that he had first approached Rodgers about purchasing the securities. Rodgers was sentenced to two years probation and was ordered to pay a fine of \$1,000.
