APRIL PERMITS

In April the State Securities Board issued permits for 77 issuers to sell \$138,102,108 in securities.

Total dollar amount of securities applications processed for the first eight months of this fiscal year was \$1,263,298,386 as compared to \$1,012,489,767 for the same period last year. Total number of applications processed for the first eight months was 810.

LICENSE INFORMATION

During April, a total of 131 examinations were administered to 128 applicants for licensing under the Texas Securities Act. This included 121 examinations on the Texas Securities Act, 5 examinations on the General Securities Principles and 6 examinations on the Special Bond Examination. There were 69.4% of the applicants who passed the Texas Law Portion, 40.0% of the applicants who passed the General Securities Portion, and 66.7% of the applicants who passed the Special Bond Examination.

RECEIVERSHIP

Trans-World Oil & Gas Corporation, Lara Corporation and Trans-World Energy Corporation, and their President, Ralph Ben Schoter, were placed in receivership pursuant to an Agreed Order entered in the 129th District Court of Harris County. Trans-World Energy Corporation, Lara Corporation, Schoter, and the corporate attorney, John E. Hawtrey, were also enjoined from committing further violations of the Texas Securities Act. Violations of the securities registration, dealer licensing and fraud provisions of the Texas Securities Act were alleged in the lawsuits, and were admitted by the corporations and their President. The three corporations sold approximately \$740,000 of securities in the last 18 months, largely to out-of-state investors.

CONVICTIONS

Chester Bert Koah was found guilty of the sale of unregistered securities in El Paso on April 7, 1977. Koah, who was extradicted from California for the trial was found guilty on one count of a three-count indictment which alleged that he had sold percentage interests in K.I.S. Research to an El Paso resident in violation of The Securities Act. The indictment also alleged that Koah engaged in the sale of securities without being registered as a securities dealer and for fraud in the sale of securities. Sentencing has not been set.

Larry Morgan, Ora Delbert Morgan and William H. Garrett, all officers of WPR, Incorporated, an Amarillo oil well company, pleaded guilty on April 11, 1977, in Wise County, Texas, to the sale of unregistered securities.

Larry Morgan and Ora Delbert Morgan were sentenced each to three years in the penitentiary. Garrett was sentenced to ten years in the penitentiary, which was probated conditioned upon Garrett's making partial restitution to investors of \$35,848.75. Similar charges are still pending against the same three men in Gainsville and Canyon, Texas.
