JUNE PERMITS

In June the State Securities Board issued permits for 110 issuers to sell \$173,563,352 in securities.

Total dollar amount of securities applications processed for the first ten months of this fiscal year was \$1,650,777,176 as compared to \$1,320,986,596 for the same period last year -- a gain of \$330 Million. Total number of applications processed for the first ten months was 1,110.

LICENSE INFORMATION

During June, a total of 156 examinations were administered to 153 applicants for licensing under the Texas Securities Act. This included 148 examinations on the Texas Securities Act, 4 examinations on the General Securities Principles and 4 examinations on the Special Bond Examination. There were 56.1% of the applicants who passed the Texas Law Portion, 25.0% of the applicants who passed the General Securities Portion, and 50.0% of the applicants who passed the Special Bond Examination.

EXEMPTIONS

A portion of Section 5.0.(9) of The Securities Act reads, "or at the time of such sale at least the following information about the issuer shall appear in a recognized securities manual." In the past, recognition was not given to the loose-leaf, weekly update supplement published by Moody's Investors Service, known as "News Reports." Effective immediately, said weekly update supplement will be recognized in conjunction with the bound Moody's manuals.

INJUNCTIONS

A permanent injunction was issued on June 9, 1977, in the 162nd District Court, Dallas County against Vantage Oil Co., its agents, servants, officers, employees and representatives. The injunction enjoined the parties from promoting, issuing, selling, offering to sell, negotiating to sell, advertising, dealing in or distributing securities, including but not limited to interests in Schedule D offerings in oil and gas leases until there has been compliance with the registration and licensing requirements of the Texas Securities Act.

CONVICTIONS

William Ronald Doyle of Arlington, Texas, pleaded guilty to twelve violations of the Texas Securities Act and to one charge of theft over \$50.00 in District Court in Dallas. The charges stem from the sale of fractional interests in oil and gas leases by Doyle to several residents of Dallas, Texas. Doyle was sentenced to ten years in the penitentiary on each of the thirteen convictions with sentences to run concurrently. Doyle had previously been convicted of theft in Ector and Brown counties. * * *

Thomas Norton of Houston, Texas, was found guilty by a jury in 180th District Court, Harris County, of using fraud in the sale of securities. The securities, interests in oil and gas leases, had been offered and sold to non-residents of Texas pursuant to Regulation B, Schedule D, of the Federal Securities Act of 1933. The Houston jury assessed Norton a \$1,500 fine which was probated for one year.
