JULY PERMITS

In July, the State Securities Board issued permits for 174 issuers to sell \$606,142,404 in securities. \$184,900,000 of the above amount represents Money Market Funds.

Total dollar amount of securities applications processed for the first eleven months of the fiscal year was \$14,958,321,695 as compared with \$4,206,248,408 for the same period last year. \$8,413,412,414 of the \$14 Billion Plus figure represents Money Market Funds. Total number of applications processed for the first eleven months of this fiscal year was 1,931.

ADMINISTRATIVE ORDERS

IN THE MATTER OF RONALD HOWARD DEGEL GRANTING OR DENYING THE APPLICATION FOR REGISTRATION AS AN INDIVIDUAL SECURITIES DEALER OR INVESTMENT ADVISER

ORDER NO. LD-639

On July 25, 1980, Securities Commissioner Richard D. Latham ordered that the application of Ronald Howard Degel for registration as an Individual Securities Dealer or Investment Adviser to deal exclusively in oil and gas interests be DENIED.

This Order followed findings by the Commissioner that Degel had violated Section 14 of The Securities Act.
