Industrial Commission Will Direct Industrial Energy Conservation Efforts

The Texas Industrial Commission has been named lead agency in the implementation of the industrial phase of Texas' energy conservation plan.

Funding for the initial fouryear program is through the Governor's Office of Energy Re-

sources.

The overall state plan, recently approved by the Department of Energy (formerly the Federal Energy Administration), calls for a 5.5 percent reduction in statewide energy use.

More than half of the savings – 3.04 percent of the state's projected consumption – is to come

from the industrial sector.

BBR reports 34% increase in plant locations

Plans for 177 new and 196 expanding manufacturing firms were reported to the Bureau of Business Research at the University of Texas at Austin during the first three quarters of 1977.

These figures reflect a 34 percent increase from the 118 new plants announced during the same period in 1976. Plant expansion totals reflect a two percent de-

crease from last year.

Although the standard metropolitan statistical areas continue to attract the majority of the state's industrial activity, nonmetropolitan communities reported a 36 percent increase in the number of new and expanded businesses from 54 in 1976 to 84 this year. industry conserve 283.81 trillion BTU's of energy in 1980," Jim Harwell, executive director of the TIC, said.

Industry is Texas' largest consumer of energy (46 percent of total). "It is understandable that such a large consumer must receive serious attention in any plan aimed at improving the overall efficiency of state's energy use." Harwell said.

TIC's industrial conservation plan will be centered around two major activities:

(1) the promotion of technical information exchange both within industry groups and among the

groups

(2) direct outreach programs to provide low technology industry with information related to its specific processes and information on improving efficiency of particular end uses which are common to several industrial groups

To help carry out these activities an Energy Utilization Department has been created under TIC's Community Development Division. Lance dePlante has been selected

to manage that department.

dePlante has had six years experience in management and program administration. He spent four years in corporate recruiting and training with Electronic Data Systems of Dallas and has owned his own national firm developing training programs and recruiting professional personnel for large corporations. He also spent four years as contract management spe-

Seymour Citizens Go After Industry

Fed up with the lack of industry in their community, a group of 89 business and civic leaders from Seymour came to Austin in September to do something about it.

The entire group participated in a TIC-sponsored Texas Industrial Planning Seminar (TIPS) — a one-day program designed to acquaint community leaders with the basic approach to take in attracting new industry.

"This is a record breaker – the largest group we have ever had at a TIPS," Homer Tucker, senior community development consultant with TIC's Community Services

Department, said.

The meeting, originally scheduled for the Sam Houston State Office Building, was moved to the Ambassador Room of the Villa Capri Motel to accommodate the crowd. "We just didn't have a room available in our building to handle that many people," Tucker said.

Seymour, located about 50 miles southwest of Wichita Falls, has 3,469 citizens that feel their community has just about everything going for it except a sizeable

industrial payroll.

"We tried to limit the attendance to 75, but the people just wouldn't hear of it," said Paul Buck, manager of the Seymour Chamber of Commerce. "Everyone in Seymour wanted to find out first-hand what he or she could do to help bring industry to our area."

The TIPS is the first step in an Industrial Commission program designed to help industrially underdeveloped areas gain the support (See SEYMOUR Page 2)
